Based upon a role call: Vice Chairperson Rosen (Yes); Member Babij (Yes); Member Axelrod (Yes); Member Powell (Yes); Member Brown (Yes); and Chairperson Mendelson (Yes). The motion passed on a 6 to 0 vote.
