She also mentioned there is an established fund through the Homer Foundation where the community can donate to help fund the brick and mortar building.

A. Mike Illg, Community Recreation Manager – Rec Center Location Presentation

Mr. Illg introduced himself and spoke to the Commission on the following topics:

• Community recreation is primarily housed out of Homer High and Homer Middle

- Most programs have to be held at HERC, which has been condemned
- Majority of programs are taught by contracted instructors
- APRC doesn't have space or time to absorb community rec programs more than they already do
- The New Community Recreation Center has been the #2 project on the City's CIP list for a long time- in response to tax payers' requests
- The Community Rec Champions are encouraging the Commissions to envision the space and see the potential for future development
- Drafting a business plan to eventually have the Rec Center be as self-sufficient as possible

STAFF & COUNCIL REPORT/COMMITTEE REPORTS

A. EDC Staff Report

Community Development Director Engebretsen reported on the following:

- City Council passed the annual Operating Budget FY26-27
- City Council included a \$20k per year for an Alaska Small Business Development Center Home or Business Advisor position

B. Chamber Director Report

Homer Harbor Fest was the past weekend. It had a turnout of 1,700 people even though the weather wasn't great.

C. Homer Marine Trades Association Report

Meeting minutes were provided. There was no discussion.

D. Kenai Peninsula Economic Development District Report

Chair Marks stated the next meeting is upcoming and she will have a report in August.

E. HERC Update

Community Development Director Engebretsen stated the City had to close the multi-purpose room due to lead paint and lead dust. Resolution of the findings could include replacing windows or painting over the chipped paint.

F. Housing/Guiding Growth Update

Commissioner Noomah stated there wasn't much to report. He stated the Guiding Growth Group and the code consultants have been mutually updating each other.

G. Planning Update

City Council and Planning Commission have a joint worksession planned to discuss the Comprehensive Plan. Public Review Draft comes out mid-July with hearings in August with the Planning Commission. Work is being done on the Title 21 update.

A. New Rec Center Location

The Commission discussed the following topics in regard to the proposed location:

- Property in considered a wetland and possible effects on storm water runoff management
- Based on location HEA lot is a better choice
- Size of lot actually needed potential size of Rec Center, potential size of parking lot needed
- Will this investment in infrastructure actually spark private businesses to invest as well
- Possible restrictions in code for building itself
- Surrounding business owners weren't present to provide opinions
- Using this land would result in opportunity costs and lost opportunities associated with longterm use

AREVALO/DICKINSON MOVED TO FORWARD A MEMO TO CITY COUNCIL IN OPPOSITION OF THE PROPOSED LOCATION BUT WOULD LIKE TO DISCUSS ALTERNATIVE SITES.

- One piece of property is not viable to offer for over slope lease recommendation to remove from the list
- Space available at the airport

She also stated that she feels the Commission made some really substantive comments and questions and that they handled the Recreation Center concept very thoroughly.

Commissioner Zubek commented that she acknowledged the struggle between meeting what the people reportedly want and what's the best use.

Commissioner Noomah stated that he is not looking forward to a town that is full of rec centers and not being able to tear the old ones down. He also commented that he's like to warn against a future where there's 30 year bonds just to pay for rec centers.
