Session 22-08, a Regular Meeting of the Parks, Art, Recreation and Culture Advisory Commission was called to order by Chair Dave Lewis at 5:33 p.m. on October 20, 2022 from the City Hall Cowles Council Chambers located at 491 E. Pioneer Avenue, Homer, Alaska and via Zoom Webinar.

### **AGENDA APPROVAL**

Chair Lewis requested a motion to approve the agenda.

LOWNEY/FAIR – MOVED TO APPROVE THE AGENDA.

There was no discussion.

VOTE. NON-OBJECTION. UANIMOUS CONSENT.

Motion carried.

### **PUBLIC COMMENTS UPON MATTERS ALREADY ON THE AGENDA**

#### **VISITORS/PRESENTATIONS**

- A. Comprehensive Transportation Plan & People Oriented Transportation Presentation - Julie Engebretsen, Economic Development Manager and Brad Parsons, Independent Living Center

Chair Lewis introduced the item by reading of the title and invited Ms. Engebretsen and Mr. Parsons to make their presentation to the Commission.

Brad Parsons provided a brief synopsis of his history and experience and thanked the Commissioners for serving the Community. Mr. Parsons then presented on the many modes of transportation that are used by residents and visitors in a community. He provided information on the concept of people oriented transportation planning by referencing the current and existing plans, depicting various portions of those plans which focused on where are people were, where they wanted to be and how to get them back to the starting point. Mr. Parsons described how engineers look at an intersection through vehicle flow through that intersection and giving it a grade. He covered some aesthetics, and design components to address transportation through an area, providing pictures of local roads in Homer and various cities in the United States.

Julie Engebretsen provided information on public outreach opportunities, presentation will be given to all advisory bodies of the city, input from multiple surveys, focus groups, Community meetings conducted at the college campus, recognizing the need for a truck route, prioritization of new sidewalks, identification of new trail or non-motorized routes, special attention on Old Town section of Homer regarding traffic, pedestrian and parking and the city webpage dedicated to the project of the Transportation Plan update.

Ms. Engebretsen and Mr. Parsons facilitated responses to questions and discussions on the following:

- Where a truck route would be placed. Alaska Department of Transportation had originally looked at purchase of the east corner of Lake and Pioneer intersection where the blue building is located as the large vehicles need additional room for making that corner.
- Engage High School and Middle School Students will be done in November and Staff will be reaching out to the REC Center, Library, and maybe FLEX
- Focus from the Transportation Planning seems to be on Pioneer and there are issues on Kachemak Drive, and other roadways.
- Intensity of the Public Comment received on State Roads will provide ammunition for inclusion of those state roads in the plan. The ability for the City to do anything will depend on the feedback from the public.
- Educate the public and provide direction on the type and kind of comments that can be provided was suggested.
- City regulations require businesses to have a certain number of parking spots, versus creating parking lots where people can park and walk to multiple businesses.
- Land Use is a separate issue, where they are focusing on transportation, which is moving vehicles and people by various means.
- Staff recommended reaching out to local government classes and stated that they can provide the contact information.
- There are different issues such as road right of ways in various parts of Homer

## **STAFF & COUNCIL REPORT/COMMITTEE REPORTS**

### **A. Staff & Community Recreation Reports for October**

Chair Lewis introduced the item and deferred to Recreation Manager Illg.

Recreation Manager Illg reviewed his report for the Commission highlighting the following:

- November 10th Telluride Film Festival
- Annual PARC Conference – completed his two year term as President and will start his 3 year term as Past President. He will be attending the AML Conference in December in Anchorage and the 2023 ARPA Conference will be in Wrangell, Alaska.
- Special Training for the Coast Guard which utilized the facility for a training space, part of the City's efforts to become a Coast Guard City.
- Proposing that the HERC be used for special events such as Birthday parties

Recreation Manager Illg deferred to Deputy City Clerk Krause who responded to Commissioner Lowney on the status of Ordinance 22-42 regarding amending Homer City Code Title 11 related to the requirement for sidewalks.

Public Works Director Keiser commented on the proposed substitute ordinance that will be considered at the Public Hearing on October 24, 2022 by City Council.

Commissioner Lowney commented on inclusion of connecting corridors and green space when subdivisions are developed and asked how the Commission can get that included in requirements or policy.

Public Works Director Keiser responded that idea falls more under the land use and there is nothing in city code to address that so a policy, regulation would require development.

Commissioner Lowney reported that when she reported to City Council two meetings ago the Mayor commented that the Commission should look into restrooms as most of the parks restrooms are shut down or closed.

Public Works Director Keiser reported that when she first started with the city she was involved with developing a HAWSP policy manual, which is the Homer Accelerated Water and Sewer Program, and the criteria for when HAWSP could be used was added and one of those criteria is to build facilities that expand water and sewer services, provide new or expanded capacity as opposed to serving existing customers, additional criteria included was funds could be used to promote public health, that was one way that HAWSP could fund restrooms.

The Mayor and several of the Councilmembers at the time determine that they were not going to use HAWSP funds to build public restrooms, so there currently is no funding mechanism to construct needed restrooms.

Commissioner Lowney requested that they have restrooms on the November agenda.

Recreation Manager Illg facilitated discussion on the following:

- status of the lending library for equipment
- SAP lights for public use
- review of the data provided on page 32 of the packet
- Coast Guard use of the HERC gym

B. Public Works Director Report for October – Public Works Director Keiser

Chair Lewis introduced the item by reading of the title and deferred to Public Works Director Keiser.

Public Works Director Keiser provided a summary of her report as follows:

- The Trails Symposium brought forward the most comments on routes that the City does not control and there will be difficult conversations and decisions needed to get some changes made by the State.

- Recent use of the HERC 2 facility for a training exercise by the State Troopers
- Dumpster provided at the HERC that does not impact the users of the HERC 1 facility
- Consultant visit regarding Demolition and Abatement Project
  - o Demolition requires trained HAZMAT Qualified Companies
  - o Will probably be done in the Spring 2023
- Main Street is paved
  - o Bayview Park has new entrance
  - o Drainage
- Ben Walters Sidewalk Project
- Design for the Shoulder Extension Project for West Fairview from Mullikin, Eric Lane
  - o Extended gravel shoulder that will potentially be paved in the future
  - o Due to typography part of the pathway will be on south side of the road and then cross over at Eric Lane to the North side of the road so traffic calming measures will be needed when constructed
- West Hill Pedestrian Pathway
- HAP Loop
  - o Project recommended by Brad Parsons
  - o Working with Jenny Carroll to create CIP project
  - o Applications for grants
- Closing out and getting ready for winter

C. Parks Report - October – Parks Superintendent Steffy

Chair Lewis introduced the item by reading the title and deferred to Parks Superintendent Steffy.

Public Works Director Keiser previously provided a written report as a laydown for Mr. Steffy since he was attending electronically.

Parks Superintendent Steffy provided a summary of his report for the Commission. He highlighted the following:

- Presenter at the ARPA Conference from Minnesota Jill Moore, Paralympian
- Installation of the acrylic pieces for the Tuyanitum Artwork
- West Homer Library Lot development plan
- Close of custodial contract and closing of restrooms on the Spit
  - o Ramp 4 aka 7 pack - completely shut down
  - o Ramp 2 will remain open
  - o End of the Road Park – one side will be closed
  - o Ramp 5 at the Fish Hook –two of the three units will be closed
  - o Load & Launch Ramp – open
  - o Ramp 6 – close all but one unit due to live aboard
  - o Deep Water Dock – will be closed and harbor personnel will open as needed during events
  - o Bishops Beach – Portal Toilets will remain open but level of service may change
    - Extra dumpsters and portal toilets will be removed
  - o Fishing Hole is closed
  - o Bartlett and WKFL will likely have one side closed

**PUBLIC HEARING**

- A. Draft Ordinance 22-xx, An Ordinance of the City Council of Homer, Alaska, Amending Homer City Code Title 20 Animals, Sections 20.04.020 Definitions, 20.08.010 Animals at Large, 20.08.040 Nuisance Animals and 20.32.020 Fine Schedule to Refine the Definition of "At Large"; Clarify Areas Where Animals are to be on Leash at All Times and Amend Related Fines. Venuti/Erickson.

Memorandum from Deputy City Clerk as backup.

Memorandum from Police Chief as backup.

Chair Lewis introduced the item by reading of the title and deferred to Deputy City Clerk Krause.

Deputy City Clerk Krause reviewed the memorandum and actions requested of the Commission.

Chair Lewis opened the Public hearing inviting the Public to provide testimony on the draft ordinance. Seeing no members of the audience present in Chambers or attending via Zoom he closed the Public Hearing and opened the floor to questions of the Commission.

Deputy City Clerk Krause and Public Works Director Keiser facilitated a discussion on the proposed ordinance addressing comments and questions related to the following:

- Clarification of Animals on Floats
  - o As written it would apply to all animals including wildlife
  - o What does the actual section of code state
    - 20.08.030 was read into the record by the Clerk for clarity
  - o Restraint is defined in City Code under definitions and therefore do not need to add in the words leash or chain
- Female animals in heat
  - o As written why are fines only applied to the female if a male is chasing it around
  - o Refer to the definitions, and code sections to provide clarity on how the fines are applied
- Definitions defines the word Animal domestic or domesticated member of the animal kingdom
- Line 47-49, Specifically listing beaches since they are public property as this is a location with high use of unleashed animals or including a specific number of feet from the parking lot or waterline to unleash a dog
  - o Preference to specify a certain number of feet since that is where the most interaction of dogs and people are happening
    - Specificity would require a tape measure and this would lead to more hassles over determining the actual distance
    - As written dogs must be on leash in the parking lots, in the park but are allowed on leash when on the beach
    - Allowing dogs off leash to the east but must be on leash to the west
- Clarification on city limits and private property owners to the East
- Current support from law enforcement for amendments as written if the Commission makes additional amendments they will need to resubmit for additional review and it will delay the whole process
  - o Amendments are being made to provide law enforcement with basis to write citations
  - o Adding stipulations will just complicate everything further
  - o Complaints are about dogs jumping on people, chasing/attacking someone's dog
  - o Leave the draft ordinance as written and enforcement can be an officers decision on what citation is given or not. This draft gives teeth to deal with the dog and the owner

FAIR/ROEDL MOVED TO ADOPT STAFF RECOMMENDATIONS AND FORWARD THE DRAFT ORDINANCE AMENDING TITLE 20 ANIMALS SECTIONS 20.04.020 DEFINITIONS; 20.08.010 ANIMALS AT LARGE; 20.08.040 NUISANCE ANIMALS; AND SECTION 20.32.020 FINE SCHEDULE TO CITY COUNCIL.

There was a discussion on increasing the fees; concerns that the ordinance will not be approved at Council level, interpretation of where people can walk their dogs off leash; designate Mariner Beach as off leash; Council can amend the ordinance if they want.

VOTE. NON- OBJECTION. UNANIMOUS CONSENT.

Motion carried.

ARCHIBALD/MOVED TO RECOMMEND CITY COUNCIL CONSIDER THE AREA SOUTH OF THE MARINER PARK PARKING AREA FOR THE USE OF OFF LEASH DOG USE.

Discussion on clarifying the intent of the recommendation was to define an area that it was legal since this was considered public property as identified in city code currently. Further discussion on the inability of the Homer Police Department to enforce leash laws on the beach since they do not have the manpower to chase someone down the beach to issue a citation or impound the dog and comparing that “public property” to other city owned locations other than parks, parking lots, and campgrounds.

Deputy City Clerk Krause explained that the motion died for lack of a second after clarification that there was no amendments to the main motion made by Commissioner Fair and seconded by Commissioner Roedl so the draft ordinance was adopted as presented.

### **PENDING BUSINESS**

#### **A. Memorandum to City Council re: HCC Title 20 Amendments**

Chair Lewis introduced the item and deferred to Deputy City Clerk Krause.

Deputy City Clerk Krause reviewed her memorandum for the Commission explaining that she wanted to provide a separate opportunity for the Commission to review and amend or correct the memorandum to Council as needed and or desired.

LOWNEY/FAIR MOVED TO ADOPT THE MEMORANDUM TO CITY COUNCIL AS PRESENTED REGARDING PROPOSED AMENDMENTS TO TITLE 20.

There were no amendments or corrections from the Commission offered.

VOTE. NON-OBJECTION. UNANIMOUS CONSENT.

Motion carried.

### **NEW BUSINESS**

#### **A. Memorandum from City Clerk re: 2023 Meeting Schedule**

Chair Lewis introduced the item by reading of the title and deferred to Deputy City Clerk Krause.

Deputy City Clerk Krause reviewed the memorandum and requested action of the Commission.

LOWNEY/FAIR MOVED TO ADOPT THE 2023 MEETING SCHEDULE AS PRESENTED.

There was no discussion.

VOTE. NON-OBJECTION. UNANIMOUS CONSENT.

Motion carried.

Commissioner Galbraith volunteered to provide the report at the Council meeting on October 24, 2022.

Commissioner Lowney requested clarification on the proposed RFP/RFQ that will be issued to update the Comprehensive Plan and Title 21 Zoning & Planning Code.

Public Works Director Keiser stated that the Comprehensive Plan and Zoning Code have some ambiguous sections for a variety of reasons and do not provide enough details to be useful. There are sections of code that do not match what is stated in the Comprehensive Plan.

Commissioner Lowney stated that it would appear to be appropriate to submit recommendations to have the cul de sac exits lining up with green spaces in new developments and she would like to request to have that on an upcoming agenda, sooner rather than later, to establish verbiage to submit for consideration.

Deputy City Clerk Krause stated she can put this on for the next agenda noting she was waiting on the final document from Ryan Foster, Special Project Coordinator for publishing.

### **COMMENTS OF THE AUDIENCE**

### **COMMENTS OF THE CITY STAFF**

Recreation Manager Illg thanked everyone for their work at the celebration today. He then suggested that the next one is scheduled earlier in the summer.

Public Works Director Keiser requested the Commission to add and action item on Karen Hornaday Park Master Plan so that consideration can be provided on a way to move forward.

Chair Lewis requested that item on the November agenda.

Commissioner Lowney noted that it was asked to be scheduled already, but requested an outline or template of what options would be available for the park. They had the Master Plan, Option B and

Option C and while it is good, it will take more than discussion of what the Commission would like to do or see done. Can the Commission recommend hiring a consultant to be involved in the update?

Public Works Director Keiser responded that she would like to have the Commission consider the following:

- determine what was liked about the old master plan
- what use can spaces that are unused be dedicated to
- thinking outside the box to really make the park the Crown jewel that it is
- the master plan was great when it was created but it could use some updates
- November is too early, recommend that for February and March meetings
  - o Need to dedicate some thought to the planning and schedule and will report back at the November meeting for a more definite timeline and action plan

Deputy City Clerk Krause commented that the Commission did a great job getting through the work tonight.

Parks Superintendent Steffy echoed Public Works Director Keiser sentiments on reevaluating the Master Plan for Karen Hornaday Park to move forward. There is a lot of utilized space within the park and lots of cool options available. He mentioned how Rotary is one of their primary partners in maintaining the parks and it was great turnout today.

#### **COMMENTS OF THE COMMISSION**

Commissioner Galbraith expressed his appreciation for the Parks and City Staff for organizing the celebration at Ben Walters Park and the recognition of Rotary and meeting all the folks today.

Commissioner Archibald commented that it will be an interesting few months ahead but expressed his belief that Council will send this dog leash issue back to the commission saying they did not have a Public Hearing since no one was here. He then stated that he has been talking with Jack Wiles regarding the master Plan as he was very instrumental in writing that plan, Commissioner Archibald acknowledged things have changed, lots of ifs out there now that are certainly not in the master plan. He then questioned what they wanted to use the 10 acres above the campground, maybe build some nice cabins that could be rented. He further offered consideration of putting a picnic areas up there or more camping.

Commissioner Lowney stated that she really enjoyed the event at Ben Walters today and that the Commission should do things like that more often recognizing the people and groups who are doing so much. She expressed another shout out for the Homer Drawdown group and City staff for all the effort in coming together to make so much happen right now around trails, but really around non-motorized transportation. It's really huge. She then reiterated the date and time for the next meeting of the group on October 16<sup>th</sup> 6:00 pm to 8:00 pm and encouraged the Commissioners to attend as there were going to be break out groups where one can have your voice heard.

Chair Lewis cautioned the Commission regarding meeting rules and noticing if more than three Commissioners were attending an event.

Commissioner Roedl echoed Commissioner Archibald comments regarding Karen Hornaday Park and the many possibilities but agreed that the whole plan needed to be updated because it has been hard to make progress, real progress, they have only been able to obtain baby steps. They have done some things right and important changes have been very difficult to come by. He expressed his enjoyment of the event at Ben Walters Park noting he had to put on more clothes due to the cold.

Commissioner Fair agreed with Commissioner Roedl regarding the wind and having to put on more clothes to be warm, but that it was a good event. He then asked about doing a Letter to the Editor and having the topic as Recognition of Rotary and the Adopt of Park Program, but he was also open to suggestions.

The Commission expressed by consensus that that would be a great letter to the editor topic.

Chair Lewis expressed his sentiments of enjoyment for the event at the park stating that it was really fun. He enjoys a good burger or dog and it was a good time.

The following City Council resolutions and ordinances activity relevant to the Park, Arts, Recreation and Culture Advisory Commission since the last PARCAC meeting on October 20<sup>th</sup>, 2022

### October 24<sup>th</sup> Regular Meeting

SUBJECT: Director's Report

1. **Little HERC Building.** We've received the plans and specifications for the remediation of the hazardous materials. We will package this information with some general civil plans and specifications that advise prospective bidders about (a) existing utility conditions and other things they need to know before the hazardous materials remediation and demolition can take place and (2) what the site needs to look like then the demo is finished. Our plan is to put this package out to bid in early January.
2. **Main Street Sidewalk.** This project is, for all practical purposes, complete. Thank you for your support!
3. **Ben Walters Way Sidewalk.** The design is nearing completion. The current cost estimate is \$1.34 million. We will likely put this project out to bid in January – February. Work will not start until early summer, but it is important to get on the dance card of our local contractors as early as possible.
4. **Karen Hornaday Park.** We have 4 landscape firms on the Term Contract roster capable of doing helping us develop a new Master Plan. I propose the following schedule:
  - December Request proposals from landscape firms
  - January Discuss selection with PARCAC
  - February - March Work is done – planning, outreach, etc.
  - April – May Approvals from PARCAC & Council
  - Summer Season Renovation work starts

We don't need any action at this time. We'll comeback in January to discuss consultant selection.

**5. Public Restrooms.**

- a. We've closed many of the public restrooms on the Spit.
- b. We're locking the restrooms on Pioneer Avenue at night.
- c. We've shifted restroom cleaning from the Parks' Division to the Custodial Division, and we're hiring a temporary custodian to help get us through the winter.
- d. We're planning to ask the City Council for budget to add a fulltime permanent position to the Custodial Division to take care of public restrooms. Matt will never talk about restrooms ever again.

**6. Parks Maintenance.** We are evaluating how to more effectively maintain the scope of the "community development" aspects of Matt's job, while upgrading maintenance of Parks facilities.

- All campgrounds have been closed for the season. We are still working with HPD on relocating a few individuals.
  - The gate at Mariner Park has been unlocked for the winter providing access between the park and the seawall for coal gathering.
  - Parks staff have been continuing to haul brush off of project sites where it was stockpiled this summer. Lee Drive is almost cleared now.
  - Parks staff have been working through our regular winterization process which varies from park to park.
  - Little Free Libraries from Karen Hornaday Park, Mariner Park, and Fishing Hole Campground have been removed for the winter. The quick release system we designed worked great. This is to prevent weather damage. The LFL at WKFL and Bishops Beach still remain, but may be pulled at some point.
  - Homer Drawdown and its many partners have continued to meet for general memberships, steering committee, and the new sub-groups. I can provide a breakdown of the next steps for HDD through the winter.
    - Rainbow Court connector
    - Lee Drive extension
  - Conversations are underway with City staff and contractors regarding the need to maintain access to critical trailheads by not blocking them with snow. We will try to markers out in as many locations as possible to provide visual assistance.
  - Hospice has requested the construction of an additional memorial wall. After initial internal discussion I met with their Board President and Executive Director to discuss options moving forward with the memorial program.
  - We have begun putting out seasonal lighting! Keep your eyes open for more and more lights appearing.
  - This report will be supplemented with additional conversational updates at the meeting.

At the October 24<sup>th</sup> Council meeting, there was an extended discussion in the Committee of the Whole related to Ordinance 22-72 which proposed changes to Title 20 Animals. The item was postponed during the regular meeting for reevaluation after comments were received from the Animal Shelter Director indicating that it was not realistic for her organization to enforce the proposal under the scope of their current contract and staffing. The Animal Shelter's contract includes animal control services, but the City's current contract does not provide sufficient funding for the organization to patrol and enforce the rules suggested in Ordinance 22-72.

After a brief discussion with the Public Works Director and the Animal Shelter Director, I have put together an alternative proposal which instead focused on Title 19 Parks, Campgrounds and Public Places. The focus on Title 19 puts more of the enforcement impetus upon City staff, although Animal Control support would be available in extreme cases.

The amendments I'm proposing are as follows:

**HCC 19.08.070 (f):** (It shall be unlawful for any person to:) Allow any dog owned, harbored, or controlled by a person to be physically unrestrained and at large in any City-owned or City-controlled campground. All fecal wastes of any dog discharged or deposited on any lands within a City-owned or City-controlled campground shall be immediately removed by the person owning, harboring, or controlling said animal and shall be deposited in trash receptacles or otherwise stored in containers pursuant to HCC 19.08.080;

**HCC 19.20.020 (g):** Dogs may not be physically unrestrained or at large within city parks. Dogs may be restricted from sensitive habitat areas by signage posted by the city. A person having control or supervision of an animal that excretes feces in a park shall immediately collect and properly dispose of the feces.

HCC 1.16.040 already includes \$300 fines for violations of 19.08.070(f) and 19.20.020.

My intent with the phrase "physically unrestrained" is that a literal physical connection must exist between dog and handler. Electronic leashes are not sufficient as there is no physical connection.

I recommend that this targeted approach to restrict loose dogs in campgrounds and parks be followed by a period of animal control stakeholder engagement and a comprehensive review and update of Title 20 Animals.

**Staff Recommendation:** Replace Ordinance 22-72 with an updated ordinance focused on Title 19

and shall be deposited in trash receptacles or otherwise stored in containers pursuant to  
HCC [19.08.080](#);

Section 2. Homer City Code Chapter 19.20.022 entitled, "General rules" is hereby  
amended as follows:

g. **Dogs may not be physically unrestrained or at large within city parks. Dogs may be**  
**restricted from sensitive habitat areas by signage posted by the city.** A person having  
control or supervision of an animal that excretes feces in a park shall immediately collect  
and properly dispose of the feces.

Section 3. Homer City Code Chapter 1.16.040 entitled, "Disposition of scheduled offenses – Fine schedule." is hereby amended as follows:

drainage issues more comprehensively. Further, some land uses within the Park have changed over time. These, and other factors, have compelled the City to develop a new master plan.
