1. CALL TO ORDER

Session 23-15, a Regular Meeting of the Planning Commission was called to order by Chair Scott Smith at 6:30 p.m. on September 6, 2023 at the Cowles Council Chambers in City Hall, located at 491 E. Pioneer Avenue, Homer, Alaska, and via Zoom Webinar. A worksession was held at 5:30 p.m. On the agenda was a discussion on Ordinance 23-21(S)(A) recommendations to City Council. Commissioner Barnwell had an excused absent from the Worksession.

2. AGENDA APPROVAL

Chair Smith read the Supplemental Items into the record Pending Business, Item A. Ordinance 23-21(S)(A), An Ordinance of the City Council of Homer, Alaska, Amending Homer City Code Section 22.10.050 to Specify that Preliminary Plats Approved by the City Shall Include All Development Commitments Made to the City. Memorandum from Public Works Director dated August 7, 2023 updated September 6, 2023 and Informational Items, Add Item F. Memorandum from City Planner re: Comprehensive Plan Update and Title 21 Rewrite, Draft resolution Awarding the Contract to Agnew Beck and request for Proposals packet and Request for Qualifications Packet for Comprehensive Plan Update and Title 21 Rewrite. May I have a motion and second to approve the agenda as amended.

HIGHLAND/BARNWELL MOVED TO APPROVE THE AGENDA AS AMENDED.

There was no discussion.

7. REPORTS

A. Staff Report 23-052, City Planner's Report

City Planner Foster reviewed Memorandum PC 23-052 for the Commission. He spoke to the following items:

- He provided a link to Title 21 regarding enforcement of code in response to Commissioner Venuti's questions at the last meeting stating that it was prudent to provide a link because the section of code was quite lengthy. He informed the Commission that code enforcement is complaint driven and planning staff will review the complaint received and visit the location. If a review of the permits related to the location, if any, determines that there is non-compliance the property owner will be contacted.
- The Draft Transportation Plan was available online and he does have paper copies which he will put a copy for each Commissioner out in the cabinet located outside the lower lobby entrance for the Commissioner's to pick up at their convenience. Comments from the public are due by October 10th and the Commissioners were strongly encouraged to attend the Open House scheduled for September 26th. Mr. Foster noted that after Public review the draft would come before the Commission for their comments during a worksession which will be forwarded to Council.
 - In response to concerns regarding a quorum of Commissioners attending the Clerk noted that attendance by the members of the Commission would be included in the weekly Homer News Meeting Notice advertisement.
- The September 20th Planning Commission meeting has been canceled as he will be at the Annual Planning Conference in Anchorage that week.
 - City Planner Foster responded that currently there are no trainings being offered for Commissioners by the Alaska Planners Association like they once did prior to COVID. There was some discussion about conducting online seminars/training sessions but nothing has been formulated at this time.
- City Planner Foster responded that if the Commission would like a worksession on Bluff Setbacks he
 could certainly schedule a worksession, if the Commission would like to submit some specifics for
 discussion and when the Commission would like to target to have a worksession that it would be
 helpful.

Chair Smith noted that he will provide a written report for the Council meeting but requested a volunteer to provide the report to Council in person or via Zoom. There were no volunteers for the next meeting.

Chair Smith introduced the item by reading of the title and then deferred to City Planner Foster to provide his formal report.

City Planner Foster provided a summary review of the actions concerning this topic and referred to his memorandum regarding the key findings from the previous meeting and recommended comments plus a additional recommendations that came out of the worksession held prior to this meeting. He also stated that he did have some language changes as well.

Chair Smith would like to bring forward the language that Public Works Director Keiser suggested to bring the recommendations back to City Council.

Deputy City Clerk Krause read into the record a synopsis of the statement that was said at the worksession as follows:

"Thank the council for bringing forth the issue as it has been beneficial to that effect and would like to recommend that nothing further be done with the ordinance at this time to allow staff to work"

Public Works Director Keiser stated that as a summary of what she stated it was good but it should be embroidered with some language to tie in the recommendations; specifically those shown on page 23 of the packet, to highlight the actual actions that will be undertaken. She expressed her belief that it will assist the Council to understand the next steps if they are told number one some of the discussion has taken place and the depth and breadth of it is important and beneficial and number two, there is some work that needs to be done and here are the specific items that will be undertaken and the Commission is asking their leave to do that work before they move forward on this ordinance.

Chair Smith express his appreciation for the clarification from Public Works Director Keiser as it provided a foundation as to why the Commission is responding the way that they did.

UNAPPROVED

Commissioner Highland expressed some concerns that if the Commission does not approve and submit their recommendations to City Council that they will approve the ordinance as it is written.

Chair Smith assured Commissioner Highland that they can address that aspect in their recommendations to City Council.

Commissioner Stark expressed his views on including Public Works Director Keiser's more elaborate statement where she highlighted the stimulation of discussion, legislative analysis and how everything is done, as a result, the City Planners recommendations and that the Commission requests City Council to adopt those and further request that they withdraw their ordinance since the ordinance would be unnecessary as a result.

City Planner Foster suggested that the Commission address the draft comments, shown on page 23 of the packet, with some minor wordsmithing by motion.

A brief discussion ensued on how best to address the comments and with advice from the Clerk the Commission agreed to formulate motions for each comment.

City Planner Foster read the first recommendation:

HIGHLAND/VENUTI MOVED TO RECOMMEND CITY COUNCIL WITHDRAW ORDINANCE 23-21(S)(A).

There was discussion on making amendments to provide the basis for why the Commission is requesting the ordinance should be withdrawn. Explanation was provided that it may be preferable to address this recommendation last since it would be the outcome of the actions that will be recommended.

HIGHLAND/VENUTI MOVED TO POSTPONE UNTIL DISCUSSION HAS BEEN CONDUCTED ON THE OTHER RECOMMENDATIONS.

There was no further discussion.

VOTE. (Postponement) NON-OBJECTION. UNANIMOUS CONSENT.

Motion carried.

City Planner Foster read the next recommendation into the record.

"Recommend an effort to reconcile the Homer City Code for development processes including cross references or consolidation of subdivisions and platting which takes place in Title 22 and construction of subdivisions which takes place in Title 11 and clean-up work and reconciliation of language in the city code."

Commissioner Highland requested clarification of the language for the motion.

HIGHLAND/VENUTI MOVED TO RECOMMEND AN EFFORT TO RECONCILE THE HOMER CITY CODE FOR DEVELOPMENT PROCESSES INCLUDING CROSS REFERENCES OR CONSOLIDATION OF SUBDIVISIONS AND

PLATTING WHICH TAKES PLACE IN TITLE 22 AND CONSTRUCTION OF SUBDIVISIONS WHICH TAKES PLACE IN TITLE 11 AND CLEAN-UP WORK AND RECONCILIATION OF LANGUAGE IN THE CITY CODE.

Brief discussion on incorporation of Title 11.

VOTE. NON-OBJECTON. UNANIMOUS CONSENT.

Motion carried.

City Planner Foster read the next recommendation into the record:

RECOMMEND UTILIZING THE FOLLOWING AGREEMENTS FOR THEIR INTENDED PURPOSE AND DEFINE IN HOMER CITY CODE:

- SUBDIVISION AGREEMENT: REQUIREMENTS FOR SUBDIVISION IMPROVEMENTS
- CONSTRUCTION AGREEMENT: CONSTRUCTING INFRASTRUCTURE SUCH AS ROADS AND UTILITIES
- INSTALLATION AGREEMENT: CONNECTING TO CITY WATER AND SEWER

Public Works Director Keiser stated that there could be confusion between the Subdivision Agreement and Construction Agreement and suggested that they include after the definition of construction agreement the language, "where the lot lines are not changing"

HIGHLAND/ MOVED TO RECOMMEND UTILIZING THE FOLLOWING AGREEMENTS FOR THEIR INTENDED PURPOSE AND DEFINE IN HOMER CITY CODE:

- SUBDIVISION AGREEMENT: REQUIREMENTS FOR SUBDIVISION IMPROVEMENTS
- CONSTRUCTION AGREEMENT: CONSTRUCTING INFRASTRUCTURE SUCH AS ROADS AND UTILITIES, WHERE THE LOT LINES ARE NOT CHANGING
- INSTALLATION AGREEMENT: CONNECTING TO CITY WATER AND SEWER

There was a brief discussion on codified language would contain more precise language for the definitions.

VOTE. NON-OBJECTION. UNANIMOUS CONSENT.

Motion carried.

City Planner Foster read the next recommendation into the record:

"Ensure Preliminary Plat considerations by the Homer Planning Commission include comments when Subdivision Agreement, Construction Agreement, and Installation Agreements are required.

Commissioner Stark suggested a change in the language to use the word references instead of comments

City Planner Foster explained that currently the process when the Commission reviews a Preliminary Plat they recommend approval or adoption with the following comments. This recommendation would require that a standard comment be added denoting what type of agreement would be required, if any.

Further debate ensued on the language to use in the recommendation from the Commission to City Council and that the accuracy of that language depicted the Commission actions during a Preliminary Plat consideration.

Commissioner Stark suggested the following language: "Ensure Preliminary Plat considerations by the Homer Planning Commission include comments referencing when Subdivision, Construction, or Installation Agreements are required.

Further discussion on comments incorporating references such as the Corps of Engineers, and comments having a foundation in city code and an example where one of those agreements would not be required would be a lot line vacation between two lots may not require any type of improvement or one lot dividing into two lots.

HIGHLAND/VENUTI MOVED TO INCLUDE A RECOMMENDATION TO ENSURE PRELIMINARY PLAT CONSIDERATIONS BY THE HOMER PLANNING COMMISSION INCLUDE COMMENTS REFERENCING WHEN SUBDIVISION, CONSTRUCTION OR INSTALLATION AGREEMENTS ARE REQUIRED AND SENT TO THE KENAI PENINSULA BOROUGH.

There was no discussion.

VOTE. NON-OBJECTION. UNANIMOUS CONSENT.

Motion carried.

City Planner Foster read the next recommendation into the record:

"Recommend providing information and training on the Subdivision Development process to City Council and other relevant city commissions."

HIGHLAND/VENUTI MOVED TO INCLUDE A RECOMMENDATION TO PROVIDE INFORMATION AND TRAINING ON THE SUBDIVISION DEVELOPMENT PROCESS TO CITY COUNCIL AND OTHER RELEVANT CITY COMMISSIONS.

There was no discussion.

VOTE. NON-OBJECTION. UNANIMOUS CONSENT.

Motion carried.

Chair Smith noted that the next recommendation is new and was not included in the memorandum in the packet.

City Planner Foster noted that there are two new recommendations from the worksession. He read the first one into the record: "Create a City of Homer Preliminary Plat Application."

City Planner Foster explained that there is process outlined in city code but that there is no application that a property owner or applicant can complete to provide basic information. He provided further information on what the Planning Department currently receives and provided recent experience on receiving limited, if

any, contact information from the applicant such as phone, addresses, email, what they actually plan to do and how that impacts the processing of the preliminary plats. He is recommending that a formal one page application be created to contain all information that they need such as phone, address and a descriptive intent

Additional discussion ensued on the content of motion, process, Commission input.

HIGHLAND/VENUTI MOVED TO CREATE AND IMPLEMENT A PRELIMINARY PLAT APPLICATION FORM.

There was no further discussion.

VOTE. NON-OBJECTION. UNANIMOUS CONSENT.

Motion carried.

City Planner Foster stated the last recommendation for the record, as follows: Request withdrawal of Ordinance 23-21(S)(A).

A brief discussion on providing a memorandum to City Council as a cover letter that thanks them for bringing the topic forward as it brought forth some very good discussion ensued. City Planner Foster explained that a memorandum would be provided noting the discussion that was conducted on this ordinance.

HIGHLAND/VENUTI MOVED TO REQUEST CITY COUNCIL WITHDRAW ORDINANCE 23-21(S)(A)

Commissioner Stark suggested adding verbiage to specify that enacting the above recommendations will negate the necessity of Ordinance 23-21(S)(A).

Deputy City Clerk Krause called for a point of order reminding the Commission that a motion that was postponed earlier is on the table, so the Commission needs to bring the postponed motion from the table, and make a motion to amend adding that language would be good.

Chair Smith re-stated for the record the actions that are required at this time was to bring the motion that was postponed earlier from the table and to amend the motion to add the language "enacting the above recommendations will negate the need for the ordinance." voting on the amendment then vote on the motion as amended.

Deputy City Clerk Krause confirmed and proposed using the correct term to "postpone indefinitely" instead of the word, "withdraw" she can make a technical correction as long as the Commission was agreeable or another motion can be made to amend the motion.

The Commission by consensus agreed to the Clerk making that change in verbiage.

Chair Smith stated the motion as amended for the record:

MOVED TO REQUEST CITY COUNCIL POSTPONE INDEFINITELY ORDINANCE 23-21(S)(A) BECAUSE ENACTING THE ABOVE RECOMMENDATIONS WILL NEGATE THE NECESSITY OF THE ORDINANCE.

Chair Smith called for the vote.

Commissioner Highland requested clarification on voting this motion up or down.

Clarification was provided to the Commission that voting yes to this recommendation is what is desired, if the Commission votes no then the recommendation to withdraw or postpone indefinitely the Ordinance will not go forward to City Council. The Chair has called for a vote so the Clerk will perform a roll call vote instead of unanimous consent.

VOTE. YES. VENUTI, HIGHLAND, STARK, CONLEY, SCHNEIDER, BARNWELL, SMITH.

Motion carried.

City Planner Foster confirmed action was concluded as required by the Commission.

Commissioner Stark requested Public Works Director Keiser to work with the City Planner to draft the memorandum to City Council regarding the Commission's recommendations, specifically to include the wonderfully articulated language regarding the request to amend the city code brought about the recommendations.

Chair Smith noted the informational materials in the packet.

City Planner Foster commented on the informational flyers for the Park Forums seeking public comment on the proposed master plan re-writes and the Transportation Plan Open House event scheduled later this month.

Discussion ensued on the proposed budget for the Comprehensive Plan (Comp Plan)Update and Title 21 Rewrite funding and that the Scope of work has some small tweaks recommended, it was noted that a memorandum was overlooked and did not make the Supplemental Packet which included some recommended changes in the Scope of Work. Further points were made as to City Council understanding and concerns regarding the costs and scope of work, and the fact that the Commission did not see the scope of work prior to Council approval.

City Planner Foster stated that he wanted this item as an informational item so that the Commission was aware of the resolution and award of the Contract to Agnew Beck and get this in motion. He explained that the excerpt from the Request for Proposals was included in the Supplemental Packet. He then encouraged the Commissioners to attend the Draft Transportation Plan Open House.

Chair Smith expressed concern regarding the attendance of four or more Commissioners in attendance at the meeting even though it was acknowledged that the Commission does not approve the Comprehensive Plan, it could cause some issues.

Deputy City Clerk Krause responded that she will include a statement in the weekly meeting notice that Commissioners would be attending that event.

City Planner Foster responded to Commissioner Venuti regarding the Comprehensive Plan being scheduled for an update every five or ten years but he would have to confirm if its codified or policy, noting that the Comp Plan update will take a couple of years with all the public components and reviews and then the time period for updates will be recalculated from that point. He stated that this was a Council priority project.

Commissioner Venuti inquired about Commissioners attending the APA Annual Conference.

City Planner Foster noted that currently and due to previous COVID years there have been no Commissioner Training included in the conference agenda. He was unsure if that would come back but will definitely look into finding some information about that possibility or future online trainings for Commissioners and report back.

Commissioners that attended training sessions during the annual conference expressed how valuable they felt those experiences were and the information provided to a new Commissioner.

City Planner Foster expressed his appreciation for the hard work that the Commission has undertaken in the last three months, it has been complicated, heavy stuff and they have had several long meetings and worksessions so he wanted to thank the Commission for all their hard work and dedication. He further expressed his appreciation to Ms. Keiser for providing her assistance on the subdivision aspect, it was critical to get the information to the Commission.

Public Works Director Keiser stated it was a great meeting, great work.

Commissioner Highland expressed her thanks to Public Works Director Keiser and suggested including the flow chart with the memo that is submitted to Council on the Subdivision Development Process and maybe include it in the Newsletter as it is really informative.

Commissioner Venuti stated it was an interesting meeting and thanked staff for all their great work and the Commissioners for serving tonight.

Commissioner Conley thanked Public Works Director Keiser and City Planner Foster for their hard work and expressed his appreciation for the Clerk keeping the Commission on track.

Commissioner Schneider echoed the sentiments expressed by the Commission for the staff for their terrific work and clarity that they provided tonight. He was still on the learning curve, but this has been a pretty valuable meeting for him and hoped it just gets better and better. Thank you.

Commissioner Barnwell expressed his appreciation for the effort Public Works Director Keiser provided clarifying Ordinance 23-21(S)(A) and that including the Flow chart in the memo would be a great, because it really clarifies the process and the graphics help a lot. He requested that the memo be submitted to the Chair before it goes to Council to make sure it includes the language that the Commission desires to be included. Mr. Barnwell expressed his appreciation for all the Commissioners work and the staff for their efforts and hard work over the last months and articulated his concerns finding Ms. Keiser's replacement. Mr. Barnwell commented on her skill set and providing irreplaceable contributions to the community, noting she was an engineer and attorney. Mr. Barnwell remarked on Public Works Director Keiser high level of diplomacy during a past incident that included the Mayor and noted that she will be missed.

Chair Smith expressed his thanks to City Planner Foster and Public Works Director Keiser, stating that the Commissioners should keep the flow chart in their notebooks for future reference. He further stated that it feels like the Commission is making some forward progress in a reasonable and conscientious manner, so he was satisfied. He complimented the Commissioners for being outstanding volunteers and that they are a great group. Mr. Smith commented to Commissioner Schneider that he may feel like a rookie for a long time noting his personal length of time on the Commission and professing to still feeling like a rookie at times. He then thanked the Clerk for keeping them on track and wished everyone a nice evening.

After the public review of the Draft Transportation Plan, the Planning Commission will have a work session to review and comment on the plan and then a public hearing to provide comments to the City Council, the approval authority for Comprehensive Plan documents.

Economic Development Commission

The EDC has been working on a Vision Statement, followed by a Mission Statement. The below is their adopted Mission Statement, from their September meeting.

"The Economic Development Advisory Commission (EDC) of the City of Homer is a volunteer advisory body that bridges citizens and city government. Analysis: This subdivision is within the Rural Residential District. This plat subdivides one larger lot into three smaller lots. This preliminary plat has been revised and resubmitted for consideration. The ROW, which did not meet City code, has been removed. An access easement is proposed in-lieu of a dedicated ROW. The panhandle(s) layout of the lots allow for water and sewer services without extending mainlines.

Homer City Code 22.10.051 Easements and rights-of-way

A. The subdivider shall dedicate in each lot of a new subdivision a 15-foot-wide utility easement immediately adjacent to the entire length of the boundary between the lot and each existing or proposed street right-of-way.

Staff Response: The plat meets these requirements.

B. The subdivider shall dedicate in each lot of a new subdivision any water and/or sewer easements that are needed for future water and sewer mains shown on the official Water/Sewer Master Plan approved by the Council.

Staff Response: City sewer and water mains are located on East Hill Road, the property owner will need to enter into a subdivision agreement with the City according to Homer City Code 22.10.040 (a) and 22.10.050 (Improvement Requirements) regarding any infrastructure improvements including sewer and water connections.

C. The subdivider shall dedicate easements or rights-of-way for sidewalks, bicycle paths or other non-motorized transportation facilities required by HCC 11.04.120.

Staff Response: The plat meets these requirements. Per HCC 11.04.120 (c)(2). *A means of non-motorized transportation is not warranted because:*

- a. There is no route for non-motorized transportation that would connect to any recreational, cultural, civic, educational services or business activities.
- b. The existing and projected population density for the property through which the new street will traverse is, pursuant to the most recent version of the Homer Comprehensive Plan, lower than the population densities projected for the Central Business District, Urban Residential Zone or Residential Office District.

Preliminary Approval, per KPB code 20.25.070 Form and contents required. The commission will consider a plat for preliminary approval if it contains the following information at the time it is presented and is drawn to a scale of sufficient size to be clearly legible.

- A. Within the Title Block:
- Names of the subdivision which shall not be the same as an existing city, town, tract or subdivision of land in the borough, of which a plat has been previously recorded, or so nearly the same as to mislead the public or cause confusion;
- Legal description, location, date, and total area in acres of the proposed subdivision;

3. Name and address of owner(s), as shown on the KPB records and the certificate to plat, and registered land surveyor;

Staff Response: The plat meets these requirements.

B. North point;

Staff Response: The plat meets these requirements.

C. The location, width and name of existing or platted streets and public ways, railroad rights-of-way and other important features such as section lines or political subdivisions or municipal corporation boundaries abutting the subdivision;

Staff Response: The plat meets these requirements.

D. A vicinity map, drawn to scale showing location of proposed subdivision, north arrow if different from plat orientation, township and range, section lines, roads, political boundaries and prominent natural and manmade features, such as shorelines or streams;

Staff Response: The plat meets these requirements.

E. All parcels of land including those intended for private ownership and those to be dedicated for public use or reserved in the deeds for the use of all property owners in the proposed subdivision, together with the purposes, conditions or limitation of reservations that could affect the subdivision;

Staff Response: The plat meets these requirements. *No such areas are proposed.*

F. The names and widths of public streets and alleys and easements, existing and proposed, within the subdivision; [Additional City of Homer HAPC policy: Drainage easements are normally thirty feet in width centered on the drainage. Public Works Comments: Please advise the property owner that they will need to enter into a subdivision agreement with the City according to Homer City Code 22.10.040 (a) and 22.10.050 (Improvement Requirements).

The property owner will need to work with the Public Works Department in determining what the standard will be for a driveway within the access easement.

The panhandle(s) layout of the lots allow for water and sewer services without extending mainlines.

Staff Recommendation:

Planning Commission recommends approval of the preliminary plat with the following additional comments.

- 1. The property owner will need to enter into a subdivision agreement with the City according to Homer City Code 22.10.040 (a) and 22.10.050 (Improvement Requirements).

VICINITY MAP ON REVERSE







Early Season Sales Tax Update

The second quarter of 2023 (fourth quarter of fiscal year 2023) experienced a decrease in taxable sales over the same period the year prior. This dip in revenue was experienced throughout the Kenai Peninsula Borough. While posting a year over year decrease in a quarter isn't ideal, it's important to contextualize this with the reminder that this is still the second best revenue performance for the April to June period within the history of the City of Homer. It will probably be some time before State economists explain what they believe drove the Borough-wide decline, but I see two likely contributors: 1. The poor weather this year may have been a significant impediment to in-state travelers who constitute a significant portion of our shoulder and peak season visitors. 2. The sales tax cap does more damage to revenues as inflation drives up prices and the values of individual transactions around the City.



It is worth noting that while in-person sales tax was down, remote seller's sales tax is performing well above our budget forecasts. We are also seeing increases in property tax that exceed our forecasts. If the first quarter of FY24 underperforms similarly to the last quarter of FY23, we have the benefit of the new fiscal year to

consider our course of action for the rest of the year. It's possible that performance of other revenue sources will cover the difference. If it appears like they won't, we are well positioned to make adjustments this winter.

Harbor Staff Tours the Coast Guard Cutter Aspen

Port staff including Bryan Hawkins, Amy Woodruff, Aaron Glidden, Del Masterhan, and Matt Clarke met with the Coast Guard executive staff of the Cutter Aspen on board the ship. The Port Director asked for the meeting so that we could both welcome the new ship to the port and share contact information with operations level staff at both the Port and the Cutter. We spoke about day to day operations, maintenance responsibilities for the Cutter's berth, Dock and parking area, and snowplowing/sanding. We took the opportunity to update the ship's staff on the Port Expansion project and the Small boat station project. Numbers were exchanged and faces put to names.

Short Term Rental Code

After our last meeting, I set to work creating a draft short term rental code inspired by conversations at Council meetings and in the community; existing programs in Soldotna, Seward, Juneau; and the code I worked with previously in Eureka, CA. That code has been shared with relevant staff for comments and adjustments. Once the draft has cleared that review, we will reconnect with the Council sponsors of previous short term rental actions.

Park Plans - Public Engagement Opportunities


Corvus Design will be in Homer on September 12th to host public meetings to gather input for the Bayview Park Plan and the Karen Hornaday Park Plan. Council and the Public are invited to join us for a Bayview Park public forum at noon in the park, a Karen Hornaday Park public forum at 3pm in the park, and a final public forum at City Hall at 5:30pm. A flyer for the event is enclosed with this report.

East End Road Mud Flow

We recently had a lot of rain that led to a lot of mud washing across East End Road from Kachemak City into Homer. Below is an account of that event and its impacts from Public Works Director Keiser.

Last week, a mudslide surged down a steep canyon just west of the new Meadows Subdivision, in Kachemak City, and swept mud and debris-laden water over East End Road, depositing a heavy layer of silt over the road and downstream into the Bagel Shop commercial area. The AK DOT dispatched equipment to clear the road and in their haste, sheared off the top of a City of Homer manhole. They left an over 24" opening, through which mud, sticks and whatnot poured for many hours, spiking flows to Homer's Waste Water Treatment Plant with over 500,000 gallons of cold, muddy water. Todd Cook and the bacteria were not happy! Public Works used the Vactor Truck to pump out the manhole, cleared the debris, and repaired the damaged section. Meanwhile, the DOT proceeded to clear the road and restore the ditch, depositing their ditch spoils onto the Public Works' ditch spoil yard on East End Road. We agreed to allow this in an effort to restore road access as quickly as possible, with the understanding the State would remove the material, so as not to overload the limited capacity at the yard. Further, sadly, the Bagel Shop was flooded and forced to close temporarily.

So, what happened? Simply put, the heavy rain exceeded the carrying capacity of the drainage and became a "flash flood", carrying branches and even small logs down the canyon. If you look down into the canyon, which, in long stretches, is about 75' deep and over 100' across, you can see where flooding water has scoured the steep slopes as it rushed downstream.




This graphic shows the stream's substantial, natural drainage area and the slope that has eroded over time. One local property owner remembers playing in the stream as a boy, over 45 years ago, and jumping across the channel. Over time, man-made devices have exacerbated the situation. For example, several smaller streams have been diverted, adding even more water to the main channel before it crosses East End Road. It is quite likely the culvert at East End Road is undersized, especially when blocked with branches and other debris.

Why does this matter to Homer? First, it's a clear example of how the State's ability to maintain its roads can adversely affect City of Homer residences and businesses. Further, there are other streams in Homer where this same situation exists; that is, where upstream development has the ability to adversely affect downstream property. As we address this in the near future, it's good to have this real life example of the importance of effective storm water management.

Transportation Plan Update

The public review draft of the Transportation Plan is out! Copies of the plan and comment forms are available at City Hall and the library, or via the City website. There will be a public presentation and open house on Tuesday, September 26th at the college, 6-8 pm. Comments on this draft will be accepted until October 10th. Thereafter, a draft with revisions based on public comment will be presented to the Planning Commission in late 2023, followed by the City Council in 2024. Council will be provided with a full project update in September.

Seldovia Regional Partnership

Last year Council passed a joint resolution with Seldovia Village Tribe and the City of Seldovia (Resolution 22-082). The main goal of the resolution was to "increase collaboration and mutual benefit of each community's residents." On Friday, September 7th I will be traveling to Seldovia for an annual meeting with the administrators of our partner organizations to discuss regional issues and ways we can support each other. We had a similar meeting last year in September which was very productive.

Consistency of Bid Awards

At our last meeting there was a request to have a more consistent approach to how we communicate background information related to resolutions awarding bids using funds from existing appropriations. Staff has been working on developing something that will be consistent and repeatable while also answering the common questions that accompany those types of items. You should see the first steps of that in this meeting's packet, however, be advised that it is not the final form. We're still working on a solution that can be used as the template going forward.

Library Siding Follow Up

At our last meeting, Mayor Castner had some questions regarding the wall construction of the Library. We researched the issue and there is a watertight layer immediately underneath the siding, made of a product called WallShield. The product provides water protection, but it is not designed to withstand permanent exposure to the elements. The manufacturer notes that it "sustains six months UV and climate exposure prior to cladding installation."

Deaccessioning of Poopdeck Trail Sign Posts

Sign posts associated with the Poopdeck Trail on Hazel are set to be removed from the trail as well as the municipal art collection due to deterioration beyond a reasonable means of conservation. This action was

supported by a motion of the Parks, Art, Recreation & Culture Commission. A memo with more information is included with this report.

Deaccessioning the Poopdeck Trail Sign Posts

At the June 15, 2023 regular meeting the Parks, Art, Recreation & Culture Commission made a final decision that the remaining post for the Poopdeck Trail sign were crumbling and in a state of decomposition, posed a safety hazard and should be removed.

In accordance with the adopted Policies and Procedures for deaccessioning works of art that were included in the Municipal Art Collection, City Council is to be notified by Memorandum of the decision by the Commission. Following is the excerpt of the minutes from the June 15, 2023 regular meeting:

PENDING BUSINESS

9. A. Deaccessioning the Poopdeck Trail Sign Posts

Chair Lewis introduced the item and noted that Public Works Director Keiser was not present. He noted the motion that was on the table and confirmed with the Clerk that they need to vote on that motion.

LOWNEY/ROEDL MOVED THE PARKS, ART, RECREATION & CULTURE ADVISORY COMMISSION RECOMMENDS DEACCESSIONING THE SIGN POSTS AT THE BASE OF THE POOPDECK TRAIL ON HAZEL AVENUE DUE TO DETERIORATION BEYOND REASONABLE MEANS OF CONSERVATION AND DIRECT PUBLIC WORKS STAFF TO REMOVE AND DISPOSE OF AS SCHEDULE PERMITS AND FURTHER REQUEST THE MUNICIPAL ART COLLECTION BE UPDATED AS REQUIRED.

Commissioner Archibald stated that in his conversations with Public Works Director Keiser the posts are crumbling, Parks Maintenance Coordinator Felice related that it was difficult to maintain the area.

Deputy City Clerk Krause reported that Library Director Berry would prefer to see it removed since it was a hazard.

Commissioner Fair requested clarification on the act of decommission versus deaccession.

Deputy City Clerk Krause provided clarification that deaccessioning would remove the item from the city art collection and since the posts were in a state of deterioration they would be removed and properly disposed of by Public Works.

VOTE. NON-OBJECTION. UNANIMOUS CONSENT.


SUBJECT: City Manager's Report for September 25, 2023 Council Meeting

Bayview and Hornaday Park Public Engagement Meetings

Consultants Peter Briggs and Linda Pringle from Corvus Designs were in Homer on the 12th and 13th to host a series of meetings with the public, user groups, and staff as part of the initial process for the Bayview Park and Karen Hornaday Park Master Plans. I attended the two rainy in-park meetings along with an intrepid crew of community members and City staff who didn't let a little precipitation get in the way of the public engagement process. Fans of Bayview Park had a great discussion about their visions for the future of the well-used neighborhood resource. Later in the afternoon, the Hornaday Park meeting offered some shelter under the gazebo and an interactive stakeholder experience (a local five-year old's birthday party). From here, Corvus will be working with staff on plans for both parks. We expect results will come back to Council later this year.



Fund Review



Staff is preparing for a work session on October 23rd that will be the first in a series related to the various funds within the City. We'll evaluate each and give Council an opportunity to give policy guidance. We are currently developing a work sheet that can be used to ensure we have a consistent approach to the 40 plus funds that need to be reviewed. I anticipate that we will start with internal service funds and possibly a few special revenue funds. This process will take a while for Council to review each fund, but I expect that it will be worth the effort to have a refreshed understanding and written policy for all funds.

Transportation Plan Update

The public review draft of the Transportation Plan is out! Copies of the plan and comment forms are available at City Hall and the library, or via the City website. There will be a public presentation and open house on Tuesday, September 26th at the college, 6-8 pm. Comments on this draft will be accepted until October 10th. Thereafter, a draft with revisions based on public comment will be presented to the Planning Commission in late 2023, followed by the City Council in 2024. Council will be provided with a full project update in September.

Sinkhole at Deep Water Dock

In July staff noticed a hole developing next to the approach to the Deep Water Dock. Upon investigation we found erosion spanning from under the approach to where the dock trestle transitions to shore. Immediately after discovering the damage we closed off one lane of the trestle so as to keep the dock schedule open. We then rented a large 1" steel plate to span over the damage so as to accommodate truck and crane movement. Working with Public Works and HDR, Harbor staff came up with a plan for what will hopefully be a permanent solution. The affected area had to be excavated and built back with concrete blocks and heavy road fabric. We will also be working toward reinforcing the water side of the approach bulkhead before winter sets in, but

that will be a separate project. This is the second time that we have had to make emergency repairs to this general location and we are trying our best to install a long-lasting solution. We may need to come to Council at a future meeting to access Port Reserve funds for this emergency repair.



Community Jails

In 2022 we had a lobbying success related to Community Jail funding. Homer and the other approximately 15 communities that hold jail contracts with the State of Alaska were able to get an increase for the program that was shared equally between programs. Through meetings hosted by the Alaska Municipal League, Chief Robl, Lt. Browning, and I have continued to engage in advocacy regarding issues with jails and our relationship with the Department of Corrections. It's uncertain as to whether we'll see more changes or elevated funding this year, but we are actively collaborating in the process.

Fire Hall Plumbing Issues

Over the last couple years we have had ongoing issues at the Fire Hall with plumbing. This past week we worked with a plumber to fix some problems that were making the kitchen unusable. Fire and Building Maintenance are working together to figure out a plan for keeping the Fire Hall's plumbing system functional. We may come back to Council at a future meeting to discuss an appropriation to support repairs at the Fire Hall.

Alaska Hazardous Waste Program Changes

The State of Alaska is considering regulation changes that would create a hazardous waste program under the federal Resource Conservation and Recovery Act (RCRA). The reason this is exciting for Homer is that it could lead to changes in landfill regulations that may make it possible for a future facility to accept construction and demolition waste with amounts of PCBs under the current federal threshold (like we've determined through testing of the small HERC building). Staff is doing research and may come to a Council meeting in October with a resolution providing direction to staff to comment to the State on behalf of the City (comment period closes October 30th).

Comprehensive Plan and Zoning Code Update

We anticipate bringing a resolution to Council on October 9th which would authorize award of a contract for the Comprehensive Plan and Zoning Code update project. City Planner Ryan Foster discussed it with the Planning Commission at a recent meeting, and we should be ready to go at our next Council meeting.
