## VISITORS

a. Unified Command Report (20 minutes)

Homer Fire Chief Mark Kirko, South Peninsula Hospital PIO Derotha Ferraro, and City of Homer PIO Jenny Carroll reported regarding the success of the first COVID vaccination clinic for citizens 65 and over. Christian Community Church provided the space for the clinic, the City managed the planning and logistics side of the event and the hospital managed the clinical side, along with assistance from other partners and volunteers. The system they had set up worked well and they were able to vaccinate 714 people, 10 people per 15 minute, 40 per hour, and are confident they could do 10 people every 10 minutes or 60 per hour. They will continue to do the mass vaccination clinics as long as they are able because it's the best way to get it out to the most people in a short amount of time. They are waiting to find out how many doses will be received in February and will open appointments again when that information is available. Testing continues but has slowed down, we're under 1.5% positivity rate here. Visitation at the hospital has been relaxed but long term care remains closed at this time. The 714 individuals managed the vaccine well and no adverse reactions had been reported to date. They recognized the community members for doing their part in helping keep our numbers down, with no big surges following the holidays, and encouraged the community to follow the mandates to continue the downward trend.

a. Committee of the Whole Report

Councilmember Lord reported Council discussed Resolution 21-011 and park pavilion fees, Resolution 21-013 updating the MOU with UAA and KBNERR, Memorandums 21-014 and 21-015 appointments to the Port and Harbor Advisory Commission and the Cook Inlet Regional Advisory Council, also Resolution 21-012 regarding capital projects, Memorandum 21-016 and vacating drainage easements in Lillian Walli Estates, and the Memorandum regarding the Mayor's veto.

- b. Mayor's Report
  - i. Memorandum from Mayor Castner Re: Veto of Budget Line Items for Administrative Charges to the HART and HAWSP Fund

Mayor Castner commented this veto is more of an administrative action because for council to make a correction at this point would require an ordinance and two readings. It's not intended to be adversarial. He also shared that at their next meeting there will be an executive session regarding Baycrest litigation and to provide direction to the City Attorney.

Mayor Castner reported on a meeting with Governor Dunleavy and City of Kenai Mayor Gabriel where they discussed impacts of the North Pacific Fisheries Council closure of lower Cook Inlet to commercial fishing, and he brought up the closing of Homer DMV, Tutka, and the Ferry System. The Governor didn't have much to say, he has an aggressive agenda for expanding natural resource extraction, but has sympathy for expansion of our port. Kenai Mayor Gabriel addressed the management plan that puts about \$3 million worth of excess salmon up the Kenai River without being harvested. The four peninsula Mayors have agreed to sign a joint letter to the Secretary of Commerce asking him to take his time in approving the Council's closure.

b. Borough Report

Kenai Peninsula Borough Assembly member Lane Chesley reported regarding the January 19<sup>th</sup> meeting where the Assembly adopted Resolution 2021-008 asking the US Secretary of Commerce to declare a commercial fishery resource disaster due to the 2020 failure of the Upper Cook Inlet Sockeye fishery; 2021-007 approving the tourism and economic development program objectives for FY22. They confirmed the appointment of Melanie Ashelmen as Borough Planning Director, were given notice of contract award to Building Specialties for a new roof on the Homer Medical Center, and addressed ordinance 2020-45 amending Borough Code under subdivisions and appeals to clarify language and procedures.

- d. Planning Commission
  - i. Planning Commission Report

Planning Commission Chair Scott Smith reviewed the written report included in the Council packet. Noting at their last worksession the Commission discussed procedure for appeal hearings. At their regular meeting they welcomed Brad Conley to the Commission, look forward to reports from Commissioner Barnwell on the Public Works Campus Task Force work, and had discussion regarding towers in the medical district area.

e. Economic Development Advisory Commission

Economic Development Advisory Commission Chair Karin Marks reported on the Kenai Peninsula Economic Development District (KPEDD) Economic Development Annual Outlook Forum that was held by Zoom, and the topic was the Regional Community Economic Development Strategy (CEDS). At the Commission's last meeting they heard reports from Public Works and Planning on subjects they are working on and the Commission appreciates that collaboration. Commissioners reported on their outreach from an informal survey regarding COVID impacts to businesses, many of the respondents had participated in the CARES Grant programs and appreciated the assistance. They approved the draft RFP for the Wayfinding and Streetscape Plan and that will be coming to Council on February 22<sup>nd</sup>, and they'll be working on their report for the Regional CEDS at their February meeting.

f. Parks Art Recreation and Culture Advisory Commission

Parks Art Recreation and Culture Advisory Commissioner Ingrid Harrald reported Homer Foundation Executive Director Mike Miller attended their last meeting to talk with the Commission about developing an Endowment Fund and different ways to fund projects for parks and trails. Parks Superintendent Matt Steffy reported on parks and trails sanding plans, trail counters to help in prioritizing trail work, new fire rings, the successful New Year's Eve fireworks event and planning for next year, and the temporary fix of the sink hole at Bishops Beach that will have a long term repair after the ground thaws. Mr. Steffy also addressed work with the library trails, work with the COVID vaccine event, and a new disc golf course in the Diamond Creek Recreation area. Recreation Manager Mike Illg reported on the Winter Recreation Guide that's going out in the upcoming water and sewer mailing and is on the City website, also on the Community Recreation Equipment Rental Program, and online program registration software and shared the HERC is closed to indoor recreation, and the high school gym is unusable due to major roof leakage. The Commission started and will continue to address Beach Policy and personal watercraft.

g. Americans with Disabilities Act Compliance Committee

Councilmember Aderhold welcomed Deputy Clerk Krause to the group as the new ADA Coordinator for the City. They had a planning discussion with Public Works Director Keiser on one of the next steps for the group which is a self-evaluation and transition plan for parks and trails and the field work will take place this summer. They received an update on the status of the facilities transition plan and considered different perspectives in prioritizing projects

where Public Works prioritizes more along the lines of what they're able to accomplish and the ADA prioritizes access as number 1. They're addressing work needed in the airport and working through responsibility between the state and city, and signage throughout the facilities. She reported the ramp for the KHLT trail on City property is in the City's possession and will be installed when the ground thaws. The committee is also looking at website accessibility and working with one of the members who has a visual impairment on that project. Public Works is taking ownership of the facilities transition plan and updating with additional background information. It's going to be beneficial to the City moving forward to have them fully onboard with ADA compliance.

Mayor Castner raised question regarding the ownership of the airport building and recent work the City had done on the roof. City Manager Dumouchel said he would look into ownership and responsibility of the building and report back.

h. Sister City Report

Deputy Clerk Rachel Tussey provided a brief overview of recent Sister City activity that was provided in her written report, highlighting that the City was invited by the Consular of Japan to participate in the Consulate's Japan Alaska Sister City Forum and discuss projects they are planning, and that Homer currently doesn't have a Sister City Exchange Program. She hopes this new activity will spark interest in establishing that program.

Councilmember Aderhold appreciates the comments and thinks that's the purpose for having a contract like this to help ensure they're doing the right thing.

#### **CITY MANAGER'S REPORT**

a. City Manager's Report

City Manager Dumouchel commented regarding items in his written report including ongoing budget meetings between him, department heads, and the Finance Director. He plans to have a budget process schedule at the first meeting in February. He also shared his pride in the City staff working with the Unified Command on the recent vaccination event. He and other staff continue to assess the internal risk level and feel it's getting close to a point to shift from red level to orange and begin limited re-openings for City buildings. There is an Assistant to the City Manager position open, folks who are interested can apply online until February 8<sup>th</sup>.

Councilmember Evensen commented briefly regarding personal watercraft in considering higher user group fees for funds to put toward additional needs related to that use. City Manager Dumouchel noted Commissions are discussing personal watercraft but he has not received any information back. He will report to Council as information comes forward. Councilmember Evensen also shared concerns about the sinkhole at Bishops Beach and how tidal movement and beach use related to the Beach Policy.

In response to question from the Mayor, City Manager Dumouchel commented the Council Chambers remodel is ongoing. The furniture is completed we have a few issues with supply chain that are being worked on, including considering adjustments in equipment selections if needed. Staff will be doing test meetings to ensure everything is working properly before starting hybrid meetings.

LORD/ADERHOLD MOVED TO ADOPT RESOLUTION 21-013 BY READING OF TITLE ONLY.

Councilmember Lord thanked Councilmember Smith for providing the majority of the language and inviting her to co-sponsor this. She's had concerns over the division of the community and the nation, and she feels like the relationship she and Councilmember Smith

have is the way forward. They often disagree with each other's positions but they have a mutual respect for each other. She believes his ultimate motivation is what he feels is best for the community, and his respect for her comes from that shared feeling. She loves this resolution and believes this is the building block of making things work as best we can as a community, and as local government all the way to the national level.

Councilmember Smith shared he has friends and relations who are liberal and others who are conservative and he's found that its far better to collaborate your way through life and not have to look at it as compromising any specific ideal one might have. There will always be different viewpoints and the idea we can exchange views without it becoming an emotional meltdown is a much greater value.

Councilmembers shared their support and appreciation of the resolution, and of Councilmembers Smith and Lord for bringing this forward.

City Manager Dumouchel had no comments.

#### **COMMENTS OF THE MAYOR**

Mayor Castner commented Council's been talking a lot about budget, working through the truncated budget process, and addressing policy issues that need to be taken up. The Commissions have opportunities to discuss the budget as it relates to their charges and he's hopeful to hear their input as Council works through the budget.

#### COMMENTS OF THE CITY COUNCIL

Councilmember Evensen had no comment.

Councilmember Smith thanked the Christian Community Church for their collaboration in the vaccination clinic. There are reports of unsuccessful attempts to accomplish what Homer was able to, and even though we're a small community, it was still a tremendous task to pull off and he's heard nothing but good things about it.

Councilmember Venuti shared her appreciation for community members who apply to serve on the City boards and commissions, and she appreciates their willingness to get involved. She shared a quote from Benjamin Franklin, "*Tell me and I forget, teach me and I remember, involve me and I learn*". She was happy to hear the Sister City report and encouraged reaching out to Deputy Clerk Tussey for more information. Lastly she thanked everyone for their efforts at the vaccine clinic.

Councilmember Aderhold shared about attending a Municipal Climate Community of Practice gathering. It's a group that started meeting in November after AML in 2019. They had two presentations, one was by Scott Waterman about the Borough's Resilience and Security Commission that is just getting started. He shared about what they're doing, where they think they're headed, and options that may be available. It was exciting as representatives from other communities asked questions and shared interest in developing similar framework. The other was by the Anchorage Director of Solid Waste Services, Mark Spafford, who talked about electrifying his fleet and having one of the first electric garbage trucks, and shared about a new transfer station in midtown and about recycling. Someone had commented that it's too bad it's too expensive to recycle in Alaska, and Mr. Spafford countered that land is such a premium and it's always better to keep things out of the landfill.

Councilmember Lord thanked the EOC and the community for their work at the vaccination clinic. It was really warm recently and she was able to walk around the neighborhood. She reminded listeners to clean up after their dogs, it smells bad in the spring and we can help with some of that. The first session of our legislature started on Tuesday, it's a good seasonal past time to listen in at #akleg.


Mayor Castner and Homer City Council,

Honorable Governor Dunleavy,

The City of Seldovia would like to invite you and/or Commissioner MacKinnon and Captain Falvey Jr. at either our January 11<sup>th</sup> or the 25<sup>th</sup> council meeting to further discuss topics associated with the Alaska Marine Highway System as outlined below.

Seldovia, Alaska is one of thirty-five coastal communities that relies on a year-round ferry system to provide essential transportation and the M/V Tustumena and Kennicott are lifelines to the people of Seldovia. We want to support you in making the Alaska Marine Highway System a sustainable service to the public while ensuring our community's access to this necessary, dependable transportation. When the ferry is running it keeps the cost of living down for rural Alaskans.

In November 2020, Seldovia City Council passed Resolution 21-13 (enclosed) in support of the establishment of an Alaska Marine Highway System Governing Board, one of the main recommendations posed in the October 2020 "Alaska Marine Highway Reshaping Work Group Report to the Governor." The resolution also advocated for the replacement of the M/V Tustumena and emphasized the need to provide this vital and critical transportation service to small Alaskan coastal communities.

The ferry is part of the infrastructure we can expect from the state. This is an essential service to the citizens of Alaska and should not be run as a corporation. We agree with the working group report's recommendation to "(keep) the current department agency model."

Operating on the premise of making money with the marine highway is wrong when compared to the income of DOT land highways, which do not contribute funding.

We are looking forward to your response to the work group report and want to pose the following topics for discussion to be held with you in January:

#### **Topics for Discussion**

- How is the State ensuring the AMHS budget is sustainable? The FY2022 budget as proposed by the Governor reduces the Marine Vessel Operations budget by \$2,469.7M or -5.4%.
- How is progress being made on the construction of a new Tustumena ferry? What • is the long-term fleet plan for the Tustumena?
- How will the state determine and set a static and dependable ferry schedule? The • community of Seldovia is willing to entertain the idea of a reduced schedule to ensure ridership on the ferry is high.
- How will the state determine when a vessel is scheduled for the dry dock? It • would be best to make sure SOLAS capable vessels like the Kennicott and Tustumena are dry-docked 6 months apart to ensure no interruption in service.

Please know our community is willing to work with the state and is open to making changes to the existing ferry system. As mentioned in the report, the voters approved the bonds needed to bring Alaska's first ferries and docks to the Kenai Peninsula. We are a significant part of the AMHS's history and want your commitment that we will be in its future.

#### A RESOLUTION OF THE CITY COUNCIL OF THE CITY OF SELDOVIA, ALASKA URGING GOVERNOR DUNLEAVY AND THE ALASKA LEGISLATURE TO ESTABLISH AN ALASKA MARINE HIGHWAY SYSTEM GOVERNING BOARD; TO SUPPORT THE REPLACEMENT OF MV TUSTUMENA; AND TO CONTINUE PROVIDING THIS VITAL AND CRITICAL TRANSPORTATION SERVICE TO SMALL ALASKAN COASTAL COMMUNITIES

WHEREAS, the Alaska Marine Highway System (AMHS) is a critical and essential method of transportation for residents of the State of Alaska and Alaska coastal communities; and

WHEREAS, Governor Dunleavy, through Administrative Order No. 313, established the Alaska Marine Highway Reshaping Work Group on January 17, 2020 with the purpose of making recommendations on the future finances and service levels of the Alaska Marine Highway System (AMHS); and

WHEREAS, it was the duty of the Work Group to consider the analysis and data in the Alaska Marine Highway System Economic Reshaping Report (January 15, 2020) and to define the future needs and purpose of the AMHS, with the goal to ensure residents have access to essential transportation services among Alaskan coastal communities; and

**WHEREAS**, the final report was presented to Governor Dunleavy from the Work Group on October 2, 2020, and included findings and recommendations for the purpose of supporting the Alaska Marine Highway System service provided; and

WHEREAS, the report recommended that the Governor establish and appoint, by administrative order, a new nine member "operations" board, with members having skills and experience a Ferry Commission or Marine Business Board of Directors would bring to bear; and

WHEREAS, an "operations" board would help eliminate the continuing challenge for the AMHS of frequent changes in policy direction coupled with insufficient appreciation of the long-term implications of such changes; and

WHEREAS, the report found that the AMHS fleet was aged and subject to challenging Alaska marine operating conditions, and despite best efforts of ships' crews and AMHS staff, the ferry system was not reliable; and

WHEREAS, the report speaks to the focus beginning in 2014 on the importance of building an ocean capable "replacement" vessel for the MV Tustumena, which has had a 50-year plus service life; and

WHEREAS, the Statewide Transportation Improvements Program (STIP) covering all system improvements for which partial or full federal funding is approved and expected to take place during fouryear durations, published amendments in October 2020 proposing that FY2020 funding previously budgeted to construct the replacement vessel MV Tustumena to service Southcentral and Southwest Alaska coastal communities be moved to the FY2023 budget; and

WHEREAS, the postponement of funding for the MV Tustumena replacement vessel further perpetuates the unpredictable and unreliable service currently provided from use of the aged fleet that is in need of constant repair and maintenance, and does not promote the provision of long-term sustainable service to Alaskan residents and their small Alaskan communities; and WHEREAS, the MV Tustumena is and continues to be an important asset for AMHS as one of only two vessels in the AMHS fleet that is ocean-capable and can provide service as a highway and lifeline connecting remote communities in Southcentral and Southwest Alaska to the rest of the great State of Alaska; and

WHEREAS, the replacement of the MV Tustumena would be a beneficial long-term investment for the State of Alaska in supporting the continuation of that critical and essential transportation service to small Alaska communities and could provide reliable, sustainable service to other coastal areas of the state as needed; and

WHEREAS, the final report from the Work Group found that reliability was a key concern of every group with which they interacted, some commentors offering that they were willing to accept less frequent ferry service if it was more predictable and reliable; and

WHEREAS, the report states that "It is understood that serving very small communities with the ferry system model will never be cost efficient. It is also understood and appreciated that affordable transportation options are important to them. Ideally, if the overall Alaska Marine Highway System could be made revenue/cost positive, it could absorb losses on these runs"; and

WHEREAS, the Alaska Marine Highway System provides an essential transportation service to the City of Seldovia and other small Alaskan communities and it is vital that these services continue, as the AMHS is the only highway connection provided to these communities for access to the rest of the State of Alaska for employment, transportation, groceries, supplies, and general livelihood that cannot be reached without the assistance of boats or planes; and

WHEREAS, long-term sustainable access to essential transportation services that is reliable and predictable could be ensured for all Alaska residents with the establishment of an AMHS Governing Board, with a forward funding plan, and with the continuation of the project to replace the MV Tustumena in the very near future;

#### NOW, THEREFORE BE IT RESOLVED THE CITY COUNCIL OF THE CITY OF SELDOVIA:

- Section 1. That the City of Seldovia urges Governor Dunleavy and the Alaska Legislature to establish an Alaska Marine Highway System Governing Board; to support the replacement of MV Tustumena; and to continue providing this vital and critical transportation service to small Alaskan coastal communities.
- Section 2. A copy of this resolution will be sent to Governor Dunleavy and members of the Alaska State Legislature.
- Section 3. This resolution shall become effective immediately upon its adoption.

Issue: The Fleet Replacement Schedule shown in the FY 20/21 approved budget called for the replacement of a grader. We seek approval to acquire the grader, with a snow gate and snow blade, as well as two other pieces of mission critical equipment.

Background: The approved Fleet Replacement Schedule for FY 20/21 identified the replacement of a grader. In addition to the grader, we has asked for replacement of a work truck for Parks as well as two sanding trucks. In view of funding constraints, we've re-evaluated our need for these vehicles. We believe we can defer the purchase of the new work vehicle for Parks without compromising mission-critical functions. We request approval to procure the grader, and appurtenances as well as the sanding trucks, because they support mission critical activities.

The Grader. Public Works has four graders, two of which, including Unit E150, the one we need to replace, are 35+ years old. The AK DOT/PF's policy is to replace graders at 15 years and a running life is 12,000 hours. Unit E150 has had a running life of 13,500 hours. To date, we have spent over \$150,000 in labor/materials to keep the Unit E150 running. Currently, the engine and transmission are weak, likely requiring a rebuild sometime soon. The Anchorage School District had a similar machine, which was only 25 years old, with 11,000 hours of running life. They recently rebuilt their machine at the costs of \$145,000. We've been told the cost of rebuilding our machine could cost approximately \$150,000 - \$175,000, because it requires more extensive repairs. Unit E150 is currently in our shop undergoing repairs, due to broken parts. It will cost several thousand dollars and a week of down time to replace the parts.

Even if we could rebuild Unit E150, there is another problem. The unit is undersized and does not have all wheel drive, meaning it does not handle Homer's heavy wet snow well, especially in the remoter parts of the City. Last week, it had to be returned to the shop and traded in for a heavier grader, which does have all wheel drive.

The cost to procure a suitable grader, with an accompanying snow gate and blade, is \$315,000, from the AK DOT/PF's bid sheet. The 2020/21 Budget showed a price of \$200,000 for a new graders. This

26

was an estimate compiled by the Administration, without the benefit of researching actual current prices. Plus, it did not necessarily include the cost of the accessories, without which the grader is practically useless to us.

#### The Sanding Trucks.

- a. Unit E 135 is eight years old and one of our two heavy-duty sanding trucks, which run all around the City sanding roads in the winter and as general service trucks in the summer. When sanding, it carries a full load of sand and plow, which stresses its capacity. The road sand contains calcium chloride. While this is a good de-icer, which keeps the sand pourable, it causes corrosion. Plus, these trucks are ridden hard! As an example, the brake pads on a normal work truck need to be replaced every 3 years. We replace the brake pads on the sanding trucks every year. This truck has spent more than its fair share of time in the shop. To date, we have spent \$44,088 in labor and materials for repair and service costs. Our estimated cost for a new truck chassis \$50,000.
- b. Unit E 116 is a 15-year old sanding truck, which services the airport the tarmac and parking area. It's a 1-ton truck, which, when <u>fully</u> loaded with sand and a plow, is at, or beyond, capacity. This stresses the drive train and all other mechanical elements, but it works at airport because of terrain is flat. That's why this truck has lasted longer than if it were operating on City roads. Still according to our asset management software program, we have spent \$43,358 in labor/materials so far to repair this vehicle. It's at the end of its useful life as a sanding truck and we need to replace it. The estimated cost of a new replacement truck chassis is \$50,000.

#### **Funding:**

That Unit 150, the grader, with snow gate and snow blade, and Units E 135 and E 116, sanding trucks, be replaced.

Public Works has \$142,800 in its Fleet CARMA account, meaning supplemental funds need to come from another account. I recommend accessing the HART-Roads Fund for the balance of \$272,200.

As of a report dated 12-31-20, the HART- Roads Fund was worth \$6,472,383.66, subject to change upon final audit results. Since then, \$1,278,678 has been spent or obligated, leaving \$6,200,183.6 in the Fund.

#### **Recommendation:**

That the City Council authorize the procurement of a replacement grader, with snow gate and snow blade, as well as two replacement sanding trucks, \$142,400 appropriated from the Public Works Fleet CARMA account and \$272,200 appropriated from the HART-Roads Fund.

SUBJECT: ORD 21-07 DERELICT VESSEL NORTH PACIFIC- HAUL OUT AND DISPOSAL

The vessel North Pacific has been in the Homer Harbor for the past several years. In 2016 it was issued a Nuisance letter by the City and began the derelict vessel process. The owners abandoned the vessel in 2018 and ceased paying their moorage. On April 11 2020 the structural integrity of the hull failed and the vessel began taking on water in the engine room. There was a release that occurred during the dewatering process, inside the containment boom that encircled the boat, and a pollution incident that I reported to NRC documented as case # 1275399. Luckily, with a quick response we were able mitigate the damage to the public waterway by installing a pressure patch inside the vessel's engine room that stopped the flooding. However, because of the very poor hull condition, the North Pacific will, if left to its own devices, eventually end up at the bottom of the harbor.



Since April 11<sup>th</sup> we have been working in partnership with the US Coast Guard (USCG) to find a permanent solution to the environmental threat and minimize economic loss that the derelict vessel North Pacific presents to this community. The City reached out to the USCG with a plan to share the burden of disposal for this derelict vessel (See Attachment) that asked the Coast Guard to help with the removal and cleaning

of the environmental hazards and help with legally pursing the negligent owner, while the City in turn shouldered the removal and scrapping of the vessel from the Homer Harbor which is a cost not covered under the available relief funds managed by the Coast Guard.

The USCG went through processes to officially recognize the North Pacific as an environmental hazard threat to public waterways which allowed them to use the Federal Oil Spill Liability Trust Fund (OSLTF) to remove all the hydrocarbons from the vessel. The Coast Guard legal unit is also currently pursing legal action against the owner of the vessel North Pacific for abandonment and reimbursement of the cost for hazardous material disposal.

With the vessel now declared clean, for our part of the deal we've reached out to get quotes for the removal and disposal of the vessel. Logistically this will have to happen in 3 phases:

#### Phase 1 – Prep.

**Scope of Work**: This includes an inspection of the vessel at the steel grid to make sure that the integrity of the hull is strong enough to endure the stresses involved in hauling the boat out and onto the uplands area of the Marine Haul Out facility for scrapping, as well as cutting and removing by crane lift any deck gear and dredging equipment from the top sections of the boat prior to dragging it out onto the beach.

**Price**: We received two quotes, both from highly qualified local firms that have history working within the Harbor. We propose the lower priced quote from C&C Diving and Salvage of <u>\$15,000</u>. **Timeline:** February - Taking advantage of the high tide cycles

#### Phase 2 - Haul Out

**Scope of Work:** Haul Out of the vessel from the tidal flats to the uplands utilizing an airbag system. **Price:** This was a sole source bid, there was only one contractor in the area with the correct equipment and willingness to take on this vessel. Fortune Sea Marine Services for <u>\$20,000</u>. **Timeline:** March

#### Phase 3 - Scrapping and Disposal

**Scope of Work:** Demolish and dispose of all metals, insulation, garbage, etc., related to the Vessel North Pacific from the uplands lot next to Outer Dock Road

**Price:** This was a sole source bid, there is only one recycling scrap company with the proper equipment and disposal avenues on the peninsula that is available for the job. Alaska Scrap and Recycling for <u>\$63,700</u>. Alaska Scrap and Recycling is willing to accept a credit of their bid amount toward future lease, wharfage, and dockage fee's associated with the Port of Homer in exchange for the demolition and removal of the North Pacific.

Timeline: July

Dear Sir,

As the Port director and Harbormaster for the City Of Homer, I am working to find a permanent solution to the environmental threat and minimize economic loss that the derelict vessel North Pacific presents to this community. Firstly, I believe it's important to state up front that the City of Homer is not the owner of the vessel North Pacific. The owner is North Pacific Gold LLC. However, due to the neglect of the owner and the imminent threat of pollution to our waterways, the community has been left with no choice but to supply the manpower, equipment, and expertise in order to protect against a sunken vessel pollution release and avoid a tremendously expensive and embarrassing salvage effort in our community's harbor. I believe our two agencies are the best equipped to deal with this threat, and suggest a joint venture between the U.S. Coast Guard and the Homer Harbor to safely remove this threat in as economical a way as possible and to pursue restitution from Paul Thompson Jr, president of North Pacific Gold LLC.

On April 11 2020 the structural integrity of the hull failed when, during an extreme minus tide, the North Pacific set down on the harbor floor causing a crack in the hull and the vessel began taking on water in the engine room. There was a release that occurred during the de-watering process, inside the containment boom that encircled the boat, and a pollution incident that I reported to NRC documented as case # 1275399. Luckily, with a quick response we were able mitigate the damage to the public waterway by installing a pressure patch inside the vessel's engine room that stopped the flooding. However, because of her draft and very poor condition, she will try to sink again. To keep this from happening I'm proposing the following plan:

#### I'm requesting that the United States Coast Guard:

- ✓ Officially recognize that the vessel North Pacific poses an imminent threat to the environment and public due to the near sinking and pollution release in Homer Harbor that occurred on April 11, 2020. More specifically, taking note of the issue of vessel draft, obvious hull condition/neglect, depth of Homer Harbor, and the pollution potential that exists when the hull is compromised.
- ✓ Officially recognize North Pacific Gold LLC as the owner of the vessel North Pacific so that Coast Guard personnel can pursue the restitution of cost for the pollution mitigation from the vessel owner Paul Thompson Jr. and North Pacific Gold LLC.
- ✓ Engage the pollution fund to hire a firm to clean all of the hydrocarbons from the vessel to mitigate the environmental threat and the danger to the public

#### The City of Homer is offering in partnership:

✓ Once the vessel is cleaned of hydrocarbons, the City of Homer and Port staff will move the pollution free hull from its current location in Homer Harbor to the Homer haul out and repair yard for removal from the water.

The City will engage the firm Alaska Scrap & Recycling to responsibly demolish the North Pacific and dispose of the vessel from the system. "Responsibly demolish" means that all salvageable material will be recycled, all waste material will be removed to the landfill, and the disposal site will be cleaned and return to original condition.

An evaluation of the April 11th event brought to light new information about the vessel and underlined just how present the threat of this vessel sinking is. The North Pacific is a deep draft single keel vessel that has been extended and widened at some point in her life. Because of her draft, the North Pacific sets down on the bottom of the harbor during any minus tide. Earlier that week we experienced an extreme low tide -5.2 and that translated into nearly the full weight of the vessel resting on the keel, and we believe that the stress of settling the old unmaintained hull on the harbor floor caused a bracket welded to the bottom of the bilge to crack, and that it was this cracked weld that started the leak resulting in a full response effort from the harbor staff and diver/salvage team. Because of the lessons learned on April 11<sup>th</sup>, we know that the vessel hull condition is such that future hull integrity issues from setting down are expected at each minus tide, and this vessel will try to sink again. Given these new factors, I would ask the Coast Guard to reconsider the issue of using the pollution fund and engage a firm to clean all of the hydrocarbons from the vessel to mitigate the environmental threat and the danger to the public.

I believe that if we work together to take these steps we will remove the North Pacific's environmental threat to the public permanently. Further, it will assist in holding the owners of the vessel North Pacific Gold LLC responsible for their property. Please be advised that the City is also continuing our efforts to that effect, and at this time we are working with our attorneys to pursue legal action against the firm for back debt and abandonment of their vessel on the public's property and for disposal costs.

I want to thank the USCG for their support and guidance over the years; our community is being well served. I have always viewed our relationship as a partnership in service as we all have the same goals of safety, service and stewardship.

In 2007, security camera systems were installed at the Homer Public Library and the Homer Airport. These systems are well past the end of their designed lifespan, and many of the cameras are no longer functional.

In 2018 and 2019, the City Council approved funds to replace these systems and upgrade them to meet modern standards. The project has been significantly delayed and redesigned due to requirements imposed by the federal government. The National Defense Authorization Act (NDAA), passed in 2019, dictates that security equipment installed at airports must contain no Chinese-made components. This has limited the choice of available suppliers and driven up costs, as well as slowed delivery through supply chains. COVID-19 has further delayed the project, both by tying up suppliers of the equipment and by forcing City personnel to concentrate on other tasks.

In late 2020, the City advertised for bids to supply and install the equipment at both locations. The winning bid, from Sherman Technologies, was selected in January 2021. Sherman Technologies has offered to complete the full project at a total cost of \$76,100. The City will also need to pay \$3,600 for additional software licenses to support the new cameras, bringing the total cost to \$79,700. This is an increase of \$19,700 over the existing \$60,000 appropriation.

In the estimation of the City IT Manager, the bid includes a reasonable cost increase, given the two years that have elapsed since the original appropriation and the aforementioned complications in the equipment supply.

### RECOMMENDATION

Appropriate an additional \$19,700 to cover cost increases and complete the project and follow up with a Resolution awarding the contract to Sherman Technologies to supply and install security cameras and supporting equipment at the Homer Public Library and Homer Airport.

### FY22/23 Budget

In the last two weeks of January I hosted eight budget kick off meetings with members of the leadership team to discuss the FY22/23 budget. These initial meetings were very informative for myself and the department and division leaders seemed to get a lot of value out of the exercise as well. In February, the Finance Director and I are focusing on deconstructing and reconsidering various "overhead" calculations. At the second meeting in February, we will have a discussion with Council regarding budget priorities for the upcoming two-year cycle.

### Land Clearing and Air Quality

In recent weeks there has been a significant amount of land clearing in Homer and Kachemak City which has caused unfavorable smoky conditions. This has been noticed by HVFD staff and they have conducted outreach to those with burn permits within city limits to discuss cold weather burning best practices. See attached for a memo from Fire Chief Kirko regarding the current situation and some changes he is proposing to our existing burn permit requirements. Changes to the conditions imposed on those seeking burning permits are within the powers of the Fire Chief per HCC 5.20.020 (d).

### **Future Firework Locations**

Inspired by comments from Councilmember Evensen, I initiated a conversation with Police, Fire, Harbor, and Public Works staff about potentially directing future fireworks displays to a location towards the end of the Spit. The popularity of the current New Year's Eve program appears to be outgrowing Mariner Park, and there are some additional benefits possible in moving the show further from town. Staff has been directed to conduct outreach to the event organizer and will continue to fine tune the concept of a new preferred fireworks location.

### Water Main Break at Lucky Shot

Recently the Public Works Department responded to a water main break on Lucky Shot Street. The narrative and photos below are provided by Director Keiser.

When Superintendent Todd Cook got to the Water Treatment Plant in the morning, he noticed water volumes, as shown on one of the meters, were abnormally high – a clear sign of a water main break somewhere. He traced the data back and found the spike started about 10:00PM last night. He immediately started driving around looking for clean, chlorine-smelling water where it shouldn't be and found it in a ditch on Lucky Shot Street. He was able to bracket the location of the break and direct the road crew's operators where to start digging.

Once the backhoe operator opened the street, you could see clean water bubbling out of the ground, like a spring. He kept digging and eventually got to the pipe, which was cast iron and leaking from obvious cracks in the pipe. As he was exposing the pipe, other crew members were keeping the hole dewatered with pumps and mobilizing parts for the repair. The water/sewer crew turned the water pressure down and notified the neighbors they would have little to no water for a while.

Once the pipe was fully exposed, the water/sewer crew cut out the section of pipe that was cracked, cleaned it and installed a new section of pipe, connected to the existing pipe with special couplings. Everything was cleaned and disinfected with our home-made chlorine solution. The water was gradually turned back on, to reduce excess pressures in the line. Plus, our inspector came out and measured the location of the water break, so it could be as-built on our system maps.

When it was clear no further leaking was occurring, the water/sewer guys packed up their gear and left. The road crew stepped back in to do the backfill and restore the road and a private driveway we had to take out in the repair process. Lucky Shot Street is a paved road, but the paving patch will need to wait for warmer weather.

What was a pleasure to watch was how well the crew worked together, even the folks who were relatively new to their roles. It was a dirt-moving ballet!

The photos below show Todd Cook and Paul Raymond digging out the cracked water main, and Ralph Skorski beside the successful repair.



### Meeting with AKDOT&PF Commissioner McKinnon

On January 28<sup>th</sup>, our lobbyists were able to arrange for a meeting with Alaska Department of Transportation and Public Facilities Commissioner John McKinnon and Deputy Commissioner Rob Carpenter. Myself, Harbormaster Hawkins, and Special Project Coordinator Jenny Carroll were in attendance. We discussed the regional importance and funding needs for the port expansion project and Spit erosion management general investigations. We also discussed potential Federal COVID relief funds for transportation and the Governor's GO Bond package plans.

### **Remote Sales Tax**

In 2020 the City of Homer began receiving sales tax income via the Alaska Remote Seller Sales Tax Commission (ARSSTC). This program has the benefit of collecting sales tax fees the City was not previously able to collect. In 2020, the City received \$183,955 from ARSSTC. The City paid \$39,947 in fees to the Commission in 2020. Starting with the FY22/23 budget, this revenue source will have its own line.

Much like our regular sales tax collected by the Borough, there is a lag between when a taxable sale occurs and when the City receives income. The table below show the funds received in 2020 and breaks them into the City's different sales tax streams. It is difficult to forecast the long-term impact of this revenue because 1) it is a new revenue source; 2) COVID has greatly disrupted spending habits and patterns. I believe, based on the limited amount of data we have so far, we would be conservative in saying that funds from ARSSTC could easily exceed \$300,000 on an annual basis.

### FY21 State Homeland Security Grant Requests Submitted

The application period for FY21 State Homeland Security Program grants just closed. Over the years, SHSP grant support has been instrumental in incrementally and systematically keeping our public safety communications system up to date. This round, the City applied for two critical pieces of equipment: (1) a bidirectional amplifier system to improve radio communication coverage for ALMR system channels inside the new Homer Police building. An unanticipated high noise floor level in the new building interferes with ALMR radio signals making it necessary to amplify ALMR radio signals; and (2) microwave links that carry radio control, data, video and voice traffic from dispatch to Homer Police Department, and during emergencies, to the City's response personnel in the Fire, Port & Harbor and Public Works departments. The microwave link the City relies on is aging out of manufacturer support and is not capable of fully meeting current system needs. Should the City be successful in these requests, we will bring an ordinance to Council for grant acceptance and request sole source procurement of funded items to insure they are compatible with and successfully integrated into our communications system.

### New Certified Municipal Clerk - Rachel Tussey

I would like to congratulate Deputy City Clerk Rachel Tussey who has earned the designation of Certified Municipal Clerk (CMC) from the International Institute of Municipal Clerks (IIMC). According to IIMC, the CMC is a "declaration that you are proficient in your important position and that you have demonstrated mastery of administrative skills critical to good government."

"I'm super excited for Rachel and very proud of her accomplishment! When we planned for 2020 training she was slated to attend two weeks at the Northwest Clerk's Institute (NCI) in Tacoma to complete her education requirements for this certification. ### **COVID-Related Updates**

### **COVID Risk Status**

On February 1<sup>st</sup> I moved the City from the "Red" to "Orange" level on our COVID risk framework. The move to orange allowed for a limited reopening of the HERC and the Library by appointment-only. The change in risk level also allows staff to hold more in-person meetings as long as masking and social distancing guidelines are followed. As an organization we continue to do quite well with very minimal positive COVID cases or close contact related absences across the last couple months.

### **COVID Vaccine Clinic Support**

On February 2<sup>nd</sup>, City staff and volunteers assisted SPH with phone-in appointment setting for the February 5<sup>th</sup> & 6<sup>th</sup> mass vaccine clinic. A phone-in option is key to providing vaccine access and assistance to those in our

community without computer or internet. The scheduling was very smooth and more satisfying to callers this time around thanks to a call queue system developed by IT Manager Nick Poolos for the vaccine call line. Thanks go out to community volunteers for their time assisting!

### **Council Chambers Update**

Work continues on the Council Chamber update. The furniture pieces are largely complete but we're continuing to have some supply chain issues for a handful of electronic components. I'm hoping to have a solution to that shortly. SUBJECT: AIR QUALITY

In recent weeks there has been a significant amount of land clearing in Homer and Kachemak City causing unfavorable smoke conditions in the area. The smoke conditions are noticed by most and may produce a health risk to some citizens with existing respiratory problems. Our burn permit regulations are clear, but I am suggesting some revisions to the requirements.

I would like to add two statements to the existing burn permit requirements:

- No burning will occur when exterior temperatures are below 34 degrees.
- The fire department may require permitted fires to be extinguished if smoke conditions are determined to be a nuisance by a fire department official or multiple complaints are received from the public.

At this time, the fire department is reaching out to burn permit holders and reminding them of the requirements for burning and advising them to only burn when conditions are suitable.

The other problem that exists is that we are not the only regulatory agency for the affected area. The State and Borough also have a part in the permit and enforcement process that is similar to what has been adopted by the local jurisdiction.

I am actively working with the borough area fire departments and the Alaska Division of Forestry to improve the burn activities and educate the community on the open burning process and regulations.

Attached is a copy of the existing City permit and a State Forestry Small Scale Permit brochure for your review.

### CITY OF HOMER OPEN BURNING PERMIT REQUIREMENTS

- 1. Only wood, slash and other similar natural materials may be burned. The open burning of synthetic materials, flammable liquids or materials that produce black smoke, noxious or toxic gas shall not be permitted.
- 2. A firebreak, clear of all combustible materials, shall be provided for a minimum of ten feet or equal to the diameter of the burn pile, whichever is greater. A minimum clearance from structures or other improvements of 50 feet or four times the diameter of the burn pile, whichever is greater, shall be provided.
- 3. Burn piles shall not exceed 20 feet in diameter and 10 feet high. (Requires Site Inspection)
- 4. Material to be burned will not exceed 4 inches in diameter.
- 5. Material to be burned will be as dry as practical. Piles left standing should be covered to permit adequate drying.
- 6. When multiple piles over 10 feet in diameter are to be burned on the same site, one pile shall be lit as a test burn and the burning conditions assessed before any additional piles are lit. Smoke should rise at least 500 feet and remain clear of all inhabited structures.
- 7. The smoldering phase of the fire will be minimized by tending and consolidating the open burn as it progresses into the smoldering phase and will be fully extinguished when active flaming combustion can no longer be maintained.
- 8. All open burning must be tended continually for maximum combustion and safety until the fire is fully extinguished. Fully extinguished is defined as cold to the touch with no hot ash or embers.
- 9. Equipment and personnel capable of extinguishing the open burn must be on site throughout the burn.
- 10. All State of Alaska regulations for open burning and permit requirements must be met.
- 11. As a condition of this permit the emergency dispatcher center must be notified immediately prior to lighting any open burn. <u>Call 235-3150</u>

Violation of the terms of this burning permit may result in suspension modification or termination of this permit. It may also subject you to civil and criminal penalties and the cost to extinguish the fire.





To the City of Homer, Mayor Castner and City Council Members,

This year, as with theatres across the world, the Coronavirus pandemic forced Pier One Theatre to close its doors. Our planned season flew out the window, and we faced a year of financial uncertainty and disconnect from our community. As we reflect on the last year, all of its strangeness, and all of its small miracles, we can clearly see that we could not have survived on our own. Your Herculean efforts to administer funds to businesses and organizations in need have sustained us throughout the pandemic. The CARES funds, SBERG and NERG, and the matching funds from the Rasmuson Foundation which you so diligently distributed were essential to the survival of Pier One Theatre. Thanks to these economic relief packages and the tireless efforts of funders to reach communities, we had a very different season than we were anticipating.

In addition to being able to meet our basic operational expenses, we had a surprisingly full season including an acting technique workshop, a Drama Slam in conjunction with the Alaska World Arts Festival which resulted in the creation of nine new plays, and a holiday film which collected music, poetry, and dance celebrating the season. We teamed up with the Center for Alaskan Coastal Studies for their Coastal Cosmic Telethon and live-streamed five original plays celebrating the natural world around us. We collaborated with KBBI AM 890 to produce three radio plays including *The Importance of Being Earnest* by Oscar Wilde and two original plays by local playwrights, *Rising* by Brenda Dolma - a story about grief and climate change, and *Shakespeare in Quarantine* by Jessica Golden - a modern take on the writing of King Lear while theatres were closed due to plague. We enjoyed an overwhelmingly positive response from the community when we helped celebrate Mary Epperson Day in June, and in October shared a curated live performance of *Haunted Shakespeare: His Murdered, Ghosts, and Otherworldly Creatures* - two COVID safe walks on the Pratt Museum trails featuring over 30 local actors (*Haunted Shakespeare* was also filmed and will be released sometime early this year). It is very clear that the residents of Homer are longing for more live theatre!

This past year has called on all of us to reimagine, to adapt, and to work hard for the community in ways we could never have anticipated. You have risen to the challenge and supported us all the way through. As we look to the end of the pandemic and a brighter future, we hope you continue to view the arts as a core part of society that lifts our hearts and strengthens us all.
