#### 6.A. Port & Harbor FY26 YTD

- Discussed the correction of a meeting date from August 27th to September 24th, and the approval of September 2025 meeting minutes. Staff presented a comparison of harbor mortgage rates across Alaska, showing Homer's daily rate of \$1.90 per foot is higher than other harbors, and shared a proposed rate table for 2026 with a CPI increase. The discussion covered the completion of a geotechnical investigation by Hyrex Fanchen, and an invitation to bid process for cold storage units at the ice plant closing on the 30th. The conversation ended with an announcement that the Harbormasters office will no longer be open on Saturdays starting next summer, with staff seeking feedback on minimizing customer impact.
  - 6.B. Port & Harbor Staff Report October 2025
- Discussed staffing on Saturdays, confirming it's typically one admin, and William expressed support for a phone tree system if it connects to a real person. The group reviewed the council meeting schedule, noting a potential conflict with the EDC meeting on November 12th, and agreed to discuss rescheduling at the end of the meeting. Updates were provided on several special projects, including the selection of a contractor for the ICE metering system installation and positive developments regarding the System 4 float replacement, with engineers from RESPEC completing fieldwork and awaiting their report.
















Approximately 30 floatation billets were install 12 and 10" of freeboard raised on the float system.

The On-going Homer Harbor Expansion Project Involving a General Investigation with the USACOE is now in its third year. We achieved project milestones in selecting alternative 2 for the harbor basin and completed the core sampling component of the geotechnical work.








### Homer's Marine Repair Facility


Seas 6' to 8'

#### Homer Harbor Expansion General Investigation Update

**Purpose:** This memorandum provides the Homer Harbor Expansion Study monthly written update to Homer City Council per Resolution 23-037.

**Background:** Following the announcement of the new US Army Corps of Engineers' policy requiring General Investigation (GI) studies to reach 35% design level, the Project Development Team (PDT) initiated revisions to the Project Management Plan's scope, schedule and budget to accomplish the new design standards, while awaiting official guidance from USACE Headquarters regarding how to implement the policy change. My September 17, 2025 HHE GI update reported a tentative budget increase of approximately \$880K and a 7-month extension of the study's timeline.

**Update:** At the October 22, 2025 PDT meeting, we learned that guidance from USACE Headquarters is getting firmed up now that the new Assistant Secretary of the Army for Civil Works, Adam R. Telle, is established in his role. PDTs are being directed to meet the new 35% design mandate within the existing study timeframe and with minimal budget increases by removing or streamlining internal procedural tasks within the PMP, such as shortening or combining internal review periods, while still maintaining compliance with all legal study requirements, including a full public comment period.

The Pacific Ocean Division and Headquarters are systematically working through an ordered list of Alaska District projects to review amended PMPs. The Homer Harbor GI has not yet come up in the review queue. The Alaska District is currently preparing its suggested course of action for the Homer Harbor GI PMP discussion, which is anticipated to occur in November.

Once we learn whether any additional local sponsor matching funds are required, staff will be prepared, if applicable, to present an Ordinance to appropriate City funds and a Resolution supporting the State's share in the match for City Council consideration.

### **Current Study Activities:**

- **Geotechnical core sampling:** Last week, contractors completed collection of core samples at eight locations throughout the study area. The samples have been sent to a laboratory for analysis of sea floor material type, density, and strength. This data will help engineers understand ground conditions and inform breakwater design requirements. Seabed samples were also collected to analyze whether dredged material may be suitable for beneficial uses such as uplands or beach nourishment.
- Economics: The PDT completed their Cost-Effectiveness/Incremental Cost Analysis (CE/ICA). This is a required tool to evaluate and compare different project alternatives to find the most efficient and justified solution. The CE/ICA will undergo Agency Technical Review for approval in early November.

### **City of Homer staff:**

- Attended twice-monthly USACE Project Development Team meetings.
- Assisted with letters to the Alaska Congressional Delegation providing an update on the study, the 35% design policy change and requests for support for:
  - o expedited agency approval process of the revised Project Management Plan,
  - o federal mechanism to provide additional study funding if needed, and
  - o maintaining USACE staffing levels moving forward to prevent operational disruptions that could impact the USACE study timeline.
- Met with Senator Murkowski's staff on 10-15-2025 and Representative Begich's staff on 10-23-2025.
- Ongoing Communications/Outreach: Information and updates about the study are being disseminated through the Homer Harbor Expansion website, the City of Homer Facebook and Instagram pages and through HHE email subscriber list as needed.

### Homer All-Ages and Abilities Pathway (HAAP) Project Update

I am pleased to report positive momentum on the HAAP project. On October 16, Council Member Parsons and city staff met with Romo Marasigan, Alaska Department of Transportation (ADOT) Planner for Homer, and two engineers from the Department of Natural Resources for a site visit of the HAAP project. Mr. Rys Miranda and Mr. Rangell Soriano of the Department of Natural Resources, State Parks Division, will develop the design, and Mr. Soriano, as Project Manager, will also possibly provide construction management on the project for ADOT.

The purpose of the visit was to conduct a comprehensive walkthrough of the original project scope, with particular attention to the City's prioritized HAAP sections for development under the Transportation Alternatives Program grant. This on-site visit allowed the state team to gain knowledge of the terrain and discuss existing conditions and specific challenges with Public Works staff in order to develop a more accurate project cost estimate. This information will be essential as we move forward with negotiating the Memorandum of Agreement (MOA) for the project. Once the MOA has been reviewed by the State's law division, it will come to the City for review in consultation with the City Attorney.

We appreciate the collaborative partnership between ADOT and DNR, and will be very excited to see meaningful progress on this project that will fill critical gaps in our sidewalk network to enhance safety and accessibility for all users.
