Session 21-24 a Special Meeting of the Homer City Council sitting as Board of Adjustment was called to order on September 20, 2021 by Mayor Ken Castner at 4:00 p.m. at the City Hall Cowles Council Chambers located at 491 E. Pioneer Avenue, Homer, Alaska, and opened with the Pledge of Allegiance.

NEW BUSINESS

a. Memorandum 21-153 from City Clerk re: Motions filed by Appellant Frank Griswold Related to the Appeal of CUP 20-15 and Zoning Permit 1020-782

Mayor Castner opened the floor to comments from the parties. He proposed 10 minutes for each side to comment, that appellant Frank Griswold would comment first then Attorney Holmquist on behalf of the City.

Mr. Griswold, participating by telephone through Zoom, asked to raise a procedural matter regarding the Board of Adjustment not having representation as mandated by Homer City Code. Mayor Castner advised that Attorney Brandt-Erichsen was in attendance via Zoom.

Mr. Griswold raised the matter that neither the notice that was mailed nor the agenda has any provisions for comments until the end at audience comments and he thinks a lot of people may not have been aware they could comment and he was unable to prepare a statement.

Mayor Castner reiterated he's providing an opportunity to for the parties to speak. He added that motions for reconsideration typically come from within the body, that they've never had a third party request for reconsideration, and that isn't a procedure in Homer City Code (HCC) to allow it to take it up.

Mr. Griswold commented if the Mayor had read the email he sent he explained with specific examples how he has submitted motions for reconsideration in the past that were provided to the Board by the Clerk for review. He also argued that it didn't seem that the Mayor was aware of what the memorandum from the Clerk is about, and clarified it's about two motions for reconsideration and a motion for leave to supplement his points on appeal, because he wants to appeal the decision of the Planning Commission decision on remand to the Board of Adjustment. Mayor Castner attempted to give assurance that the Board would listen to his arguments and make a decision whether to consider the matters.

Mr. Griswold continued that the City Clerk's duties are ministerial and not adjudicatory and she can't reject timely filed motions to the Board of Adjustment, but should have forwarded them to the respective bodies to decide whether to take them up. He addressed the differences of the notice of appeal rights on the decisions that were issued and that a decision of the Planning Commission can't be appealed directly to the Superior Court. He appealed to the BOA, the BOA remanded to the Planning Commission, a remand decision isn't a final decision, and only final decisions can be appealed. The Planning Commission never took up the remand, they waited for a strategic withdrawal of the CUP so they wouldn't have to take it up, and they don't have the authority to dismiss the appeal. The BOA has never issued a final decision. If he filed it in Superior Court they would likely say he has not exhausted all his remedies and it should go to the BOA for final decision before the Court takes it up.

Attorney Holmquist explained there is no authority or procedure in City Code to hear a motion for reconsideration of a final written decision. The Alaska Supreme Court has held that administrative agencies such as the planning Commission or the BOA only possess the authority expressly granted to them under statute or code, so they have limited jurisdiction or they only possess the authority that's granted to them by implication, as necessarily incident to the exercise of powers that are actually granted. Homer City Code provides that the appeal of a final decision should be filed in the Superior Court. The Supreme Court has held that where there is no provision for reconsideration, an administrative statutes ordinances the administrative decision is final.

Mayor Castner noted Mr. Griswold made good points about what happened after the remand and that it leaves him in limbo. He asked what the City's position is regarding that.

Attorney Holmquist explained that in the motion to dismiss provided to the Planning Commission they outlined that neither the Commission nor the BOA have jurisdiction or authority to decide any issues raised in the appeal with the applicants withdrawal of their application because it invalidated the CUP, because there was no longer a permit to base an appeal on. Their argument is that it didn't matter whether the Planning Commission or BOA issued the final decision because neither had the authority to take any further action. Regardless whether the Planning Commission or the BOA takes action to dismiss the appeal the end result is the same either way. He reiterated the appeal must be dismissed because there's no jurisdiction or authority to take any further action on it after the applicant withdrew their application. He added if at some future time the applicant determines she wants to refile for a CUP then she will need to go through all the steps of the CUP process again.

Mr. Griswold rebutted by pointing out Homer City Code has a catch-all that the BOA or hearing officer may proceed and administrative appeal in any lawful manner, not inconsistent with this title statutes and the Constitution, so considering a motion for reconsideration is allowed by 21.93.570. Because it's not inconsistent with statutes or the Constitution, it's clearly contemplated by the superior Court and the fact that it has been the policy of the city in the past under the same set of rules to at least take them up.

LORD/ADERHOLD MOVED THAT THE BOARD OF ADJUSTMENT TO ADJOURN TO EXECUTIVE SESSION TO DISCUSS THE APPELLANT FRANK GRISWOLD'S MOTION FOR RECONSIDERATION AND LEAVE TO SUPPLEMENT POINTS AND APPEAL TO ADDRESS PLANNING COMMISSION'S DISMISSAL OF APPEAL REGARDING THE APPEAL OF CUP 20-15 AND MOTION FOR RECONSIDER RECONSIDERATION REGARDING THE APPEAL OF ZONING PERMIT 1020-782 AND HAVE ATTORNEY BRANDT-ERICHSON JOIN US IN EXECUTIVE SESSION.

VISITORS

a. COVID-19 Agency Update Derotha Ferraro, South Peninsula Hospital Director of Public Relations & Marketing and Lorne Carroll, State of Alaska Public Health Nurse III (10 minutes)

Lorne Carroll, State of Alaska Public Health Nurse III, shared a brief overview of the new cases dashboard on the COVID-19 Statewide Dashboard, highlighted updated information, and explained how to navigate through the improved dashboard. He provided a copy of his presentation slides. He shared regarding the impacts to hospitals statewide and eligibility for Pfizer boosters.

Derotha Ferraro, South Peninsula Hospital (SPH) Public Information Officer reported boosters are available at primary care clinics and the hospital vaccination and testing site on Bartlett Street where appointments are encouraged at this time due to work being done at the site to accommodate the monoclonal antibody infusions at the site. There will be a mass vaccine event for the Pfizer Boosters on October 15th, and they'll also have flu shots available. She reviewed testing, vaccination and monoclonal antibody and hospitalizations over the past two weeks. At this time SPH hasn't been faced with decisions regarding rationing care, other than with rescheduling inpatient surgeries. The State requested staffing support through FEMA and will get just over 500 individuals. SPH will get 6 nurses, 5 CNA's and a surgical tech to help staff. Vaccinations aren't mandated for hospital employees, but they anticipate CMS (Centers for Medicare and Medicaid Services) releasing emergency regulations that will require it. She

encourages people with question to reach out to CMS or their legislators since it's a federal guideline that's tied to participation in the Medicare and Medicaid programs.

There was brief discussion about vaccination status for children. They also touched on eligibility and cost for monoclonal antibody infusion, and clarification that monoclonal antibody infusion is not a replacement for the COVID-19 vaccine.

Councilmember Lord reported Council discussed Ordinance 21-60 635 regarding invasive species management and talked with Police Chief Robl about increased activity around local drug use, speeding and traffic management, and department staffing.

b. Mayor's Report

Mayor Castner noted the letter to the community that was drafted by Councilmember Aderhold, approved by Council and he signed on their behalf, and clarified that it was not his letter, but the Councils.

He explained he received a letter from the Municipality of Alaska this morning that's provided in the supplemental packet that he's been asked to sign on behalf of the City of Homer. It's a letter from the Municipality of Anchorage to US Department of Transportation Secretary Buttigieg in support of funding for repairs at the Port of Anchorage.

There was discussion among Mayor and Council about this \$1.2 billion project. Some expressed concern about possible impacts to funding for Homer's expansion and Harbormaster Hawkins explained he didn't think there would be any. The Port of Anchorage project is to replace their existing facilities with a new ones, not an expansion. He agrees with supporting the letter because the port is critical to us for our supply chain. They also addressed the misuse of funds by Anchorage on prior port improvement projects, the current dire condition of the Port of Alaska, and the significance of the port to communities on the road system and the supply chain it provides.

LORD/ADERHOLD MOVED TO SUPPORT THE MAYORS SIGNING ONTO THIS JOINT LETTER CONCERNING THE PORT OF ALASKA.

e. Economic Development Advisory Commission

Economic Development Advisory Commission Chair Karin Marks reported on the Wayfinding and Streetscape Planning work being done and they're moving well along the proposed timeline. At their last meeting they had reports from Kenai Peninsula Economic Development District and Alaska Small Business Development Center to help the Commission stay current on related topics and it's helpful for them as they work to set their strategic plan and goals for 2021/2022. They also discussed the proposal for a grant for proceeding on a Multi-Use Community Center to replace the two HERC building.

f. Parks Art Recreation and Culture Advisory Commission

Parks Art Recreation and Culture Advisory Commission Chair David Lewis reported at their last meeting the Commission continued their work on a Lend a Leash Program in conjunction with the Friends of the Homer Animal Shelter to help address issues with dogs running loose on Bishop's Beach and Mariner Beach. CITY MANAGER'S REPORT

a. City Manager's Report

City Manager Dumouchel reported on the Fire Fighter 1 class to become a Volunteer Fire Fighter for the City. There's information on the website or folks can call the Fire Department, we need people to join our team.

In response to questions he reported on the location of the half-pipes at the existing Skate Park.

Councilmember Aderhold expressed her apprecaiton for the completion of the ADA parking spaces at the harbor.

Councilmember Lord noted the Planning Commission's written report and asked if there's a role for the Council in the conversation on the concerns with water drainage. She'd like to be kept abreast of what's happening on that front and how to help move it along.

At the request of the Mayor, Public Works Director Keiser commented regarding the tools the city has now for addressing drainage management plans in development but none of it is tied together in a consolidated plan. There's also a gap during the development when clearing is done before ditches are built, culverts are installed, and before building is completed so water doesn't drain properly. It's something they've discovered is causing a problem and Public Works will be working with Planning to address that gap time.

Councilmember Aderhold acknowledged the significance of addressing drainage and how were going to handle water. Another big part of it is trees, which soak up a lot of water and to a lot of good that gets taken away when someone buys a big piece of land and cuts the trees down. It feels like there needs to be some planning related to retaining trees to the extent we can until something is built.

Councilmember Aderhold commented if we can keep inching forward with DOT and reminding them we have other types of transportation besides cars and trucks and that we need to provide for non-motorized transportation also.

Councilmember Smith noted normally there's a project nomination process that we were left out of. He doesn't know what to do be more proactive to provide input. He talked to Representative Vance about this long standing problem.

Councilmember Lord appreciates how many pieces the resolution pulls in and the case it makes, and she appreciates Councilmember Smith's comments and his reaching out.

Councilmember Venuti thanked Kevin Walker for his comments earlier and shared about her time on the Transportation Advisory Committee when they discussed this and ideas that developed. She agrees it should be on the city side, not the ocean side.

Public Works Director Keiser interjected about receiving a letter from the state notifying us they're doing a scoping study of the Kachemak Drive Pavement Preservation Project. They're seeking input from the City and we're in the process of preparing comment related to drainage. She thinks this resolution is very timely.

Mayor Castner noted the Lake Street project originally had no cross-walks or west side sidewalks in the design, and we asked poignantly for some solution for pedestrian crossing and that was achieved, so there is some latitude when they go through their budget. He thinks that's encouraging.

VOTE: NON OBJECTION: UNANIMOUS CONSENT

Motion carried.

b. Resolution 21-066, A Resolution of the City Council of Homer, Alaska Adopting the Water and Sewer Utility Financial Plan and Rate Setting Policies and Utility Financial Plan, Version 2021-01.

Memorandum 21-170 from Public Works Director as backup

LORD/ADERHOLD MOVED TO ADOPT RESOLUTION 21-066 BY READING OF TITLE ONLY.

Mayor Castner expressed his concern of setting precedent in that this projects a lot of money way out into the future and this Council can't bind future Councils by their actions. His

experience has been that once a Council starts moving in a direction it's almost impossible to stop them.

Councilmember Lord expressed her support for this and adopting financial policy around our utility system. We're best served by transparent, written financial policies that provide a framework in which we operate. In a large part they reflect our practices and providing further clarification in terms of what we do and how we want to operate our utility system from a financial perspective. She hopes this and future Councils will make decisions with best guess estimates of the future because that helps us figure out what it is we need. She recognizes this isn't an allocation of funds but enunciated policies. She asked for input from Public Works Director Keiser.

Public Works Director Keiser reviewed that in adopting this policy Council is not approving or establishing future rates, capital improvement projects, or expenses or revenues, those are done through other processes. What they are doing is establishing policies, many that are already being followed, that are articulated so that future Councils and the public can understand how the decisions are made. It's also adopting a model for how to keep track of expenses and revenues for the utility over time.

Councilmember Aderhold shared her support for the resolution and policy. This was a lot of work over the past year and she appreciates the final result. There are several plans in the city that are used to prioritize and determine how move forward on things, and that's what this document does for the water and sewer department. She loves the model because it lays everything out, it's very transparent, and an improvement to how they've looked at rate setting in the past.

Councilmember Smith supports structure and policy in place for making better decisions. It's hard to ignore some of the projections in those numbers and one of the thorns is the administrative fee that's been charged and we've talked a lot about. He thinks the escalators in the model are unreasonable and need to be addressed over time. It costs money to run the utility and he thinks there's some balancing act that's going to have to be done at some point to understand the true effect of having all these in place and what it does to the rate.

Mayor Castner rebutted that these are percentages, not hard numbers, and they fluctuate significantly depending on what the income stream is. When charging 15% for CARMA and 15% for an administrative fee, he questions what good or service is being delivered for that 30% increase in the tariff, then it's taxed 7.85% so the concept of taxing taxes and surcharges is bothersome to him. He believes the cost of water and sewer is going to get very expensive wit this program.

Councilmember Lord noted if there's a way to not taxing utilities that would be a proactive policy if they're able to do it. It's a suggestion that could be brought to the table for

consideration. This policy is a tool to have that and other conversations about setting rates and what will happen over time.

Councilmember Davis also supports adoption of this financial plan because it gives structure and transparency to a lot of what we're already doing, and he likes the capital reserves it sets up. In their last discussion on thing that caught his ear was the idea of distributing excess revenues instead of working to spend them.

Mayor Castner clarified he thinks sales tax should be collected on the commodity but not the extra things.

VOTE: NON OBJECTION: UNANIMOUS CONSENT

She also announced openings on the Parks Art Recreation and Culture Advisory Commission, Economic Development Advisory Commission, and Library Advisory Board, and a Student Representative opening on the Economic Development Advisory Commission.

COMMENTS OF THE CITY MANAGER

City Manager Dumouchel announced job openings with the City and directed listeners to the City website for more information.

COMMENTS OF THE MAYOR

Mayor Castner commented he's going to work with the Clerk to organize the Student Representatives into a get together for an orientation on how to serve on a Commission. He thinks he could do better to help those who have stepped up to participate. He hopes we can find one more to serve on the Economic Development Advisory Commission, these sorts of things look great on a college resume.

COMMENTS OF THE CITY COUNCIL

Councilmember Lord encouraged folks to go vote. She said a lot of people have reached out to her about who's on their borough ballot and she recapped the races on the borough ballot for the city and for outside city limits. She encouraged getting vaccinated and thanked those working in healthcare a million times over.

Councilmember Hansen-Cavasos had no comments.

Councilmember Venuti commented regarding a class at the college by Ed Berg on global climate change that started tonight. The KBC Facebook page has a neat picture of Lee Post's marine skeletal articulation class excavating a beaked whale that's been cooking in a bone box. There are other exiting classes going on at our local college. She appreciates the PARCAC for their work on the Lend a Leash program, she think it sounds like a winner for pet owners and dogs so they're safe when they're around traffic or other people. Local medical staff is available to answer questions about the COVID vaccine, her fear is people think this won't happen to them, but it's very real. Our numbers are still too high to relax, she hopes people will take notice and get vaccinated. She encouraged everyone to get out and vote.

Councilmember Aderhold commented there was a lot going on around town September 17th, she went to see Brad Hughes' shop and the Loved and Lost Bench he's building in response to the disappearance of Duffy Murnane. It was a privilege to see the work and hear from Sara Berg about each person portrayed on the bench and what they mean to her. She also participated in a working group called the Alaska Municipal Climate Network that started almost 2 years ago as a members of a number of municipalities getting together and talking about how our small municipalities can respond to climate change. They'll be having a session at the upcoming Alaska Municipal League meeting and it will be great to bring the information to AML members and get more communities joining in with the informal group. She attended the Homer Draw Down celebration at the Pratt Museum and encouraged everyone to visit and see the art displays on peatlands. She also commented about the Central Kenai Peninsula League of Women Voters event to watch the documentary Reunited States and then a discussion with the director and author of the book Reunited States. She encouraged watching the film and checking out the discussion on the Central Kenai Peninsula League of Women Voters Facebook page, it's really about the power of listening and opening yourself to changing your own mind.

Councilmember Davis also encouraged getting out to vote. He shared that tonight is his last meeting as an appointed councilmember and he wanted to take the opportunity to thank Mayor Castner and all the Council members and staff for their patience, he's learned a lot and it's been exciting.

Councilmember Smith commented voting is part of our civic duty and national pride in understanding what a blessing it is to have a representative republic where we can cast our vote and elect our officials to represent us. He requested the City be more proactive in election signage. He expressed his condolences to the McBride's, their extended family, and friends for HOMER CITY COUNCIL SPECIAL MEETING SEPTEMBER 27, 2021

Paul's passing. He participated in the Central Kenai Peninsula League of Women Voters event through an invitation and he thought it was excellent. It reminded him of two films that impacted him when he was younger, first was Twelve Angry Men that talks about diversity of bringing people together and how one person can have a tremendous effect of bringing people to understanding and changing their views, and Awakenings in a sense that when we wake up to the state of who we are and what we take for granted, and truly appreciate what we have in our lives. He shared about his family members and their service which impacted in his willingness to serve.

The Alaska Municipal League (AML) Annual Local Government Conference is scheduled in Anchorage, Alaska, November 14-17, 2021, and Alaska Conference of Mayors is scheduled for November 18, 2021.

The AML is a voluntary, nonprofit, nonpartisan, statewide organization of 140 cities, boroughs, and unified municipalities, representing over 97 percent of Alaska's residents. Originally organized in 1950, the League of Alaska Cities became the Alaska Municipal League in 1962 when boroughs joined the League.

Meetings include Newly Elected Officials (NEO), Alaska Conference of Mayors, board committees and meeting with Legislators.

Cost estimates for travel include round trip airfare from Homer to Anchorage at \$250 to \$350 or mileage at \$0.53 per mile, and room rates at \$118 per night. Per diem is \$58 per day, for three meals. Conference registration for NEO only is virtual at no cost, Conference only is \$300, and Alaska Conference of Mayors is \$125.

For FY22 Council budgeted \$4,000 for transportation, \$3,500 for subsistence, and \$2,500 for training.

This year, the Homer Public Library upgraded to radio ID tags. The previously used magnetic sensitizer/desensitizer machines have been rendered obsolete for our operations. The anticipated resale value of the units is very low (<\$100), however, another library has an interest in our now surplus sensitizer/desensitizer machines as they would have a use for them.

Homer City Code (HCC) 18.30.010 allows the City Manager to sell or otherwise dispose of any surplus, obsolete, or unneeded equipment with a value of less than \$5,000. Additionally HCC 18.30.040 (b) allows the City Manager to donate property to another municipality when the City Council deems it advantageous to do so. I am recommending that the City Council endorse my donation of the library's surplus magnetic sensitizer/desensitizer machines to the City of Palmer.

SUBJ: Grant Acceptance / Sole Source Purchase Approval

We have received a grant from Homeland Security to fund the purchase of a bi-directional amplifier system for the Police Station and two microwave links. These items will make significant improvements to our public safety radio system. The grant provides full funding for these projects. I request we obtain council permission to accept these grants and approve a sole source purchase for the associated equipment items and the installation to ProComm Alaska.

After moving into our new police station we discovered our radio signal strength inside of the building to be very low. This results in officers inside of the building to not receive radio transmissions on their portable radios. An officer can be just about anywhere within the building and not receive a dispatch to a 911 call or hear another officers call for help. The most effective, safe and reliable way to address this situation is to install a bi-directional amplifier system within the building which will amplify the radio signal strength to ensure effective and complete two way radio communications regardless of the officers' location.

Our public safety radio system essentially consists of our dispatch center and two outlying repeater sites. One of the sites is on the Homer Spit and the other is on Skyline Drive. Both sites contain repeaters for the police department and the fire department. For optimum system performance, radio signals should go back and forth between dispatch and the repeaters via microwave links with enough bandwidth to handle radio control and full data, video and audio signal transmission. Currently, one of our microwave links is old and does not provide the bandwidth we need. We do not have a microwave link to the second site and are only able to link with it via direct radio transmissions thereby severely restricting the capabilities of the site. Installing new microwave links with IP radio gateways will provide us with full system capability through all of our repeaters.

We request to sole source these projects to ProComm Alaska. Our entire radio system is built with Motorola brand equipment. ProComm is the only Motorola dealer in the state with fully trained and certified technicians meeting FCC and APCO requirements. ProComm has furnished and installed all of our equipment and they do all of our annual preventative maintenance and tuning. ProComm is uniquely qualified to complete these two projects for us and is the only radio service provider in Alaska capable of doing so and successfully integrating the new equipment into our existing system.

SUBJECT: Phase II of Citywide Server Upgrades

The City Council previously adopted Ordinance 21-19, allocating a total of \$75,000 for upgrading departmental servers across all of Homer. The work is necessary to ensure the City's network can continue to meet demand for security, data storage and records retention, and to avoid breakdowns in aging equipment.

Phase I of that project, which covers the servers at City Hall, has begun. Orders have been placed and the equipment should arrive in early 2022.

Phase II upgrades the servers in other departments, but due to rapidly changing prices in electronics markets, the original cost estimates are out of date. The good news is that we now have hard quotes for the cost of upgrading, and prices can be locked in if funding is allocated before the end of November. If funding is approved, equipment would arrive at virtually the same time.

RECOMMENDATION

Allocate an additional \$45,000 to complete the entire server upgrade project.

Ordinance 18-44(A) appropriated \$130,000 for upgrading the City's Microwave Wide-Area Network (WAN), which carries official data traffic between City buildings. The project was put on hold pending the completion of the new police station, then put on hold again by Resolution 20-050, and delayed further by the exigencies of COVID-19.

Preliminary work has begun, including mapping existing and potential infrastructure sites and modelling path loss (that is, the predicting the signal strength over distance). All regulatory requirements have been identified. Going forward, the IT division anticipates soliciting bids during the winter of 2021-22 and hopefully beginning construction in summer 2022.

THANK-YOU CARDS

- Description: A card mailed to donors.
- Scope: Recognizes all financial donations to the Library Endowment Fund and the Friends of the Homer Public Library Endowment Fund during the preceding year. Donations are recognized regardless of their size.
- Responsibility: LAB members write thank-you cards for donations to the Library Endowment Fund. FHL Board members write thank-you cards for donations to the FHL Endowment Fund and directly to FHL. The Library Director writes thank-you cards for donations made directly to the library.
- Recordkeeping: Donors are tracked by the Homer Foundation, which provides names to both the LAB and FHL. Donations made directly to FHL will be tracked by the FHL Coordinator. Donations made directly to the library will be tracked by the Library Director or a designated staff member.

HOMER PUBLIC LIBRARY ANNUAL REPORT

- Description: An annual library report will be issued every January, including a list of donors during the preceding January-December.
- Scope: Recognizes all financial donations to the Library Endowment Fund and the Friends of the Homer Public Library Endowment Fund during the preceding year. Donations are recognized regardless of their size. Donors are listed alphabetically by last name in the report.
- Responsibility: The Library Director writes the Annual Report.

FISH PLAQUE

- Description: A metal fish bearing the donor's name will be attached to the wall outside the front door of the library.

- Responsibility: The LAB will manage producing the fish, in collaboration with the metalsmiths.

- Recordkeeping: The Homer Foundation issues an annual list of donors to its partners. Donations made directly to FHL will be tracked by the FHL Coordinator. Donations made directly to the library will be tracked by the Library Director or a designated staff member.
- Notes: Installation occurs once a year, in late spring or early summer. The recognition is for gifts made during the previous January to December, and is not carried over from year to year. Further, the recognition is for a donation made as a single lump sum; not accumulated over multiple payments in a 12-month period. A donor can have multiple fish on the wall, if they have donated over multiple years.

JOINT LETTER OF APPRECIATION

- Description: The LAB and FHL will issue a joint letter of appreciation to the donor, with the understanding that the donor may use the letter for advertising purposes.
- Scope: Recognizes substantial or unique gifts that provide great value to the library.
- Responsibility: Based off a common template, the letter is drafted and personalized by the LAB and the FHL Board.
- Recordkeeping: The recognition is for extraordinary (and generally rare) gifts, and must be discussed jointly by the FHL board and the LAB.

EXCEPTIONS

Exceptions or waivers to the provisions of this policy will be considered in exceptional circumstances only, and will be subject to approval by the Homer City Council. The City reserves the right to terminate or alter arrangements for recognition under unusual or extraordinary circumstances.

There needs to be a correction to the assessment roll:

The City Lot 44, also designated as Lot I, on the corner of Lake Street and Ocean Drive Loop, is indicated to be 100' wide. If you look at any map of the area, it is clearly wider than the 7 - 100' lots to its west. The Borough's GRM Recording Number HM0003415 map shows it to be 128.63 feet. This would seem to indicate that the City owns 28.63 feet more of the wall than the roll indicates.

Given a finite length of the wall, the roll indicates 1735 feet, and a finite cost, the roll indicates \$ 780,118.57, a per foot of wall cost would be \$ 449.64 per foot.

If the wall is in fact another 28.63 feet longer, as the plat indicates for at least Lot 44, that would be a total wall length of 1763.63 feet. Dividing that length into the total cost, you get \$ 442.34 per foot.

That is a net difference of \$ 7.30 per foot. On a 100 foot section of the wall that amounts to a \$ 730. reduction in that share of the total assessment.

On City Lot 44, that would be a total assessment of \$ 56,898.19, not \$ 44,963.61, as the roll indicates.

Issue: The purpose of this memorandum is to seek an additional appropriation for the betterments to the City's water and sewer utilities that will be part of the AK DOT's East Hill Road Repaving Project.

Background: On April, 12, 2021, the City Council adopted Ordinance 21-15 appropriating \$98,000 to fund the "betterments" to the City's water/sewer utilities that will be impacted by the AK DOT's East Hill Road Repaving Project. This was the AK DOT's estimated cost of the work, which included making various adjustments to manholes, water valves, etc.

The AK DOT advertised public Invitations to Bid, opened the bids and calculated that the actual cost of the work, as bid, would be \$128,953, \$30,953 over the original estimate. The purpose of the proposed ordinance is to seek an additional appropriation to cover this cost increase.

The Water CARMA account has an available balance of approximately \$1,264,021.

Recommendations:

The City Council increase the appropriation for this project by \$30,953, to a total of \$128,953.





The AK DOT/PF will be repaying East Hill Road, possibly this summer. They will be adjusting Cityowned manholes and water valves and paying for this work as part of their construction. A number of these utility appurtenances need more serious repair. The purpose of this memo is to request an appropriation to pay for what would be "betterments" to the State's East Hill Road Project.

Background:


East Hill Road contains City-owned water and sewer lines, which will be impacted by the State's East Hill Road repaying project. Some of the impacts will be paid for by the State, such as adjusting the elevation of existing sewer manholes and water valves. Anything beyond this simple adjustment would be considered a "betterment" to the project and would be the City's responsibility to pay for.


A number of the sewer manholes and water valves need more serious repair. The attached illustration demonstrates representative work. For example, the drawing entitled the "Manhole Cone Adjustment" shows the cross-section of a typical concrete manhole. Sometimes the concrete "cone sections" or "grade rings" become broken over time/traffic and need to be replaced. Adjusting existing grade rings to the new road elevation is part of the road project and the State will pay for this. Replacing broken grade rings or broken cone sections is a betterment, which the City is responsible for. Likewise, sometimes the "valve boxes" break or lean or the water "valve stem" breaks. Simple adjustment of the valve box is part of the road project. Replacing broken valve stems is a betterment, which the City is responsible for.

It is in the City's best interests to repair these units, while the East Hill Road Project is under construction. The approximate cost of the "betterments" is \$98,000.

Funding is available:

The Pie Charts demonstrate that there is available funding in the Water and Sewer CARMA Funds.





Recommendation:

That the City Council appropriate \$98,000, to be split equally between the Water CARMA Fund and the Sewer CARMA Fund.



The purpose of this memo is to provide Council with additional information related to the Natural Gas Fund.

Background:

On March 8, 2021, Homer City Council adopted Ordinance 21-13, which directed the Finance Department to retire the debt obligation with the Kenai Peninsula Borough regarding the Natural Gas Line. Ordinance 21-13 also directed the Finance Department to provide Council with a fund financial summary.

On September 20, 2021, the Finance Department met with Mayor Castner and City Manager Dumouchel to discuss the fund financial summary reporting to Council. The main focus of the meeting was to determine the necessary future appropriations and to develop a future plan for the fund. Ordinance 21-63 is the resulting product from this discussion.

Fund Overview Questions:

Question 1: What financial activity takes place in the Natural Gas Fund (Fund 175)?

Answer: The Natural Gas Fund was setup to record capital project costs, debt obligation costs, Free Main Allowance deposits, and Special Assessment District revenues.

Question 2: What is the financial position of the Natural Gas Fund? When will the fund balance turn positive?

Answer: As of 12/31/20, the Gas fund had a negative fund balance of \$369,213. We anticipate at least one more calendar year (2 more audits) with a negative fund balance due to the prepayment of debt. Finance recommends not appropriating any transfers from this fund until there is sufficient fund balance.

Question 3: What funding sources did the City utilize to retire the debt obligation with the Kenai Peninsula Borough?

Answer: The primary funding source utilized for the debt retirement was the Free Main Allowance (balance as of January 2021 distribution was \$1,972,000). The full payoff amount was \$2,511,190.83. A funding gap of \$539,190.83 was created in this transaction. This gap was essentially advanced by the City. This gap and FY 2021 activity has decreased the fund balance to a negative \$336,056 (unaudited). Assessment revenue will continue to come in to cover this payment advance.

Question 4: What are the demographics for the Special Assessment District (SAD)?

Answer: There were a total of 3,788 parcels originally assessed in the SAD and currently there are 1,043 parcels still owing money. Of these parcels: 993 are current on a payment plan, 50 have never paid, and 137 parcels are in late status. There are 2,745 parcels that are paid in full.


Question 5: How was the doubtful amount derived?

Answer: The doubtful amount (\$161,188) stated in Ordinance 21-63 was approximated by multiplying the 50 parcels that have never paid by the original assessment amount. This value will not be seen in the financial statements, as it is not accounting standards to generate an allowance for doubtful accounts for special assessment districts. We are optimistic that this amount won't be as significant due to our ability to collect on assessments when properties are sold.

Question 6: What does proposed Ordinance 21-63 do?

Answer: As written, Ordinance 21-63 directs the Finance Department to wait until the fund balance for the Natural Gas Line fund turns positive (paying off all obligations to the City). At this point, the Finance Department is to annually transfer excess funds (those above \$0) to the General Fund Fund Balance.

Winter Camping and Restrooms



This leaves us unable to support camping and provide what I consider an acceptable level of service to our very large collection of restrooms. See the attached memo for more information regarding the closure of the Fishing Hole Campground. I am working with the Public Works Director on some options, which will allow us to better serve these resources in the future.

Finance Stakeholder Group Kickoff

In my August 23rd report to Council, I mentioned that I would be creating an internal stakeholder group which would include representatives from all departments and focus on Finance-related issues. The purposes of the group include: creating a friendly group setting for interdepartmental discussions about Finance processes, policies, procedures, etc.; allowing staff to share ideas and best practices for handling finance-related tasks; identifying issues with existing Finance processes (with the intent of improving them); strengthening connections between those who interact the most with the Finance Department; serving as an important contributor to some upcoming projects (i.e., procurement policy overhaul, etc.); and providing feedback to City Manager and Finance Director on finance-related topics. This group recently held its first meeting on October 14th. I helped kick off the first meeting, but moving forward I have asked Port Administration Supervisor Amy Woodruff to be the group leader.

Skate Park Update

On October 19th, Public Works began work on the assembly of the skate park half-pipes purchased by the Friends of the Homer Skate Park for use at the skate park on the HERC campus. Staff from the Road Crew and Parks are working together on this project before the snow starts to fall.



All-Purpose Vehicles

It was recently announced by the State of Alaska's Department of Public Safety that beginning January 1, 2022, all-purpose vehicles will be allowed on roads with speed limits of 45 miles per hour or less – unless a local government has restricted usage within their rs. In June of this year, the City Council proactively


passed Ordinance 21-33 which expanded Homer City Code Chapter 7.20 Snowmachines to also cover allpurpose vehicles. All-purpose vehicles are, and will remain, expressly excluded from use on sidewalks, alleys, streets, and highways within the City of Homer.

AKDOT&PF Response to Resolution 21-065

City Council recently adopted Resolution 21-065 which requested that the Alaska Department of Transportation and Public Facilities (AKDOT&PF) include accommodations for non-motorized users and evaluate a future project to create safe and sustainable pedestrian facilities among Kachemak Drive as part of the upcoming Kachemak Drive Pavement Preservation Project. The resolution was sent to AKDOT&PF and a response from Planning Chief Todd Vanhove is attached to this report.

Radio Upgrade

We recently completed the Port and Harbor radio upgrade project. The two radio propagation charts below show the range we were capable of reaching with our old system, and the expanded range now that we have moved our base station to the Skyline tower. The different color bands correspond to the approximate size of a receiving vessel. The larger the vessel, the higher the antenna is off the water and therefore the longer the range for our communications. We are still learning the system operationally but now that we have everything in place and tuned to optimal levels we are enjoying the expanded range and clarity of communications especially on our port operations channel.

SUBJECT:	Winter Closure of Fishing Hole Campground

In 2016, Council approved ordinance 16-08 which amended Homer City Code (HCC) 19.08.030. It allowed the City Manager discretion to allow winter camping within campgrounds on the Homer Spit.

In recent years, the Fishing Hole Campground area has remained open in the off-season (camping season is defined as April 1st through October 31st in HCC 19.08.020) and hosted a small number of campers. At this time, the Fishing Hole Campground is experiencing a high level of inappropriate use and is creating significant work for the Parks Division and the Police Department, both of which are currently understaffed for normal operations.

For the 2021/2022 camping off-season, I will be closing Fishing Hole Campground to campers. The camp host will remain on site as a caretaker and no others will be allowed to camp in this location. The Parks Division will post signage on site, erect appropriate barriers, and update camping information on the City's website. While camping will be prohibited, the park will remain available for day-use in the off-season.

At this time, there are other private options for visitors that wish to camp within the City over the winter.

Dear Mr. Dumouchel,

The department received the City of Homer's RESOLUTION 21-065 requesting the addition of non-motorized accommodations be added to the pavement preservation project on Kachemak Bay Drive. We agree a pathway is a desired amenity and would do much in service of the community at large.

The current project in design has very specific funding limitations in terms of scope. Funding can only be used for resurfacing the pavement. Given the preventative maintenance purpose and need of this project, and the lack of available funding to address pathway-associated safety and engineering concerns, we regret we will not be able to include the addition of a bike lane on the Kachemak Bay Drive within the current project.

Because of the urgent need to resurface Kachemak Bay Drive as soon as possible, the paving project must go forward even without the pathway. The department suggests the critical path to building non-motorized amenities is to initiate an entirely new and separate project just for the pathway. This new project will require ROW acquisition, a safety analysis, geotechnical, and environmental work, as it will extend beyond the existing right of way.

As Kachemak Bay Drive is currently a DOT owned and operated facility, this new project will be subject to competing for federal funds for non-motorized improvements with every other Alaskan road in the same functional class. There will be opportunities in 2023 to compete for funds for projects that build these types of amenities. This can be an extended process and not produce the desired results for several years. However, if the city wants to pursue federal funds for this new project, we will be happy to assist you.

Another approach is to fast track the project by the city of Homer taking over ownership and maintenance of this route. With local funds, federal processes are not required, so a much expedited timeline can be achieved. The Department urges you to ponder this option and see if the city agrees it is the best route moving forward to provide this amenity as quickly as the

Issue: The purpose of this Memorandum is to update the Council on the progress of the proposed Bunnell Avenue/Charles Way Water & Sewer Special Assessment Districts.

Background:

On May 10, 2021, the City Council adopted Resolution 21-030 initiating the process for creating special assessment districts (SAD) to bring City water and sewer to the Bunnell Avenue/Charles Way neighborhood.

A packet of information, containing proposed alignments for the water/sewer main extensions and a preliminary assessment roll were sent to property owners in the neighborhood. On May 27, 2021, a Neighborhood Meeting was held. Subsequently the time for filing objections passed. Enough people approved of the project to move it to the next step in the SAD process, which was to hold a public hearing. At the public hearing, people made the following comments:

- The project should be designed/constructed to avoid disruption to the wetlands as much as possible.
- The project should be designed/constructed to minimize the costs as much as possible.

We decided to take a second look at the strategy for serving the area with water/sewer with the goals of (a) minimizing wetland disruption and (b) getting a more reliable cost estimate. In order to achieve these goals, we took the liberty of making a modest investment to produce a design survey to more accurately determine how gravity would flow in the neighborhood as well as a more precise conceptual design. If the SAD process goes forward, these costs will be absorbed into the costs of the SAD. If the SAD process does not go forward, these costs will be absorbed into the existing Public Works Operating Budget.

This work is not yet finished. I request that further action on the proposed Special Assessment Districts be postponed until I have more information to report.

In response to the public comments we received about the proposed special assessment district, we recommend that the Benefitted Area method of assessment be used.

Per the HCC, there are three possible methods of computing assessment: Equal Share, Frontage Foot and Benefitted Area. Usually, the Equal Share method is used, unless there is a compelling reason for a different method. For example, one of the properties in the Alder Lane Water Assessment District was three-four times larger than the other lots. With the Equal Share method that property would have been assessed the same as the smaller lots, which wasn't equitable. So, we recommended, and the City Council adopted, the Benefitted Area method. With the Ocean Drive Seawall Special Assessment District, the benefit to each property was directly proportional to the length along the Seawall, so the Frontage Foot method was used. With the districts (water & sewer) proposed for the Bunnell Avenue/Charles Way neighborhood, the Benefitted Area method would be most equitable because it would account for the benefit to Bishop's Beach, one of the City's most popular parks as well as several other larger properties.

The attached spreadsheets show the effect this method will have on the proposed assessments. The computations for the larger lots only includes the first 200 feet of the lot, as allowed in HCC 17.01.010, so long as this approach is approved by Council.

Recommendations:

- 1. That the City Council adopt the Benefitted Area Method as the method of assessment for the Bunnell Avenue/Charles Way Special Assessment District.
- 2. That the City Council approved the approach of only including the first 200 feet of the lots that are at least 50 percent larger than the average lot in the proposed district.

Per Homer City Code 2.08.080, Mayor's absence: At the first meeting of the Council following certification of the municipal election each year, there shall be appointed a Mayor Pro Tempore, by majority vote of the Council, to act as Mayor during the Mayor's temporary absence or disability.

Pursuant to Council's Operating Manual: A Mayor Pro Tem shall be elected by the majority of the Homer City Council. The term of the Mayor Pro Tem shall be until the call for election by the Homer City Council of a New Mayor Pro Tem. The Mayor Pro Tem shall, in the absence of the Mayor, act as Mayor of the City of Homer as though they themselves had taken the Oath of Office of Mayor with all duties, responsibilities and powers of the office of the Mayor of the City of Homer. The Mayor Pro Tem, when acting in that capacity, does not lose the privilege or duty to vote as a Councilmember.

Pursuant to Council's Operating Manual: Council Seat- Customarily the selection is by seniority. Senior members may choose a different seat prior to the junior members being seated. The Mayor Pro Tempore shall have first seating choice and then the Senior Councilmembers and so on and so forth. (Resolution 04-89)

RECOMMENDATION: Councilmember ______is selected/appointed as Mayor Pro Tempore for the City of Homer for 2021/2022.

After Council selects the Mayor Pro Tempore they may have first seat choice, including remaining where they are currently seated.

The City issued a Request for Qualifications on September 27th. Although several firms were on the plan holders list, only Stantec submitted a response.

Staff met on Thursday the 21st to review the submittal and discuss next steps. Stantec was the consulting firm for the Public Safety Review Committee in 2014, which spent a lot of time looking at the HERC site for a joint Police and Fire station, and then ultimately for the Fire Station remodel and construction of the new Police Station. They know the HERC site and our community well! Stantec's proposed project team in their submittal and their extensive knowledge of the site lead are very strong. Their strengths are an asset as we move forward with the redevelopment of this site.

Its unlikely staff will have a final agreed upon scope of work and contract ready to sign by Monday's Council meeting. Council does not meet again until November 22nd. Staff recommends Council award the contract to Stantec, with a "not to exceed agreement." That will allow staff time to hammer out a final schedule, contract and start the project!
