FY26/27 Budget Priorities

This is our first session in planning for the FY26/27 budget and I'd like to share some of the things I am thinking of in preparing for the draft FY26/27 budget.

Tax Revenue

In 2020 we saw a large increase in sales tax as COVID shut down travel and Alaskans stayed "home" for vacations and moving around in state during the summer. Unfortunately, those trends are changing and sales tax revenue to the City has been on the decline. Property taxes have been up with the new development that's been going on and that has helped to offset the loss of sales tax, but overall there is still a decline in tax revenue overall. For FY26/27 we'll have to sharpen our pencils to come up with a realistic revenue projection to build our budget on.

Deferred Maintenance

From rolling stock to aging infrastructure, things are breaking down and some departments are running out of space as we grow. We've seen several instances of unbudgeted expenditures due to necessary repairs and maintenance. The City Manager's office has sent deferred maintenance worksheets out to departments, and Public Works is developing a fleet replacement schedule. We will bring this information to Council and schedule budget priority work sessions with departments and divisions as we work through the budgeting process.

Restricted Fund Balance for Emergency Use

Ordinance 19-35(S)(A) adopted several code amendments in Title 3, Budget, including HCC 3.05.049(b) establishing within the fund balance an amount equal to four months of revenue for the current fiscal year that is restricted to emergency use only. The current restricted balance for emergency use for FY25 is approximately \$5.5 million.
