**Topic:** Zoning Ordinance Update Workshop - CONTINUED

#### **OVERVIEW**

The update of the Homewood Zoning Ordinance has been underway since November 2021 with the consulting firm Houseal Lavigne Associates. Documentation of the complete process can be found on the Village's website:

This meeting will be led by Staff based on the draft articles provided by Houseal Lavigne in January (articles 1-5) and June (articles 6-8). The purpose of this meeting is to conduct a workshop involving Staff, Commission members, and members of the public to revisit items previously tabled for further research, discuss further revisions raised by any attendees, and run scenarios using real properties in the Village to visualize potential outcomes of the proposed ordinance.

All attendees will be invited to participate fully as Staff leads a discussion around the following topics:

1. <u>Temperature Check: Review the objectives.</u>

15 minutes

Discussion: Are we achieving what we set out to? Are we missing anything?

2. Independent Study: New Materials

5 minutes

These will be made available online for self-guided review and will be referenced to augment discussion in this workshop.

3. <u>Deep Dive: Revisiting Topics of Further Review</u>
