a. <u>Motion – Approval of Commercial Business License Application for Trease</u> <u>Storage LLC located approximately at 5500 S 5700 W</u>

Tyson Trease located at 5630 W 5300 S described that the lot would have 50 available spots. He is wanting to put up a chain link fence around the property and add gates for access to the storage.

Council Member Northrop asked if there would be open access to the storage or if it will be set to business hours. Tyson explained that it will be set to be business hours for the security of it and respect the neighbors around.
