- a. Conditional Use Permit Request for Brian Hotchkiss for an oversized structure totaling 6144 sq ft with a height of 33 ft 3 ½ in located at 6328 W 4800 S
 - i. Applicant and/or Staff presentation(s)

Brian Hotchkiss located at 6328 W 4800 S explained what he will be doing with his structure. Brian also explained that they are adjusting the height on the left side of the building. Explained that he had spoken with bordering neighbors, they will support his structure. Commissioner Prince asked if anyone will be living inside of the oversized structure, Brian confirmed no. Brian also states that there will be a bathroom inside of the building.
