

# **Business License Advisory Ad-Hoc Committee**

Meeting Minutes of June 10, 2024

Present were member representatives from the City Council to include: Mayor Dave Drotzmann and Councilor David McCarthy; representatives from the Hermiston Chamber of Commerce to include: Executive Director Val Hoxie, Tami Sinor, and Kris Bennett; and representatives from the Hermiston Downtown District to include: Judy Currin-Pederson (arrived at 5:50pm) and Kristi Kopacz. Also present was city staff to include: City Manager Byron Smith, Assistant City Manager Mark Morgan, and City Recorder Lilly Alarcon-Strong. Councilor Jackie Myers was not present. The meeting was opened by Mayor Drotzmann at 5:30pm.

### **Review and Approve Meeting Minutes**

Tami moved and David seconded to approve the meeting minutes of the April 8<sup>th</sup> Meeting. Motion carried unanimously.

#### **Business License Fee Discussion**

Byron presented information (PowerPoint Presentation and handouts given attached) and the Committee reviewed information regarding:

- Reviewing the preliminary discussions to possibly implement a Business License and Fee process and approval by Ordinance to set fees by resolution approval
- Formation of Ad-Hoc business License Advisory Committee by the City Council
- Reviewed results from the Business License Fee Survey, led by the Chamber of Commerce and Downtown District
  - There was a discrepancy between the results shown on the Survey Results and the PowerPoint Presentation regarding Question 4 "Should any of the following be exempt from a business license?" Byron stated the error is in his PowerPoint presentation when he was imputing the numbers from the official survey results.

Val spoke regarding the many efforts the Chamber of Commerce made to push out the survey to businesses and the encouragement they put forth to have a large turnout. They were disappointed with so few participants; however, they did receive verbal comments from those who did not want to participate in the written survey who were ok with a business license fee in the amount of \$50.00 to \$100.00 annually, only three individuals representing their businesses were against a fee.

(Judy arrived at 5:50pm)

Kristi stated businesses already have three fees they must pay to the State when opening or operating a business and another business fee seems unfair, but if it must be paid, it should be a smaller amount.

Judy agreed, stating the fee should be smaller because they know it will increase over time.

Tami stated it is common to pay a business license fee and it's viewed as part of doing business and in her line of business, it is required before even being able to submit a bid for public or private work.

David stated the reality is that everywhere else has a business license fee and people are surprised when they come to Hermiston and there isn't one already established.

Dave stated residents strongly supported a business license fee and asked Val how they implemented their annual fee.

Val stated the fee was already established when she began her employment with the Chamber; fees are paid annual at the anniversary date the business signed up to be a Chamber Members, however this has proven cumbersome for the Chamber and would prefer the fee to be paid at the beginning of each year instead, and this is what she would recommend the City do.

Kris stated she would be more in support of a fee if she knew it was going directly to the Police or Fire Department which would be good, but not so much if the money is going to other departments of the City. Businesses would feel better about the fees if the City was transparent on where the fees are going and also made sure every business in the City is paying the fee.

Dave stated the City is already very transparent and many items can already be found on the City's website; and although no one wants to pay additional fees, this is what constitutes are asking for and this is why this committee was formed- to establish what the fee is going to be.

Kristi stated she feels like the fee should be within the \$50.00 to \$100.00 range but would prefer the lower end of this range.

#### **Public Comment**

None given.

Committee members discussed the proposed fees as recommended by staff as well as changing the fees to different amounts; David moved and Val seconded in favor of implementing the fees recommended by staff. David, Val, Tami, Dave, Judy, and Kris voted in favor; Kristi voted against. Motion carried 6-1.

### **Adjournment**

There was no other business, and Dave adjourned the meeting at 6:15pm.


