

## **Public Safety Committee Minutes**

October 28, 2024

Councilor Primmer called the meeting to order at 5:15pm. Councilor Hardin and Linton were excused. Staff in attendance included: City Manager Byron Smith, Chief Jason Edmiston, Court Administrator Jillian Viles, Captains Travis Eynon and Scott Clark, Communications Manager Amanda Hartsteen, Patrol Sergeant Chris Martin, Patrol Corporal Jarrod Flatau, Patrol Officer Kieron Carlson, HES General Manager Nate Rivera, and City Recorder Lilly Alarcon-Strong.

### Police Department

### Introductions & HPD Personnel Update

Hermiston's Police Department (HPD) Chief Jason Edmiston introduced members of HPD who were in the audience and gave personnel updates stating HPD is fully staffed with the exception of potential officers for the Good Shepherd Health Care Systems agreement and two staff members who have been off for several months due to illness or injury.

### • <u>3rd Quarter (2024) Activity Report</u>

Chief Edmiston reviewed the 3<sup>rd</sup> Quarter Activity Report (attached). Information was provided to include: 3 of the 4 violent or person crime categories are down from last year; though HPD is showing 2 homicides for the year, both were attempted murders with multiple arrests made, and one case was adjudicated after only 30-days with the aggressor being sentenced to roughly 10 years in prison; unfortunately aggravated assaults continue to trend upwards and show a 23% increase from last year and a 52% increase over the 10-year average- HPD is seeing more and more transients in the community that bring with them severe dependencies and often undiagnosed and untreated mental health issues; burglaries are down a staggering 70% from last year and down 75% from the 10-year average- HPD believes this is in part with advances in technology and citizens target hardening their properties; total crime is down 43% and violent crimes are flat from last year. With increased staffing, officer-initiated activity, traffic stops, total arrests, and citations issued are all up from last year.

Chief Edmiston stated HPD has hired incredible officers who want to make a positive impact on their community, as such, calls for service continue to trend up 3% from last year and remain at an all-time high for HPD, up 33% from what has been seen. As calls for service are tracked, so are those involving transients. This population, as previously mentioned, are often linked to substance abuse and mental health challenges and require time and energy from HPD to handle the 25% of calls that come from this group.

### <u>Umatilla County Deflection Program</u>

There was some discussion regarding Measure 110 and how the decriminalization of drugs has negatively impacted those struggling with addiction and communities as a whole. Captain Travis Eynon and Court Administrator Jillian Viles spoke regarding the Deflection Program which will see all drug and misdemeanor citations through the District Attorneys Office and spoke regarding the small amount of people who will be able to qualify for the program due to the disqualifiers set in place.

### • **Projects of the Horizon**

Chief Edmiston spoke regarding the possibility of using Artificial Intelligence (AI) as police departments throughout the country begin to do bata testing in these and other categories, including: Axon Draft One Report Writing, Axon Body Camera Translation Services, Citizen RIMS 2.0, Narc Ranger Unit, and others.

Councilor Primmer stated this would be a great use of technology to help HPD and the community.

### • <u>Past/Upcoming Events</u>

- Christmas Express
  - Chief Edmiston stated this program plans to serve an estimated 500 families this year and is expected to undergo changes next year. More information on expected changes will be disclosed at a future time.

#### Hermiston Municipal Court Updates

Court Administrator Jillian Viles reviewed the 3<sup>rd</sup> Quart Municipal Court Report to include: crimes and violations filed in the Municipal Court, the number of days these cases take to be adjudicated from when they are filed, the annual number of violations and criminal offenses filed currently and in previous years (attached) and technology and software updates that allow people to review their case and options online before coming to court.

#### Public Comment

Roy Barron asked if there were any federal grants for mental health programs that the Municipal Court could take advantage of.

Court Administrator Viles stated the Municipal Court has a partnership with Community Counseling Services who attend court each week to immediately set up appointments and help with people needing treatment.

Maria Duron stated through the community, she is hearing a lot of misinformation about Christmas Express and asked if there was communication that could be shared to dispel these rumors.

Chief Edmiston stated HPD is aware of the misinformation that Mrs. Duron is speaking of and Amanda Hartsteen and Tim Miears are working on this front. This is also one of the reasons in which HPD has decided to undergo changes in the program starting next year to help dispel misinformation and rumors.

Dave Drotzmann thanked the police and court departments for their efforts in great interventions programs to help people get out of their cycles of crime, recover, and become productive people in society, stating great leadership is at work applying for and receiving grants and doing the work to do

something different to help those who need something different in order to succeed, however there is still work to be done to help with the homelessness issues.

Maria Duron thanked the police and court departments for seeing people for who they are and giving people the opportunity to have a better life through the work they do and the partnerships they have created in the community.






