Present were James Lafolette, Dean Hackett, Terry Cummings (arrived at 4:03pm), and Chris Hankel. Member Kristi Atkins and Council representatives Rod Hardin and Maria Duron were excused. Also present was City Recorder Lilly Alarcon-Strong and Youth Advisory Member Katelyn Wadkins. Chris opened the meeting in prayer at 4:02pm.

Youth Advisor Introduction

Youth Advisory Member Katelyn Wadkins stated she is a high school senior and is involved in many sports and extra-curricular activities. She became involved with FBAC when replying to an email from Mr. Aaron Davis, a high school teacher, regarding students being interested in participating in City Committees. This new program is a way to open the door and encourage public participation and volunteerism as the youth will one day be leaders in this community. She stated she looked through the list and asked to be involved in FBAC as her first choice and is excited to be a part of the Committee.

School Adoption: Service Ideas

The Committee reviewed the school adoption list, made updates, and spoke regarding some of the efforts that have already been made, to include:

- Sunday night prayers around the school that includes picking up trash and reporting any vandalism or security issues
- Making security curtains for classroom doors
- Providing:
 - Daycare, translators, and snacks during conferences
 - Snacks for staff once per month
 - Coats and gloves for kids during winter
 - Specific items for families in need
 - Enough school supplies for 80-100 students each year, until the school started providing free supplies to all students
 - Readers/listeners to help children with in class reading

Lilly suggested churches consider providing a variety of shirts in different sizes and styles for students at the Junior High Schools and High School. This would allow students, who are dress-coded, to change into something that is not provided by the school as school provided clothing is specific and is an indicator to all that that person has been asked to change.

Dale Larson stated his school (Hermiston Christian) really needs contacts for snow removal services.

Chris stated he will give Dale contact information for snow removal and reach out to the Administrations at the Junior High and High School about needs in their schools and will let the Committee know what he finds out.

James stated he will email elementary schools and do the same.

National Faith & Blue Weekend Updates and Action Plan

Terry stated Chaplains met with staff members of the Parks and Recreation Department and had a great brainstorming meeting (meeting mins attached). Terry stated the event is being combined with Hermiston Fall Festival which is planned for the entire weekend. The Chaplains will be in charge of "the service" as the FBAC did not meet during the summer months. All area law enforcement has been invited to attend and participate in the service. Kid activities are being planned, to include: bounce houses, games, free pumpkin carving, patrol cars, having a K-9 Officer/dog present, and more.

Faith and Blue Service Ideas

The chaplains met on August 3, 202 and discussed multiple ideas on how to make this service as meaningful as possible. Below are ideas, suggestions and a proposed outline of the service. We will meet again to try and finalize details.

Our discussion resulted in our thoughts that the following four elements should be included in the service portion of this event: recognition, thank you, prayer and a call to action. Of course each of these resulted in many ideas but for now we ended with the following four parts to our 30 minute service (which will be honed and tweaked as we get closer to the event).

Suggested time: 12:30 p.m. (Is this the best time?).

Suggested length: 30 minutes

Suggested location: not determined at this time

Service Agenda: (four parts)

- 1. Chaplain Finn will begin with a welcome and introduction of all LE (blue) by agency. We may ask them to stand briefly (if we are inside and seated) to be recognized. This should take approximately 4 to 5 minutes.
- 2. Chaplain Ramirez will ask three pastors to join him for a time of prayer for LE. Each pastor will be asked to pray for a specific area/need and Hector will close the prayer time. This part will be approximately 8 minutes and will not exceed 10 minutes.
- 3. Chaplain Cummings will address our heartfelt appreciation and thanks to our officers for their dedicated service and for answering the call to serve, hopefully with thoughts to encourage the faith community. This will be approximately 4 to 5 minutes.
- 4. Chaplain Johnson will present a challenge to LE and the general public by giving his testimony through the police, military and finally chaplain segments of his life and end with a challenge to LE and a call to action to the faith community. Time not to exceed 10 minutes.

There are many more details to be worked out but this is our general goal at this time. A main question we have at this time is whether we will be inside or outside for this service.
