The request for bids are out on the project which includes constructing new taxi-lanes on both sides of the new hangar as well as construction of the new hangar. Bids for the paving portion are due on February 15, 2024 and bids on the hangar construction are due February 22, 2022. This construction is scheduled to be complete before the end of 2024.
- 3. Tracy May reported that discussion with the FAA over future land acquisition is expected to move forward during 2024 and 2025.
