Hispanic Advisory Committee Meeting Minutes March 17, 2026

Chair Jessica De La Cruz opened the Meeting at 6:01pm. Committee member Carolina Delgado, Jacobo Gutierrez and Jesse Road (arrived at 6:14pm) were present. Also present were Council representatives Maria Duron (arrived at 6:02pm) and Jeff Kelso, as well as staff representative City Recorder Lilly Alarcon-Strong. Youth Advisor Kari Bazan was also in attendance. The pledge of allegiance was given.

Introduction of Newest Member, Jacobo Gutierrez

Jacobo introduced himself stating he is working on his bachelor’s degree in business management and has a passion for outreaching and connecting with people, including content creation, video editing, and being a behind the screens kind of person and is happy to join the Committee.

Social Services Month Presentation from Good Shepherd Health Care System

Provided information (attached) regarding: The Connexions Program, Family Health and Fitness Day, and the many programs and partnerships they have to provide resources, advocate for patients, as well as help patients navigate their needs to include: Event outreach, home safety assessments, teaching community classes, health screens, birth and end of life Dulas, providing bike helmets, life jackets, and care seats, basic needs from housing to food. Most if not all of these items are free and individuals can sign up themselves or can be referred to. Most classes are offered at Good Shepherd or EOTEC but can be hosted at other facilities as long as they are large enough to accommodate all attendees. All these classes are free, there is a cost to CPR and First-Aid Classes. Some classes were held at the Harkenrider Senior Center but outgrew the facility, however, the Senior’s do have similar classes.

Blue Agave New Event Center Information

Manuel and Eva Arteaga presented information (attached) regarding the newest event center they built and are offering to the public to use; it is 10,000 sqft and can accommodate 540 people, has a kitchen, 50 tables, 540 chairs, stage, sound system, and wifi. 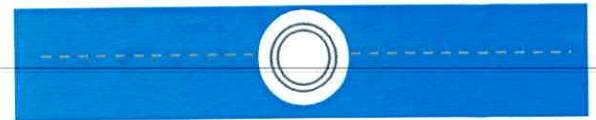

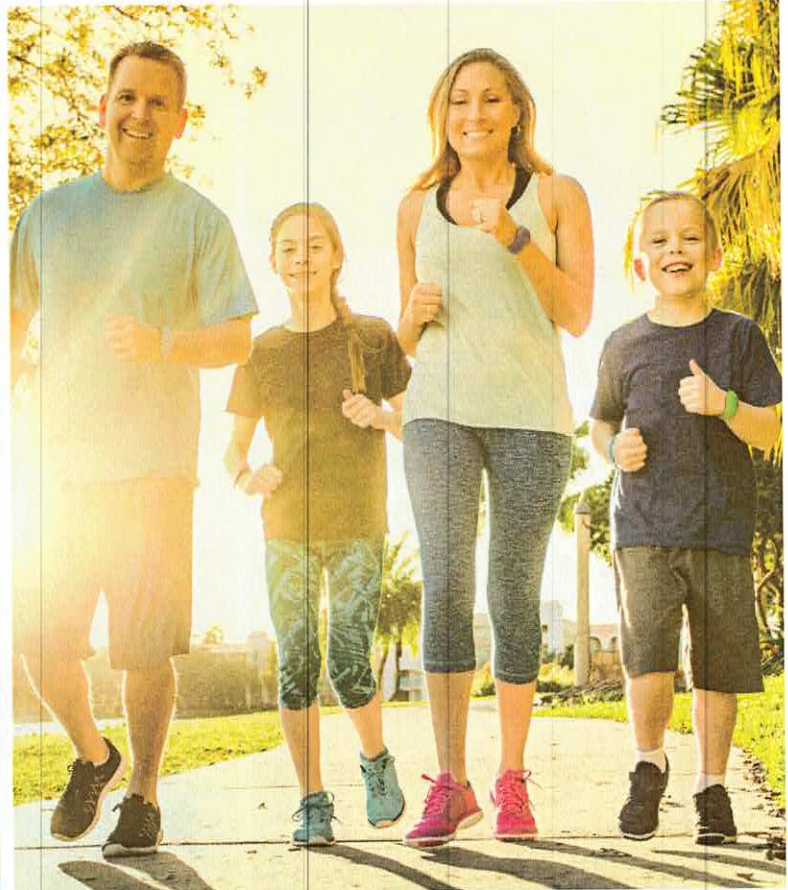

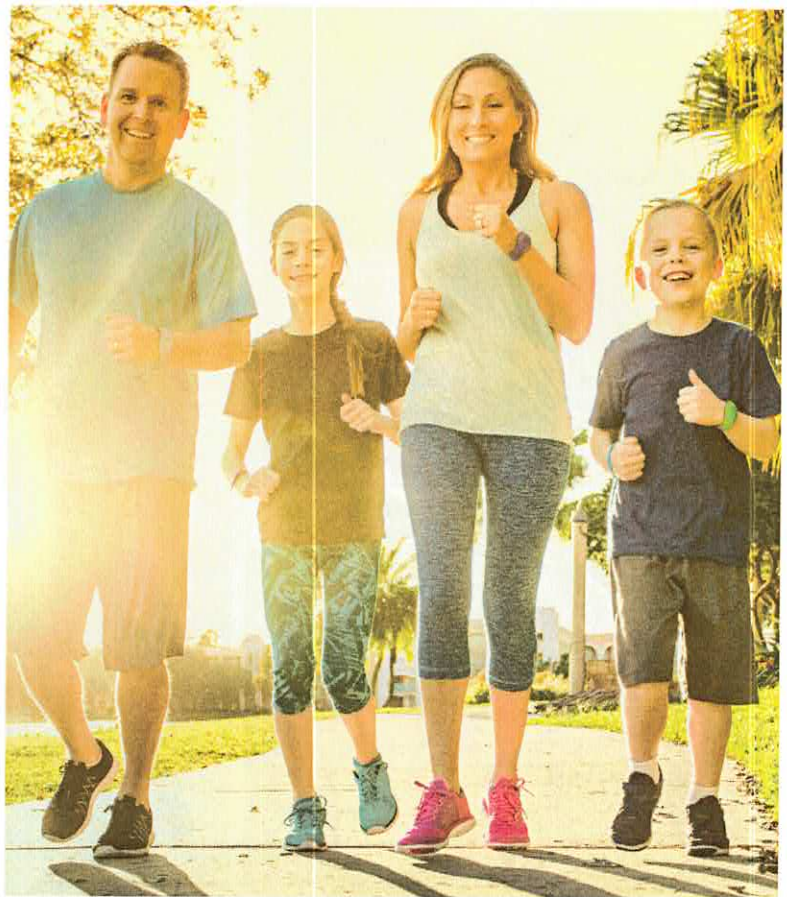
