Chair Jose Garcia called the meeting to order at 7:00pm. Present were Committee members Mark Gomolski and Abby Reyes-Munoz; Council Representatives Maria Duron (arrived at 7:08pm) and Roy Barron; City Recorder Lilly Alarcon-Strong, and Youth Advisor Heavenly Coleman. The pledge of allegiance was given.

Youth Advisor Introduction

Heavenly Coleman stated she is a High School Senior and ASB President, participates in National Honor Society, Generation College, and other groups. She's participating in City meetings as she wants to be more involved in the community.

The Committee welcomed and thanked Heavenly for her participation.

Minutes

Mark moved and Abby seconded to approve the minutes of the January meeting. Motion carried unanimously. There was no meeting in December.

Homeownership Programs Through Capeco

Ysenia Gomez, Capeco Homeownership Case Manager, gave information (attached) regarding the many services Capeco offers, to include: Financial Education and Counseling; Home Ownership Courses and all costs and responsibilities associated with homeownership; Helping clients understand what they can afford, foreclosure prevention, and creating a crisis budget; debt reduction, elimination and budgeting; and more. Classes are offered in English, Spanish and virtually. Point-in-Time Count regarding homeless individuals; UEC Mobile Home Replacement Program; financial assistance to help pay for utilities and replacement of windows and energy efficient appliances; and more.

DEQ Presentation

Laura Gleim, DEQ Public Affairs Specialist and Shannon Davis, DEQ Eastern Region Administrator, presented information regarding (attached) nitrates in drinking water, the importance of testing water from private wells, trying to encourage people to prioritize safe drinking water practices, health issues caused by consuming unsafe water, ways to better inform the public, and more to include:

- **Drinking water safety:**
 - **If your water is from a private well:** The Oregon Health Authority [recommends you test your water regularly for nitrate, bacteria and arsenic](#). These are common drinking water contaminants in Oregon. Water in private wells must be tested during real estate transactions, but otherwise private wells are not regulated in Oregon and water quality is the responsibility of the well user. Public Comment

Delores Veliz- Asked if there are other cities with these same struggles.

Zaira Sanchez- Stated she works for Oregon Rural Action and has specifically worked on nitrate water issues, information, and outreach. She stated because private wells are not regulated by the government, people need to do their own well water testing and this information isn't readily known so people aren't testing like they should.

Jesse Roa- Stated he has grown up in Umatilla and Morrow County all of his life and remembers seeing and hearing these water issues/information/resources for the last 30+ years; he believes people know about unsafe nitrate levels in drinking water but they just don't care anymore.

There was some discussion regarding other cities with similar issues, LUBGWMA Committee, the frustration with government inaction against groundwater polluters, and entities/organizations coming together to improve community outreach going forward.

- Thanked Commissioner Murdock for all the work he did in the community before retirement, including the Hispanic Cultural Center
- Thanked Mark Gomolski for all the help he is giving to Latino families in the area, but specifically to those staying in Martha's House, stating Mark brought in immigration attorneys to help Columbian families on their way to become citizens. This is a great help as many immigrants are taken advantage of when going through this process. These families are spreading word of the graciousness of Mark and Martha's House.
- Stated they are proud of the youth for their participation in the community through participating in City meetings

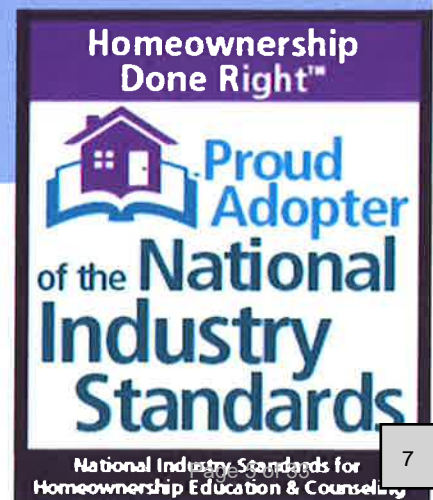

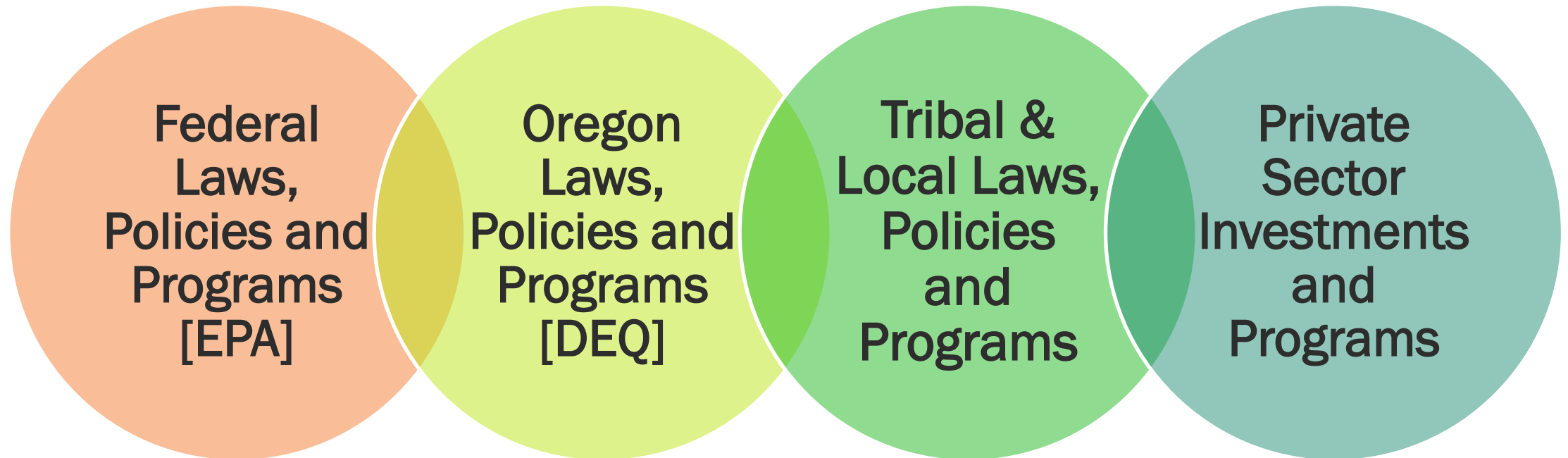

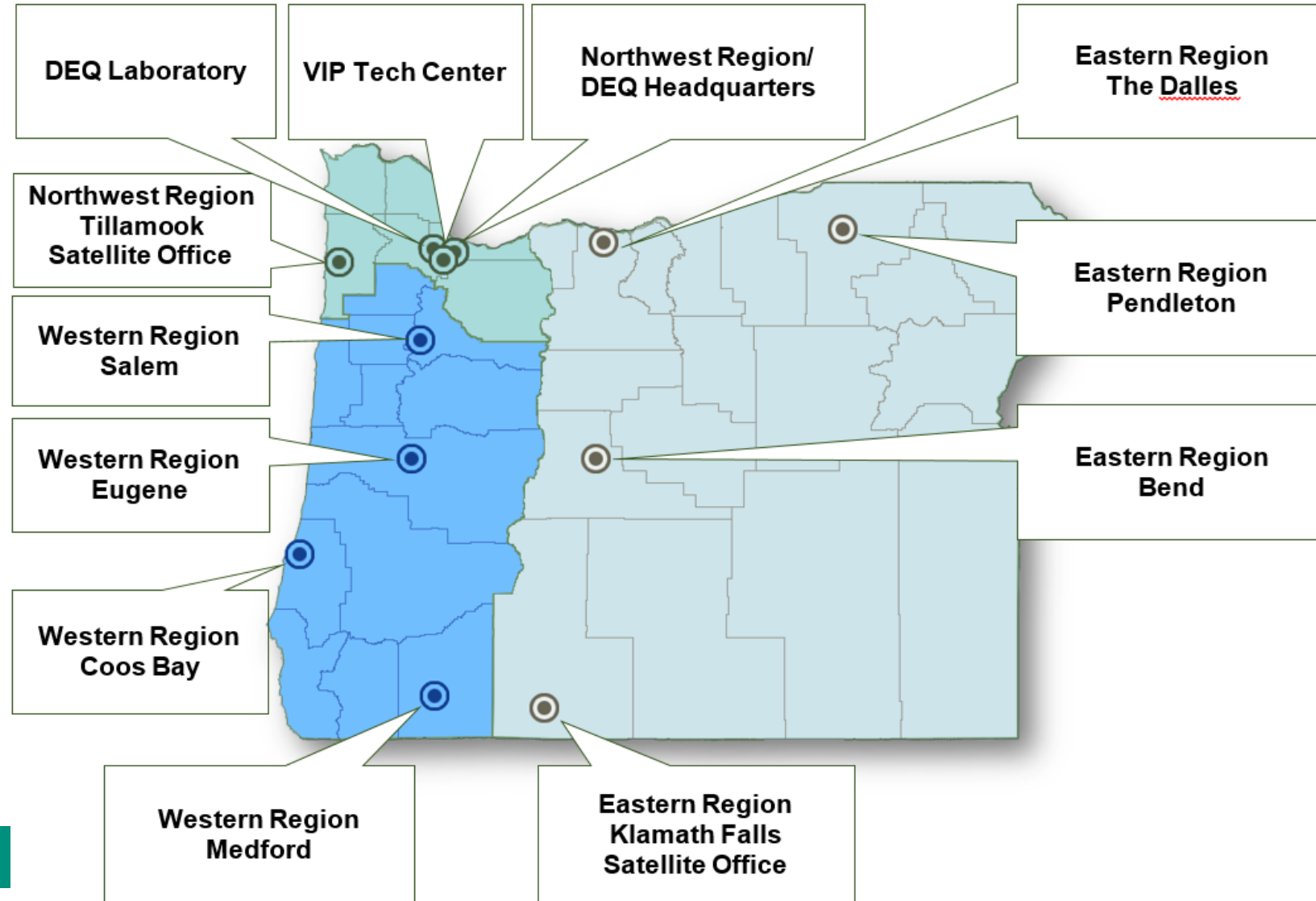

Air Quality Regulation

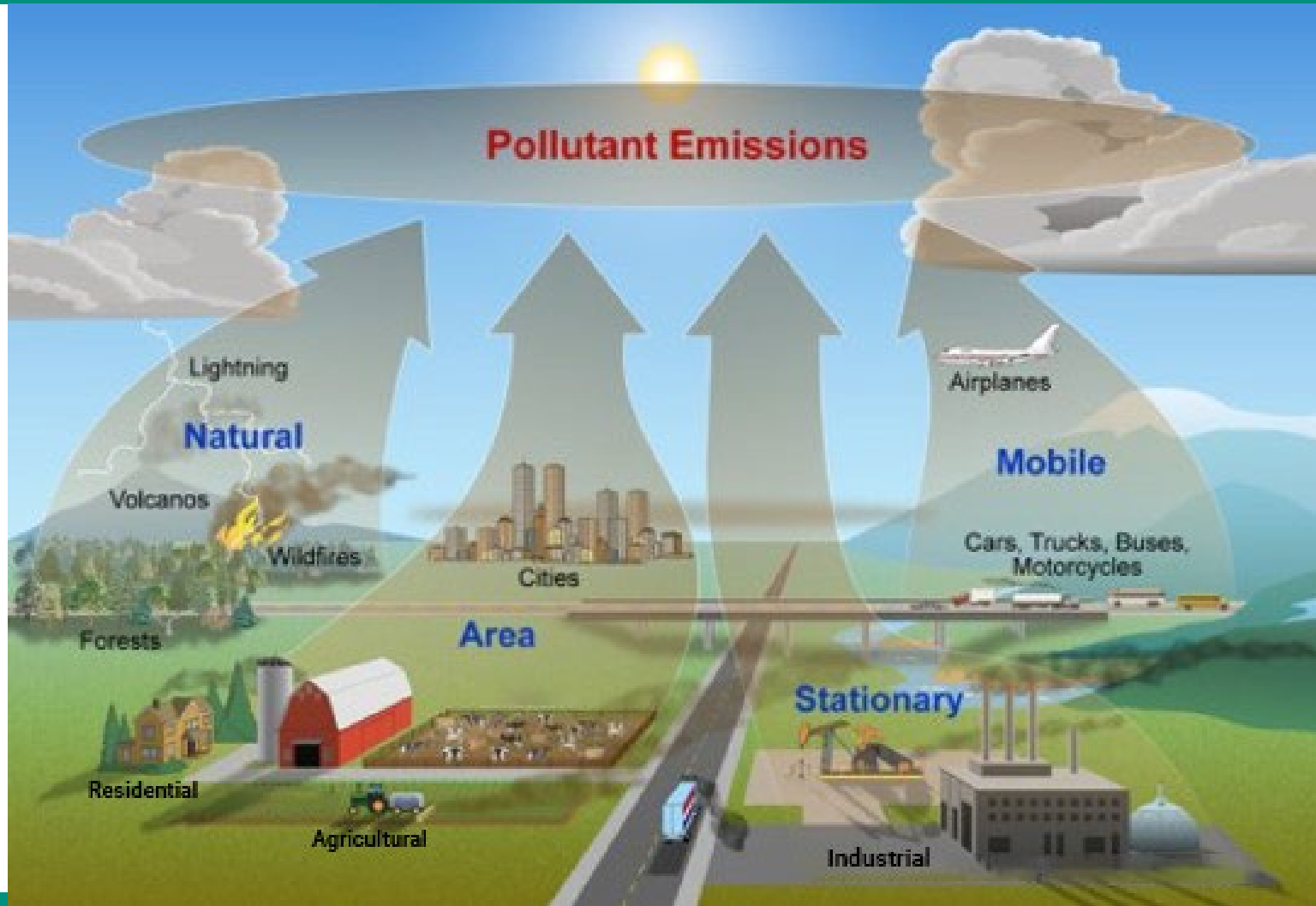

What is an Air Quality Permit?

- Limits pollution from industrial facilities so air quality remains within state and federal standards.
- Includes:
 - operating conditions
 - emission limits
 - monitoring and reporting

Air quality permit modification

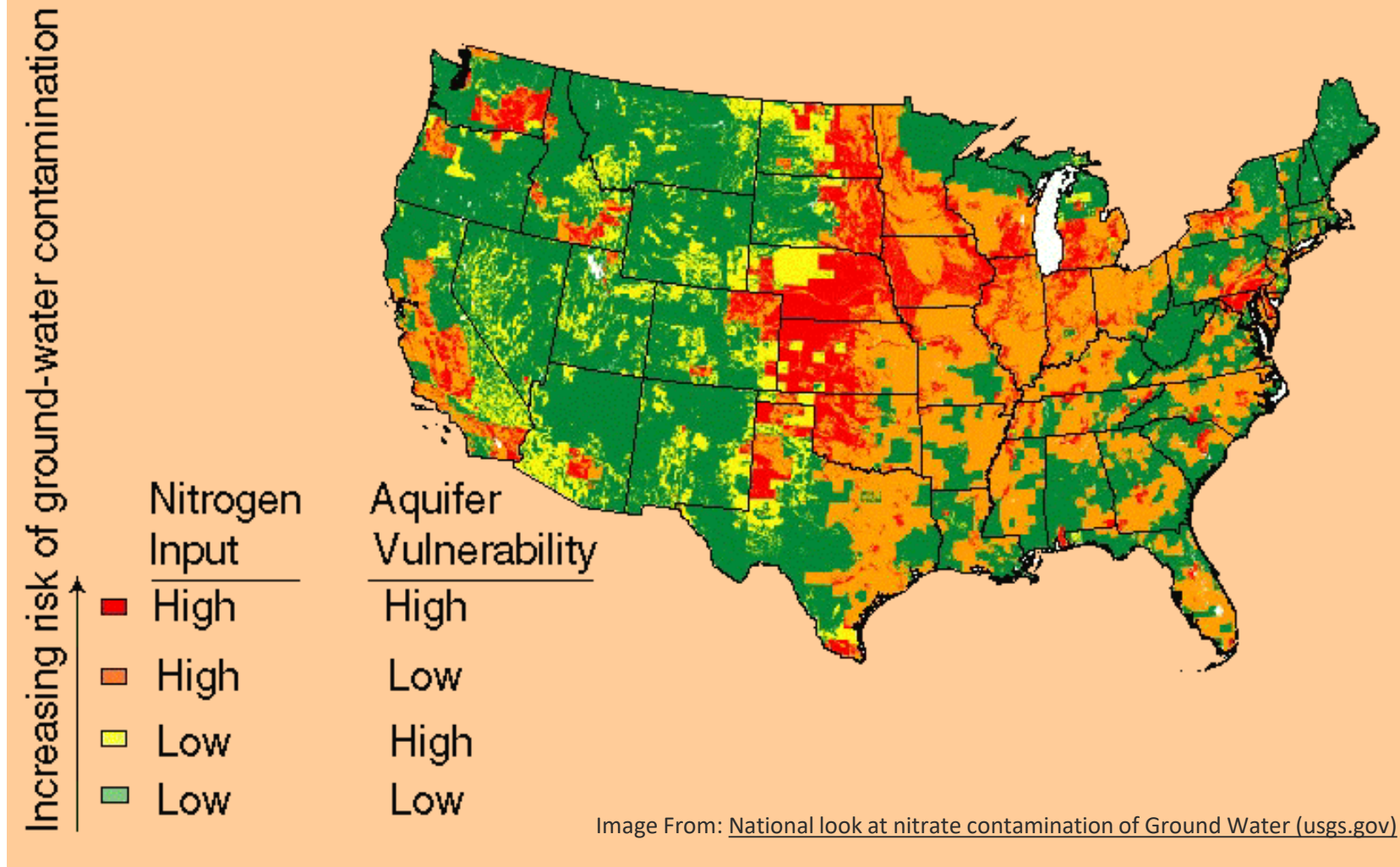
- Facility produces electricity and renewable natural gas from cow manure.
- Permit regulates emissions from these systems.
- Does not regulate emissions from the dairy itself.
- Proposes to increase some emissions limits and decrease others.
- Analysis shows air quality will remain within healthy levels.

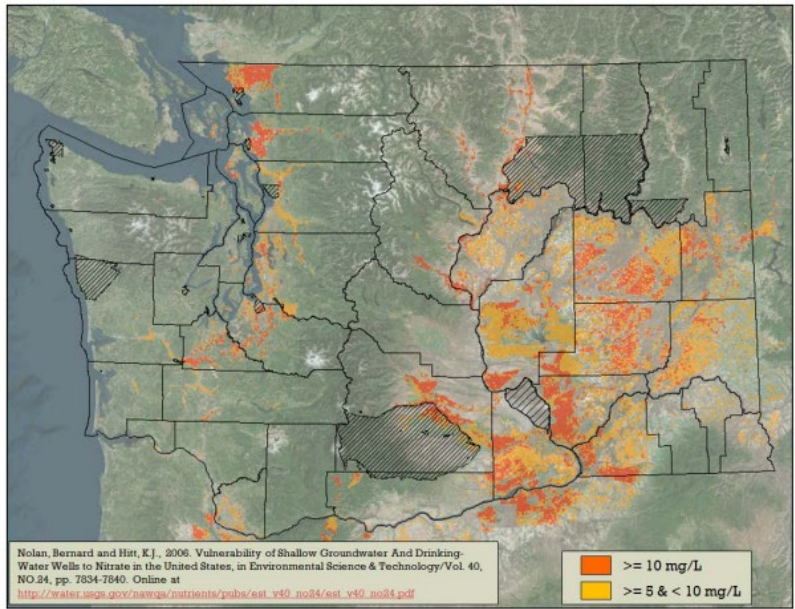
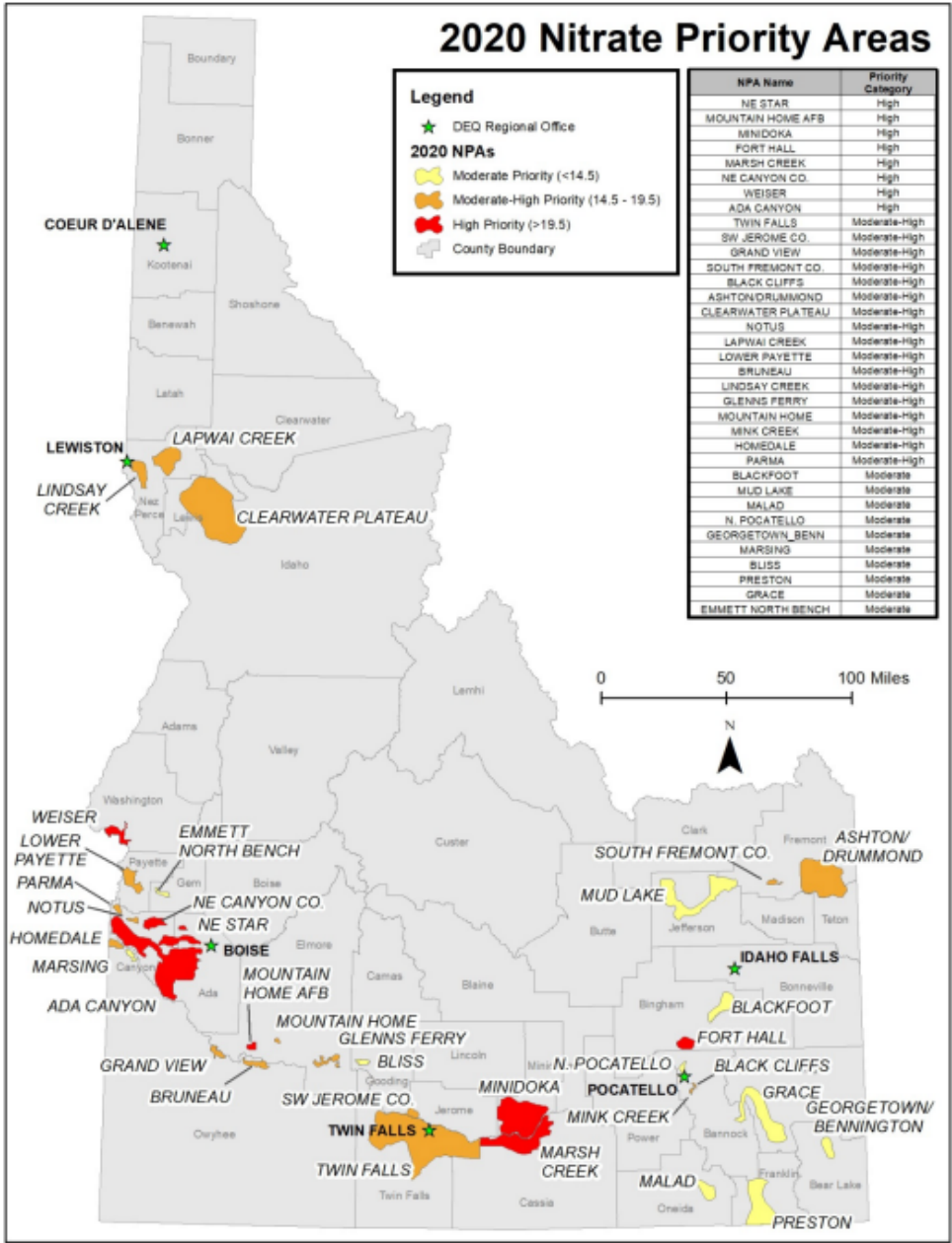
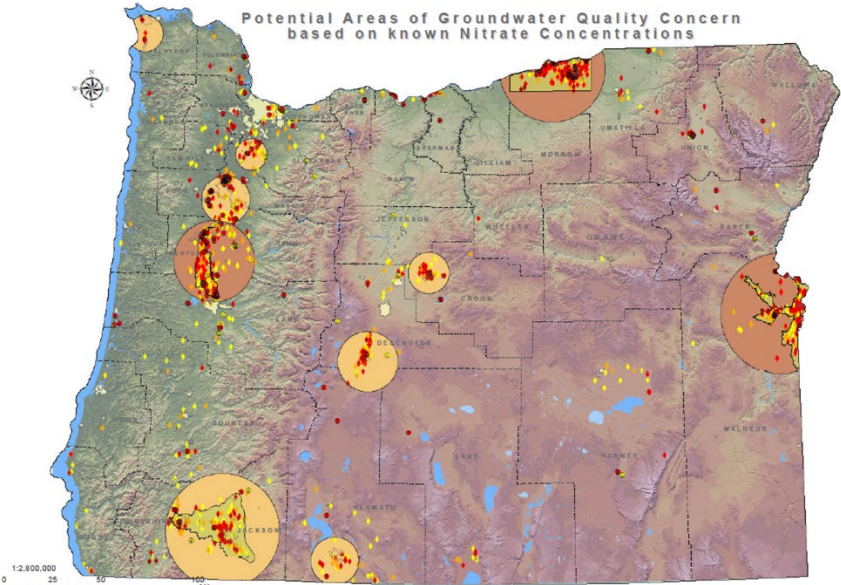


Figure 11: USGS nitrate prediction grid categories greater than or equal to: 5 ma/L Nitrate as N in shallow groundwater (extracted from Nolan, 2006).

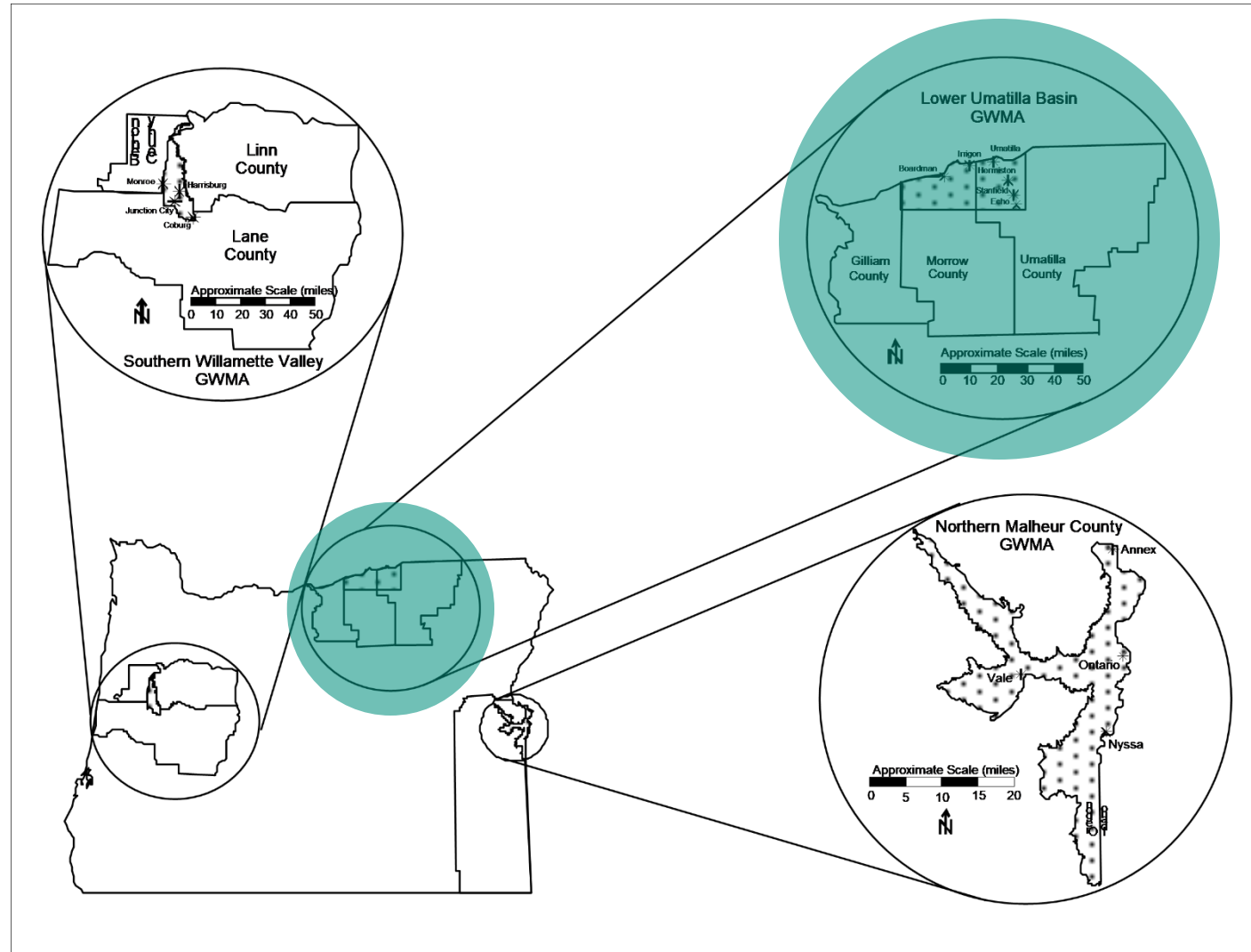

3. Southern Willamette Valley (2004)

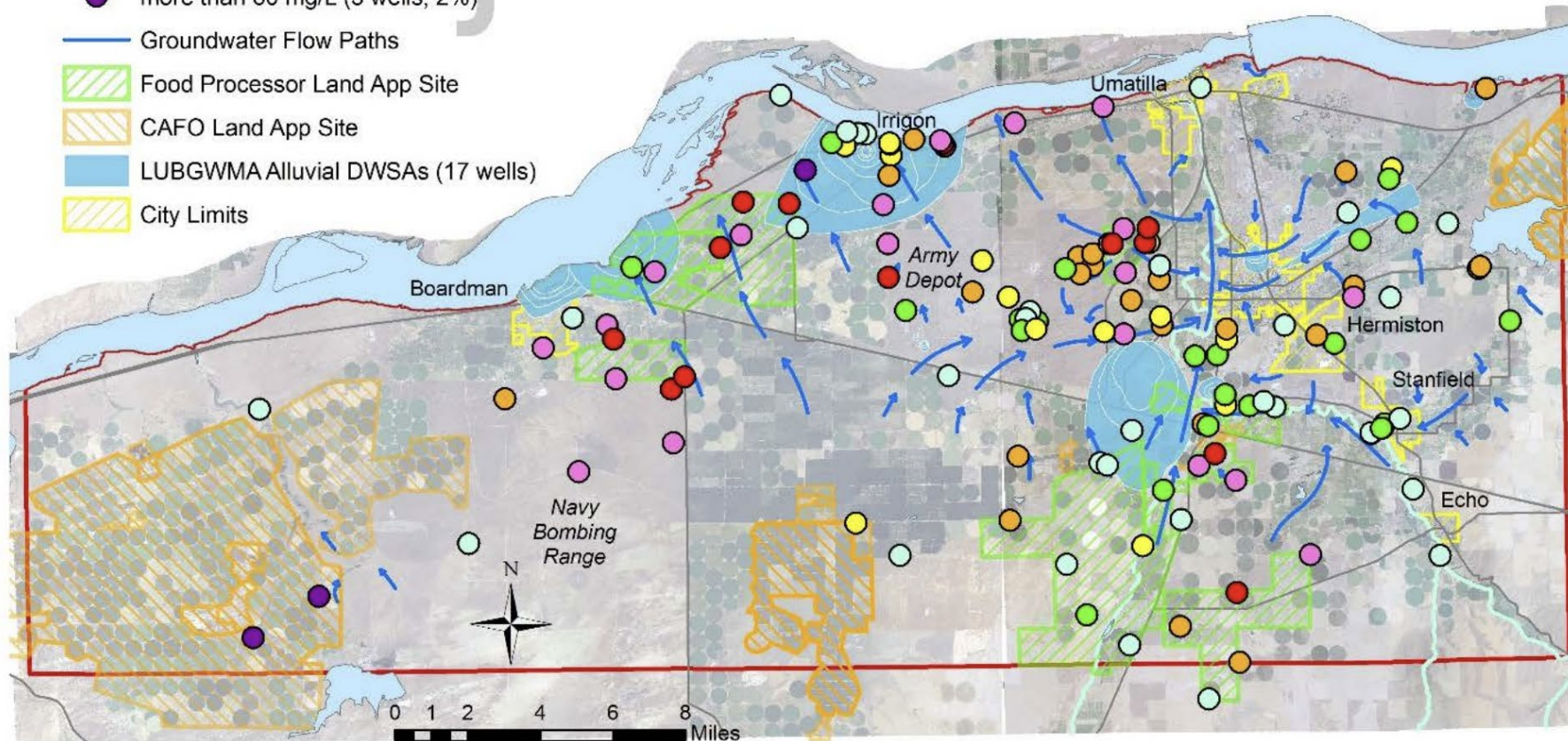
Figure 2-9 Fourth Synoptic Sampling Event Nitrate Results Second LUBGWMA Action Plan

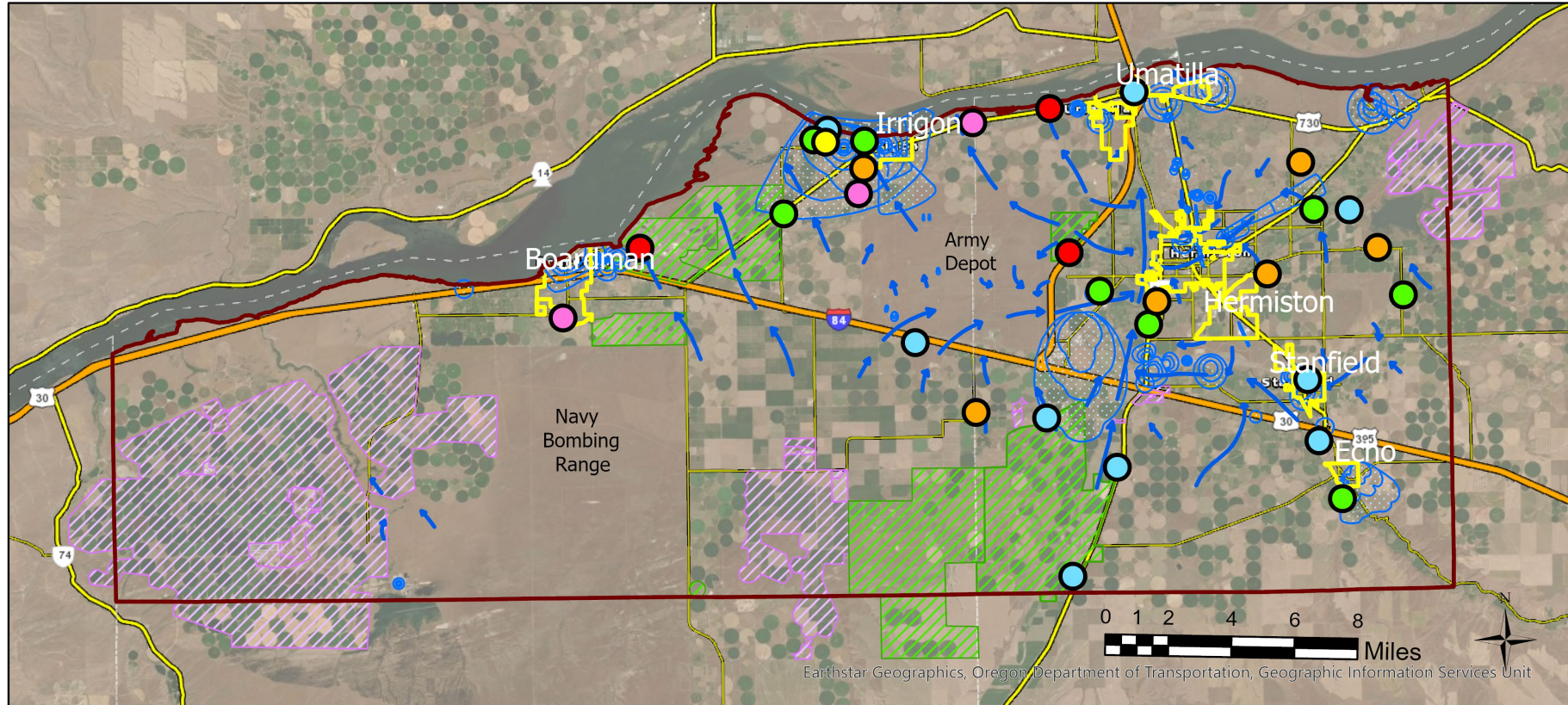

March 2022 Nitrate Concentrations Lower Umatilla Basin Groundwater Management Area

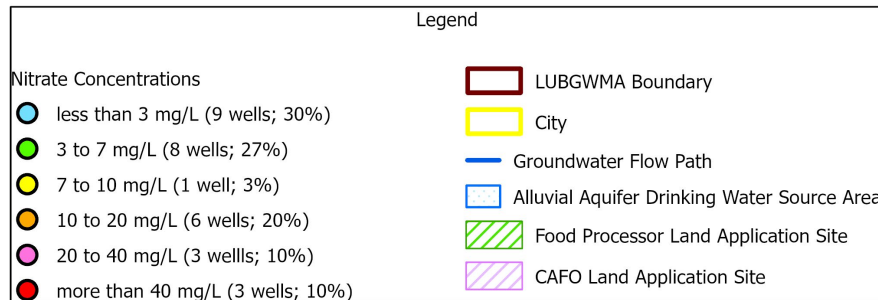

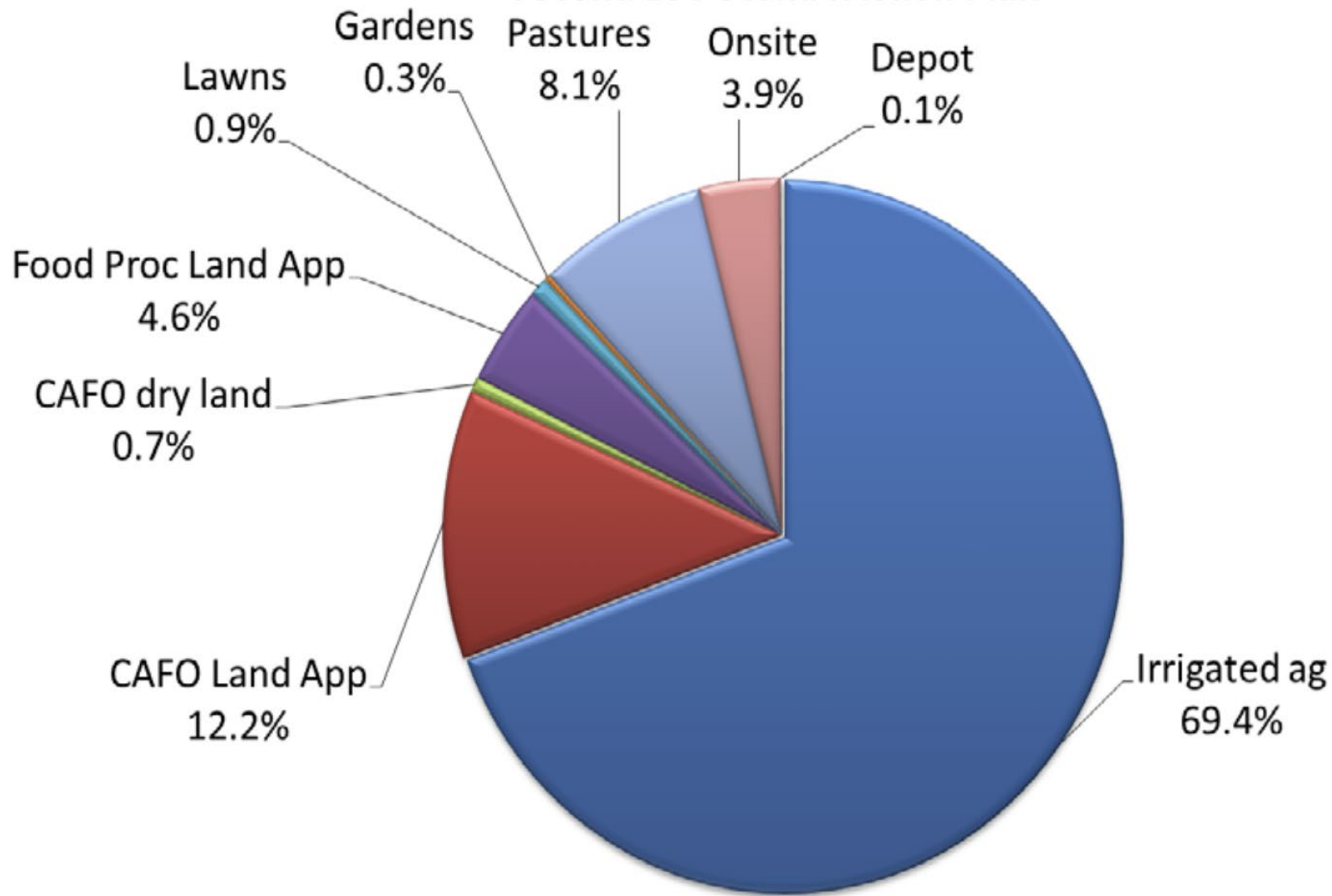
