- 1. Fuel sales for the month of May were reviewed. Fuel sales are increasing with summer weather and supporting Life Flight Network's activities.
- 2. Work on the new taxiways for the planned new T-hangar building is continuing. The existing taxi lanes and the old concrete slab have been removed in preparation for new taxi lanes and a new concrete slab. The new drainage system is being installed.
- 3. Staff discussed estimated closure dates for the adjoining taxi lanes as the construction proceeds. There will be a pause in the work until the information for the new concrete foundation is finalized and submitted for permit approval. This pause is necessary to coordinate the schedule between the excavation/paving with the new hangar work.
