CALLTO ORDER

MINUTES

Motion to approve minutes from September 14, 2023 Parks & Recreation Committee meeting made by Nicole Westing, seconded by Angel Aguilar. Motion carried unanimously.

REPORTS & BUSINESS

DIRECTOR'S REPORT presented by Brandon Artz

USDA FOREST SERVICE

- USDA Forest Service awarded City of Hermiston \$1,000,000 for urban and community forestry.
- Project: Urban and Community Forest Health and Biodiversity for Long-term Resilience.
 - Funds will be used for the mitigation of invasive Russian Olive trees and focusing on the replanting of native trees in the west side of Hermiston encompassing Oxbow trail area.
 - o Funds are expected to be dispersed sometime in March 2024 via The River Network, our pass-through partner.
 - o Grant agreement requires funds to be fully exhausted within 5 years.
 - Initial request was \$3.5M therefore the budget will need to be adjusted to work within the \$1M grant.

HARKENRIDER SENIOR ACTIVITY CENTER

- Monthly meetings with Hacker, Portland based architects, to review designs and updates.

HERMISTON PICKLEBALL

 Hermiston Pickleball Club is in the early stages of fundraising for the development of a pickleball facility at Butte Park with the support of Parks & Recreation.

Parks & Recreation

- Proposed facility will consist of eight standard courts and one ADA court.
- Plans also include substantial sound mitigation due to proximity of area residents.
- o Design, budget, and fundraising details on presentation pages 5-7
- o EOTEC is currently managing indoor pickleball.

BARK PARK SHELTER

- Marlette has been our partner on this project, providing volunteers and donation of materials.
 - o Shelter construction is near completion.
 - Solar lighting will be installed for extended use.
 - Dog water fountain to be installed that was partial funded by the proceeds of the Hermiston Chamber of Commerce's Doggie Dash in June 2022

TEEN ADVENTURE SKATE PARK

- Concrete pouring has started.
- Permitting for ADA has been approved.
- Roughly five more weeks of construction still to go.
- Restroom, irrigation, and landscaping will continue after the skate park is complete.
- No official opening date set.

HORIZON PARK PLAYGROUND

- Currently working with three different manufacturers (MRC, PlayCraft, NW Playgrounds) for quotes on playground equipment for Horizon Park.
- \$70,000 Budget, expect to have all three quotes by next meeting.

RECENT EVENT UPDATE

- Faith & First Responders and Kiwanis Kids Day hosted their events together at Butte Park drawing over 2,000 people in attendance. Idea for next year: possibly shut down all activities during presentations and performances on the stage.
- Cork & Barrell sold 250 tickets. Good crowd despite so many other events happening at same time.



The Forest Service awarded more than \$1 billion to community and faith-based organizations, Tribes, cities, towns, and other partners to

- More information is on the way as they figure out how they are going to disperse funds.
- Budget will need to be updated from \$3.5mil to \$1mil
- The River Network is our pass-through partner.










Bark Park Shelter






