a. Sonic Bloom 2023 After Action Report

Brittney Ciarlo, Emergency Manager, Cheri Chamberlain, Land Use Officer, Building Inspector and Code Enforcement and Ryan Sablich Building Inspector and Code Enforcement presented the report.

Many statistics were given from the report. Some of the things that worked well were improved management plan for roads, routine sound checks, Farmers Market, etc. One of the things that needs improvement would be adequate cell service to accommodate the event.

<u>Shea Wootan</u>, Art and Theatre teacher at the High School, asked the Commissioners to support the arts and entertainment and tourism that is around us. These things can lift a community out of poverty. If we don't support Sonic Bloom, it would send the wrong message to our community.

Ryan Gies, Huerfano County resident, asked Commissioners to remember how positive the support was here today for Sonic Bloom.

Al Meisman, Huerfano County resident, wants Commissioners to support Sonic Bloom.

<u>Travis Nelson</u>, Huerfano County resident, said Sonic Bloom is good for our county and he encourages Commissioners to put their support behind it.

<u>Carl Young</u>, Huerfano County Administrator, asked Jess Gries, Attorney for Sonic Bloom to consider applying for a Conditional Use Permit instead of a Temporary Event Permit.

Public Hearing Conditional Use Permit #15-010 Walsenburg Cannabis Staff Report 2023 Cheri Chamberlain, Public Hearing Officer, Building Inspector and Code Enforcement stated this is continued from the public hearing on May 23, 2023, when Commissioners gave Walsenburg Cannabis and David Lessar an opportunity to move forward to keep the Permit CUP #15-010.

Cheri Chamberlain gave a summary of the conditions of the buildings and property from a recent visit. All in all, it looks like a good site for horticulture. It would take very little to get operational. No broken windows. Mr. Lessar said the original intention was to see this as major cannabis cultivation facilities. The cannabis market has since taken quite a turn. Right now he does have two credible, potential buyer prospects and is trying to move this forward. He appreciates the Commissioners patience in playing this out.
