A. CALL TO ORDER AND ANNOUNCE A QUORUM PRESENT

1. Approval of Minutes from June 10, 2025.

2. Hutchins Big Event Outlined by W. Randle.

W. Randle reviewed the event schedule for Hutchins' Big Event and event goals. The event will start at 8:00 AM, with training and education from Republic on the services to be offered to Hutchins. If they are unavailable, W. Randle advised that she would reach out to neighboring cities to explore alternative options. The event will break up into 6 groups around 9 AM. The goal of the event is to educate the community about recycling and cleanliness. The Board will need to identify the area where they would like to place the mural (sidewalk or Basketball court) to present to the council for concerns.

3. Discuss and Consider Hutchins Big Event

The Board requested that Republic provide training and education on the services they offer to Hutchins. If they are unavailable, W. Randle will reach out to neighboring cities to explore alternative options. W. Randle advised the Board to come up with suggestions of locations that they would like to paint the murals, so that the suggestions can be presented to the council and approved. Additionally, the Board plans to place 10 trash receptacles throughout the city. A. Rodriguez motioned for approval, and G. Wadley seconded the motion. All in favor, the motion was approved.
