

Monday, June 03, 2024, at 6:00 PM City Hall, 321 N. Main Street

A Meeting of the Hutchins City Council was held on Monday, June 3, 2024, with a Work Session at 6:00 p.m and a Regular Meeting at 6:30 p.m. at Hutchins City Hall Council Chambers, 321 N. Main Street, Hutchins, Texas, at which time the following items were discussed and considered.

A. WORK SESSION

1. Recreation Center/Library Space Programming Presented by Brandstetter Carroll Inc.

The presenters were delayed by driving in severe thunderstorms and heavy traffic.

Mayor Vasquez opened the Work Session at 6:28 p.m. with all members of the council present. Mary Ann Mitchell and Amanda Hager from Brandstetter Carroll Inc. presented the council with an updated space programming design and requested the council's input on their vision for activities, space utilization, and functions within the spaces.

During the discussion, the consultants confirmed the need for a 5-acre site for the facility. The conceptual drawing shows parking for about 200 cars, however, this number may change with the final design. A 5,000-square-foot area is planned for the library. Changes made after the council retreat included adding an indoor walking track in the recreation center, a play area for kids, a youth sports court, lockers, and changing rooms (but no showers), a designated children's area in the library, and a teen room. The council also discussed the importance of making the facility multi-functional and able to accommodate growth. Suggestions included adding retractable walls in the multi-purpose rooms and having outdoor basketball courts.

Mayor Vasquez adjourned the Work Session at 6:51 p.m.

Background Information

Recently, the City of Hutchins and Republic Services renewed its solid waste contract to allow Republic Services to continue to provide trash service within the City of Hutchins. As part of the renewal, Republic Services conducted a cart audit during January 2024. The audit allowed Republic Services to verify how many carts each resident uses and to ensure each home is receiving the services that they are paying for. Republic Services found 68 discrepancies during their review.

The proposed plan of action is as follows:

- Notify residents that they have additional cart(s) that are not reflected on their current bill.
- Allow the residents the opportunity (within a certain period of time) to contact the City and state if they desire to pay for the additional carts or have the carts removed.
- The City will adjust the trash bills based on the preference of the resident.
- The City and Republic will schedule a date to remove the additional carts

A representative from Republic Services will present the details associated with this audit process.
