We discussed "cleaning up" the 5 buckets; Energy, Transportation, Waste Management, Water and Land Management/Conservation. The author of each bucket needs to define an overall goal and include documentation for action steps. Goals should be measurable. The action steps should keep in mind feasibility (can be done relatively easily) and long-term actions, i.e., City issue a Proclamation/Resolution (relatively easy) and install EV stations around the city (long term). Studies of where the action step has been done before and also cost/benefits should be included. Instances where an action step could be included in another bucket should be indicated, i.e., "increase EV vehicles" is under the Energy bucket and the Transportation bucket.

Improved lists should be sent to Caroline Beamer by February 22nd for review at the next Sub Committee Meeting on February 24th.

Resolution urging the United States Congress to enact the Energy Innovation and Carbon Dividend Act

WHEREAS, an Intergovernmental Panel on Climate Change issued a special report on the impacts of global warming of 1.5°C above pre-industrial levels in October 2018 warning that global warming is likely to reach 1.5°C between 2030 and 2052 if it continues to increase at the current rate.

WHEREAS, the United Nations climate science body said in a monumental climate report that we have only until 2030 to make massive and unprecedented changes to global energy infrastructure to limit global warming to moderate levels; and

WHEREAS, the United States government released its Fourth Annual Climate Assessment in November 2018 reporting that the impacts of climate change are already being felt in communities across the country, and that more frequent and intense extreme weather and climate-related events, as well as changes in average climate conditions, are expected to continue to damage infrastructure, ecosystems, and social systems that provide essential benefits to communities; and

WHEREAS, conservative estimates by the world's climate scientists state that, to achieve climate stabilization and avoid cataclysmic climate change, emissions of greenhouse gases (GHGs) must be brought to 80-95% below 1990 levels by 2050; and

WHEREAS, presently the environmental, health, and social costs of carbon emissions are not included in prices paid for fossil fuels, but rather these externalized costs are borne directly and indirectly by all Americans and global citizens; and

WHEREAS, to begin to correct this market failure, Congress can enact the Energy Innovation and Carbon Dividend Act to assess a national carbon fee on fossil fuels based on the amount of CO₂ the fuel will emit when burned and allocate the collected proceeds to all U.S. Households in equal per-capita shares in the form of a monthly dividend; and

WHEREAS, for efficient administration, the fossil fuels fee can be applied once, as far upstream in the economy as practical, or at the port of entry into the United States; and

WHEREAS, as stated in the **Energy Innovation and Carbon Dividend Act**, a national, revenue-neutral carbon fee starting at a relatively low rate of \$15 per ton of CO2 equivalent emissions and resulting in equal charges per ton of CO2 equivalent emissions potential in each type of fuel or greenhouse gas should be assessed to begin to lower what are now dangerously high CO2 emissions. The yearly increase in carbon fees including other greenhouse gases, shall be at least \$10 per ton of CO2 equivalent if statutory goals are not met; and

WHEREAS, the **Energy Innovation and Carbon Dividend Act** specifies that, in order to protect low and middle income citizens from the economic impact of rising prices due to the carbon fee, equal monthly per-person dividend payments shall be made to all American households (one-half payment per child under 19 years old) each month from the fossil fuel fees collected. The total value of all monthly dividend payments shall represent 100% of the net carbon fees collected per month; and

WHEREAS, the **Energy Innovation and Carbon Dividend Act** encourages market-driven innovation of clean energy technologies and market efficiencies which will reduce harmful pollution and leave a healthier, more stable, and more prosperous nation for future generations; and

WHEREAS, the **Energy Innovation and Carbon Dividend Act** will, after 12 years, lead to a decrease in America's CO2 emissions of 40 percent and preserve national employment; and

WHEREAS, border adjustments - carbon content-based levies on products imported from countries without comparable carbon pricing, and refunds to our exporters of carbon fees paid - can maintain the competitiveness of U.S. businesses in global markets; and

WHEREAS, a national carbon fee can be implemented quickly and efficiently, and will respond to the urgency of the climate crisis because the federal government already has in place mechanisms, such as the Internal Revenue Service, needed to implement and enforce the fee, and already collects fees from fossil fuel producers and importers; and

WHEREAS, A national revenue-neutral carbon fee would make the United States a leader in mitigating climate change and in the clean energy technologies of the 21st century and would provide incentive to other countries to enact similar carbon fees, reducing global CO2 emissions without the need for complex international agreements, and

NOW, THEREFORE, BE IT:

RESOLVED, that the City of ______, (state)______ urges the United States Congress to enact without delay the **Energy Innovation and Carbon Dividend Act,** and

BE IT FURTHER RESOLVED, that the City Manager or City Clerk, no later than 30 days after passage of this Resolution, shall transmit copies of this resolution to the President and Vice President of the United States, to the Speaker of the House of Representatives, to the Majority Leader of the Senate, to each U.S. Senator and Representative from the State of ______ in the Congress of the United States, and to nearby city and county governments urging that they pass similar resolutions.


How It Works



Border Carbon Adjustment

To protect U.S. manufacturers and jobs, imported goods will pay a border carbon adjustment, and goods exported from the United States will receive a refund under this policy. This will level the playing field so that countries like China and India will be required to pay as well. It will ALSO help bring other countries on board.

Dividends & Low Admin Costs



Lifetime Admin costs are 2% of the carbon fees collected. A 4-person home after 10 years would receive \$300-400/mo

Who Benefits from a Carbon Dividend?




Figure 2. Comparison of Year 1 household costs from carbon fee with Year 1 carbon dividends. Direct energy is gasoline, electricity, and home heating. Indirect energy is embodied energy in all other purchases. Financial asset costs accrue from carbon costs incurred by businesses and passed back to owners. Carbon dividends are net after personal income tax.





Figure 3. Percent of households whose carbon dividends exceed carbon costs, arranged by race/ethnicity.



Citizens support Carbon Dividends

The Carbon Dividends Plan has majority support across party lines.

Including 4-1 support overall, 2-1 GOP support and 75% support from Republicans under 40.

To the Rails to Trails Advisory Committee

We are pleased and excited to see the Ecusta Rails to Trail Greenway come to fruition. In addition to the benefits for Western North Carolina residents, the greenway will showcase our region to a wider population around the area. We would like to encourage implementation of another positive aspect of the greenway development.

In 1894 when the railroad between Hendersonville and Brevard was built there was little consideration of the impact on the natural environment incorporated into the design. In the 21st century we have become much more knowledgeable about the environment and the impacts that human infrastructure projects can have. The Ecusta Trail will have 16 major trestle crossings of waterways in addition to numerous culvert crossings of smaller streams. The construction of the trail offers an opportunity to correct and improve on past waterway crossing construction efforts.

Instead of hardening the banks adjacent to stream crossings, we have the opportunity to improve the natural infrastructure of the intersecting streams. We are encouraging the use of natural bank stabilization, modifying crossing design to accommodate natural stream alignment and flood water passage, and the planting of native riparian vegetation on steam banks. Stable and appropriate stream crossing design will ensure that the Trail causes minimal impact to the region's water systems from erosion, improves regional water quality and enhances the quality of all aquatic organisms, some of which are threatened. Additionally, this will improve the greenway for both humans and the environment. Appropriately designed and planted stream crossings will encourage pollinators, birds, fishes, mussels and other native animals while providing a more natural and educational experience for those using the trail as well as providing more of a buffer to neighboring properties.

The Ecusta Trail has been thought about and dreamed of for many years. As the planning and construction begins, we urge the Rails to Trail Advisory Committee to think long term in order to ensure that the Trail enhances the natural experience of its users and benefits the broader community through environmentally sound waterway crossing design techniques.

The What

- Let's Go, Hendo! A Life Line is an interactive story through which the participant performs a series of choreographed "hopscotch" movements as they they make their way
 - from Main(Hands On Museum Corner), passing the Good of the Hive Mural eventually connecting to the Bear Crossing ASL Hendo and Bee Line Sidewalk murals, the Farmers Market, Historic Train Depot, and Historic 7th Avenue.
- It is an active and transformative journey through diverse Henderson County terrains and experiences during which time an individual learns something of the world around it, its place in it, and perhaps something about itself.
- As the participant moves through the story's plot line and corresponding changing landscapes, it transforms into different native WNC inhabitants of the terrains: from a human skipping across stones in a creek, to a brook trout flowing with its river's current through and to the mountains and what's on the other side.
- The story reinforces the importance of the environment, community, art, and fitness, in short, sustainability.
- It serves as an apt metaphor for our community's, our environment's and our own continuing lifecycles and the interconnectivities, co-dependencies between. See next slide for details.



The Who

Proven Track Record for Underbudget, On time, Sponsor-Favorable Results

- In response to a Fast Action Grant from Friends of Hendersonville and the AARP, Elizabeth Queen's original concept for the Hendo Beeline, a sidewalk mural along Maple between 5th and 7th was manifested into reality over the course of approximately 8 weeks during the Fall of 2021 with the help of local artist David Queen, the work of approximately 20 local supporting artists aged 3-+75, and hundreds of volunteers, especially including students from Hendersonville High School.
- Around the same time, local mural artist Diamond Cash, with the help of family and friends completed the now iconic Bear Crossing and ASL Hendo sidewalk murals.
- These successful installations exceeded expectations and created a public thirst for more, more, more community driven, interactive public arts activities in our area.
- To conduct the proposed work for Let's Go Hendo: A Lifeline, Elizabeth would again work with local volunteers as coordinated through the City's volunteer program and local schools.

The How To Do

1. Premise: We understand that the sidewalk along King Street is slated for renovation sometime in the coming few years. Therefore, it does not make sense to design a fully fledged sidewalk mural (representing the story's terrains) at this time.

- 2. Short Term: Phase 1: a "Pop Up" installation
 - for completion before 2022 Garden Jubilee (mid-May 2022)
 - to invite foot traffic between sites and introduce Phase 2 concept and funding opportunities to community pending King Street Renovations
 - Anticipated cost relatively nominal (\$+/-4k).
 - Story Board Signs (#15)- same look, feel, construction as those currently being made for the Good of the Hive and Mainstreet Pollinator Garden
 - Stencils (#10) Animal Character foot/pawprints
 - Paint/Protective Sealant- (no underpaint/primer intended for this more "Temporary" installation.
 - Artists' Stipend
 - Funding Note: Some funds and paint remain from the 2021 Sidewalk Mural work as that project worked around sidewalk construction between King and Grove.

3. Longer Term: Phase 2: a more permanent installation (companion sidewalk murals that go with the story) - anticipated cost \$12-15k. E.Queen prepared to choreograph this one as was done a'la Hendo Beeline and draw on local talent and volunteerism to manifest this into reality when the time/funding is right.

4. A'la Carte: Elizabeth's companion book Let's Go Hendo: A Lifeline is intended to be simultaneously published, offered via retail outlets, 10% of profits of book sales, related merchandising to benefit author-selected local Hendersonville charities annually. The author expressly reserves and retains any and all intellectual property and other rights to to the Let's Go Hendo story, book, and related merchandising including but not limited to trademarks, copyrights and the rights to license the Let's Go: A Lifeline story and companion interactive art and fitness sidewalk mural concepts to other communities at her, her estate, and assigns sole discretion.
