RESOLUTION BY THE CITY OF HENDERSONVILLE CITY COUNCIL TO ENCOURAGE THE INSTALLATION OF ELECTRIC VEHICLE SUPPLY EQUIPMENT (EVSE) AT NEW BUSINESS AND MULTI-FAMILY DEVELOPMENT AND REQUIRE EVSE INSTALLATION AT NEW OR RENOVATED CITY OWNED CONSTRUCTION

WHEREAS, ON June 3, 2021, City Council adopted the City of Hendersonville Core Values and Beliefs that include a statement that the City of Hendersonville believes that environmental sustainability is critical to preserving the community for future generations; and

WHEREAS, the Core Values and Beliefs environmental sustainability statement includes a commitment to maintain a solid relationship with residential and business development; and

WHEREAS, the Core Values and Beliefs environmental sustainability statement includes a commitment to lead by example in evaluating all City operations to ensure they are environmentally sustainable.

WHEREAS, Hendersonville Environmental Sustainability Board formally requested that City Council promote the installation of EVSE in new business and multi-family development; and

WHEREAS, Hendersonville Environmental Sustainability Board formally requested that City Council require EVSE installation at new or renovated City owned construction.

NOW THEREFORE, BE IT RESOLVED by the City Council of the City of Hendersonville, North Carolina that:

1. The City Planning Division, in coordination with the Environmental Sustainability Board, is directed to prepare and distribute to prospective developers, information on the benefits and logistics of the installation of EVSE.
2. The City Manager and public works department is directed to ensure that new or renovated City owned construction, where parking is provided, includes the installation of EVSE.
