*Saturday, August 17, Maple Street Farmers Market.* 8 a.m.-2 pm. -- ESB will have a booth at the Maple Street Farmer's Market highlighting the symbolic monarch migration project of the Bee City USA-Hendersonville. Janet T and Glenn L will provide copies of the Tree Board brochure and the "landscape species list" and explain the importance of Keystone Plants.

Saturday, October 5 – Farm-City Day. 10 a.m.-4 p.m. Jackson Park. Possible tabling at this event?

Sunday, October 13 – Explore Brooklyn Creek Restoration Project. 2 p.m. Meet at Sullivan Park pavilion in Green Meadows Community. Park along Martin Circle. (Rain date: Sun., Oct. 20, 2 p.m.) Mike Huffman, the City's project manager for this extensive stream restoration project, will explain not only the project – which uncovered portions of the stream long forgotten – but also the relevance of the stream in the history of this community. A restored Bird Sanctuary, restoration of the natural meandering stream, streambank plantings, and upcoming community involvement will be discussed during this less-than-1/2-mile stroll.
