Your Special Event Permit includes the following public services:

CLOSURE:

This is a closure of Main Street from Allen to Caswell

PUBLIC WORKS:

- Barricades for street and avenue blockage
- The Private parking lot to be blocked off from Main Street
- MVB barricades at Allen & Caswell on Main Street
- Power access for the closure Allen & Caswell
- Water barricades for Avenues to be filled at 9:30am
- 2 Sets of Trash and recycling cans
- No Parking signage dropped the night prior

- Barricades to block Truist & Wells Fargo Main Street entrance unfilled
- Barricades to block one side of the bike lane

POLICE:

- Put out No Parking after 5am signs the night before the event
- Assistance with towing if needed
- 3 off duty officers Extra Duty to be paid through Caregivers of Mother Earth

FIRE/EMS:

- Tent inspection
- EMS standby request must be made directly to EMS by event organizer (form required)
