1. Call to Order

The meeting was called to order at 5:06 p.m. by Caroline Gunther, Chair. Members present were Angela Prodrick, Vice Chair; Jean Greeson, Katie Weibel, Robin Grainger, Melissa Vazquez and James Lyon. New member Marianne Pendleton attended the meeting via Zoom.

City Staff present: Melissa Justus, Staff Liaison, Chief of Police Blair Myhand and Civilian Animal Control Officer Alexis Barker.

2. Public Comment

There was no public comment.

3. Approval of Agenda

Motion made by Vice Chair Angela Prodrick to approve the agenda as presented; unanimous vote followed.

4. Approval of Minutes

5. Old Business

The recommended revisions and changes to the Chapter 10-Animal Ordinance by the ASAC was approved on August 9, 2023 by City Council.

Discussed having a possible off-site meeting to include training on the procedures and process of having future Dangerous Dog hearings. James Lyon has worked with the Henderson County Animal Services regarding these procedures. Chair Caroline Gunther will talk with Daniel Heyman about training possibly with already produced material, starting from scratch or combining training with Henderson County.

Vice Chair Angela Prodrick discussed the Spay & Neuter (S&N) program and that she had approached the COH Finance Department about special appropriation funds being available from the state for the program, they recommended that she bring the topic to the ASAC. The sale of special North Carolina license plates appropriates funds towards this program.

Blue Ridge Humane Society gets \$5,000.00 per year from the City of Hendersonville for the S&N program. The special funds could allow the COH to put the money that is allocated back into the General Fund. Chair Caroline Gunther will talk with City Manager John Connet about whether the ASAC should research these state appropriated funds further and will report back to the committee at the October 19th meeting.
