
HENDERSON COUNTY ANIMAL WELFARE SURVEY

We received a total of 934 respondents (which is above and beyond a survey of this type given the kind of coverage we were able to bring to the public over it.)


1. Are you a Henderson county resident?


5. On a scale of 1-5, 1 being least and 5 being most, how concerned are you about the vaccination status of pets in your area?


7. Do you have specific health concerns regarding your pet?
