MINUTES

Call To Order at 6:03 p.m.

Also in Attendance: Town Clerk Brock, Town Administrator O'Keefe, Town Planner Harwoski

Park Assessments:

Well #3: Dwarf Magnolia may be dead, or needs trimmed. Blocks need power washed.

Cemetery: Need to begin on the list of items before May 31.

Town Hall/Police/Central Park: Fountain is bagged, not sure why.

No Report on Blevins Patriot Park or on Griffin Park as Rachel was not in attendance.

Mural Status:

Kristina (the muralist) had indicated she would like to redo the lettering. Pat is to contact her. (Kristina was contacted and she said she would be redoing the lettering in approximately two weeks).

Sunshine Laws/Ethics Training:

Town Clerk Brock provided the Parks and Rec members an overview of Sunshine Laws. Town Administrator O'Keefe provided an ethics training and information on the Parks ordinance.

CIP:

Town Planner Harwoski provided a comprehensive explanation of the CIP, column by column. Discussion took place on the need to review the CIP on a monthly basis by Parks members and provide any updates.

Venezia lot:

Parks was asked to submit ideas for the "Pine Park", as we are calling it temporarily. We had submitted options earlier in 2021, but will revisit the options and submit a Board Report on our ideas.

Parks was reminded they are responsible for advising if any of the fees need to be updated for the boat ramp, pavilion, cemetery, etc. Parks will take this into consideration at the next meetings.
