City Manager Schmitz said it would have to be looked at how the property is addressed in comparison to the other properties. The following comments were heard from Council and Staff: Weber – He had a resident reach out to him about not allowing street parking on 2nd St NE between 7th and 8th Ave NE. He would like to talk about this and other areas at a future work session. Hanna – Asked when the recycling dumpsters will be available for residents to use at RiversEdge? Moore – Homecoming is this week and there are lots of events happening for people to be aware of. City Manager – There are trees at RiversEdge that need to be trimmed before the dumpsters will be placed there. Speed learning signs have been installed on 2nd Ave NE and 6th Ave SW. He hopes that they will be on later this week. Mayor – Thanked Council Member Weber for attending the meetings at INRCOG last week while he was at the Iowa League of Cities Conference.
