REAL ESTATE:

1. 2024-R-024

Authorizes DMD to convey land to BWI or its affiliate in consideration of certain commitments to be made for the purpose of beneficial redevelopment including creation of affordable housing.

2. 2024-R-030

Metropolitan Development Commission authorizes DMD to amend the contract with Indiana Theatre Maintenance LLC, to add to extend the term and services through 2028 with a new overall not-to-exceed amount of \$240,000.
