### **CALL TO ORDER**

Mayor Kennedy called the meeting to order at 7:00 P.M.

### **INVOCATION**

Councilmember Varlack prayed aloud.

### **PLEDGE OF ALLEGIANCE**

The Pledge of Allegiance and Texas Pledge were recited.

### **SPECIAL PRESENTATIONS & ANNOUNCEMENTS**

1. Proclamation- Breast Cancer Awareness Month

Mayor Kennedy read the Breast Cancer Proclamation aloud.

### **CITIZEN COMMENTS**

Valeria Thompson expressed concerns regarding the county's movement of dirt and requested information about the soil. She stated that county staff informed her the material was contaminated and therefore she could not have it. However, she has observed other individuals receiving portions of the soil. She questioned why others are allowed to take it if it is considered unsafe or hazardous. Ms. Thompson is requesting answers about the soil, including why some residents are permitted to obtain it while others are not, the county's policy for soil disposal or distribution during projects, and the criteria used to determine eligibility.

Carolyn Bowen spoke about uniform development codes, noting that while new developments follow uniform standards, the rural areas do not. She expressed concern that these standards are being imposed on rural residents unfairly. She also commented on the City Manager search process.

Kristina Hanson invited the City Council to the grand opening celebration for the Ellwood Development.

### **COUNCIL COMMENTS**

Mayor Pro Tem Greene-Scott thanked everyone in attendance and noted that the City Council is currently in the process of hiring a new City Manager. She reminded the public that early voting is underway and that Election Day is November 4.

Councilmember Murray thanked everyone for attending.

Councilmember Brooks reported that she met with the Historical Committee, shared the committee's plan, and encouraged interested residents to apply for membership.

Councilmember Hargroder expressed appreciation for those in attendance.

Councilmember Boyce also thanked the attendees. He noted that the City Manager candidates were able to engage in productive conversations with residents during the search process. He thanked the members of the Charter Committee and recognized the Teen Advisory Committee for their service at the Houston Food Bank, stating he is very proud of them.

Councilmember Varlack thanked the attendees and the members of the Charter Committee, noting that they have begun reviewing potential amendments to the city charter. He encouraged residents to review the charter and share any suggestions or proposed amendments. He also reminded everyone that early voting is underway.

Mayor Kennedy invited Reverend Will Cumby to deliver an additional invocation, and Reverend Cumby offered a prayer aloud.
