CALL TO ORDER

Mayor Kennedy called the meeting to order at 7:00 p.m. Mayor Kennedy called a recess at 7:00 p.m. The Mayor and City Council returned back into session at 7:10 p.m.

INVOCATION

Reverend Duane Turner prayed aloud.

PLEDGE OF ALLEGIANCE

The Pledge of Allegiance and Texas Pledge were recited.

CITIZEN COMMENTS

The following citizens spoke regarding the building setback requirements in Magnolia Bend. They expressed concerns that the current setbacks are too restrictive and should be reduced. They also stated that the Unified Development Code and the Subdivision Ordinance appear to contain conflicting provisions and requested that the Council review the regulations.

Michael Dunlap thanked Mayor Kennedy for the opportunity to speak. He addressed the consideration of adopting a City flag and outlined several reasons in support of the idea. He stated that a flag serves as a

strong symbol of identity and fosters a sense of community. It provides a visual representation of connection among residents and reflects the City's history; past, present, and future. He further noted that a City flag would symbolize the people of Iowa Colony and could be displayed at public buildings and community events as a reminder that Iowa Colony is a community built on unity and history.

SPECIAL PRESENTATIONS & ANNOUNCEMENTS

1. Proclamation- Martin Luther King Jr. Day

Mayor Kennedy read aloud and presented the Martin Luther King Jr. Day Proclamation to Councilmember Arnetta Murray.

2. Officer recognition for performing emergency life saving techniques.

Chief Bell recognized Officer Portano for his actions on December 6, 2025, while assisting other agencies during a medical emergency. His quick response, effective life-saving measures, and coordination with assisting agencies played a critical role in stabilizing the patient and ultimately saving their life. Chief Bell also shared that he received a formal compliment recognizing Officer Portano's professionalism and dedication to public service, and he expressed his appreciation for Officer Portano's outstanding work.

City Manager Tarron Richardson presented a token of gratitude to Officer Portano on behalf of the City Council and himself in recognition of his actions and service.

PUBLIC HEARINGS

3. Hold a public hearing pursuant to the City of Iowa Colony's Citizen Participation Plan regarding the completion of the City's Community Development Block Grant - Regional Mitigation project (GLO Contract #24-065-009-E166) to allow citizens the opportunity to review the project's performance and to discuss citizens' views, proposals, questions, and comments.

Mayor Kennedy opened the public hearing at 7:36 p.m. Megan Flynn with Public Management provided an overview of the CDBG award from the General Land Office (GLO) for the drainage improvement project. She asked if there were any questions and noted that the project is anticipated to reach full closeout by March. There were no additional comments. Mayor Kennedy closed the public hearing at 7:38 p.m.

COUNCIL COMMENTS

Mayor Pro Tem Greene-Scott thanked everyone in attendance and recognized staff for their hard work on the MLK event, the State of the City, and the BCCA meeting. She quoted Dr. Martin Luther King Jr., stating, "We have some difficult days ahead, but we will get through it together, and we have to work through it together."

Councilmember Murray shared that she previously lived on 40 acres and noted that when you own land, you value the ability to use it as you choose.

Councilmember Brooks thanked everyone who participated in the MLK parade and said she was especially impressed by the involvement from the Magnolia Bend community. She encouraged continued engagement and offered her assistance to residents. She also expressed that it was great to see strong attendance at the City Council meeting, reflecting transparency and community involvement.

Councilmember Hargroder thanked everyone for attending and expressed appreciation to Councilmember Murray. She acknowledged the recognition given to staff for their hard work and stated that during her time serving alongside Councilmember Murray, she has witnessed her dedication to community building. She added that Councilmember Murray deserves recognition for her efforts. She also thanked the City Secretary for her efforts with the State of the City and BCCA.

Councilmember Boyce stated he was pleased to see a full gallery. He noted it had been a busy few weeks with the MLK parade, the City of Alvin's first MLK event, the State of the City for Iowa Colony, and the BCCA meeting at Meridiana Elementary School. He shared that he served on the committee and worked closely with Councilmember Murray, noting that the MLK event has grown significantly and was a great success. He commended her for bringing the event to fruition and thanked staff, including Public Works and Albert Cantu. He also acknowledged the Police Department for their planning and dedication to ensuring safety during the events.

Councilmember Varlack thanked Councilmember Murray and Councilmember Boyce and recognized Mrs. Boyce for her speech at the MLK Day event. He also thanked Chief Bell and his staff for their leadership and service, particularly in light of current national challenges. He quoted Dr. Martin Luther King Jr. and stated that Iowa Colony must continue to be the light and change the world needs.

Mayor Kennedy thanked everyone for attending and welcomed Dr. Tarron Richardson to his first City Council meeting. He acknowledged the Police Department's efforts and contributions, as well as the success of the MLK Day event and program. He also recognized the Iowa Colony Fire Department and thanked Councilmember Murray and her team for their work.

STAFF REPORTS

The City Secretary reminded everyone that the filing period for a place on the ballot closes on Friday, February 13, at 5:00 p.m. The positions up for election are Councilmember Position 1, Councilmember Position 2, and Councilmember Position 3.

Dinh Ho, City Engineer, provided clarification regarding the adoption dates of the Zoning Ordinance and the Subdivision Ordinance, as well as the building line setback regulations contained within each document.

Councilmember Brooks asked what the quickest resolution would be to address the issue. Mr. Ho explained that amending the ordinance would require a public hearing and formal action to revise the ordinance. He further noted that any amendment would need to be citywide and could not be limited to a specific subdivision.

Councilmember Boyce asked about issues related to stray animals and inquired about best practices residents can follow to assist staff in addressing the problem. Fire Marshal Cantu advised residents to microchip their pets, explaining that doing so greatly improves the City's ability to identify and quickly reunite animals with their owners.

Councilmember Varlack inquired about the status of the gates at Sterling Lakes Drive. Dinh Ho responded that construction has begun.
