Mayor Kennedy called the meeting to order at 7:11 P.M.

2. Hold a public hearing for a sign variance regarding the height and sign area for a temporary free-standing sign at the Southwest corner of Crystal View Drive and County Road 48.

Mayor Kennedy opened the public hearing at 7:58 P.M. There were no comments from the public. Mayor Kennedy closed the public hearing at 9:01 P.M.

COUNCIL COMMENTS

- Councilmember Barnett had no comments.
- Councilmember Murray stated that the Fourth of July event was amazing.
- Mayor Pro Tem Greene-Scott stated that the Fourth of July event was great even though Whitney Houston's version of the National Anthem was not played. She reminded everyone to stay hydrated as it is hot outside. She thanked those in attendance at the meeting.
- Councilmember Varlack thanked the members of the public for attending the meeting. He also thanked the staff for being in attendance. He mentioned that the Fourth of July event was outstanding. It appeared that there were more people in attendance at the event this year than last year. Staff did an outstanding job getting folks out of the parking lot after the event. It was a major improvement from last year. Just a reminder to please stay hydrated in this heat. There are still many stones that are being deposited onto the road particularly coming out of the concrete crushing facility at Meridiana Parkway leading both directions on 288 going South and North. He is asking the contractor to please run the street sweeper at least early in the morning and around late afternoon. He stated that the Touch a Truck event was awesome.
- Councilmember Byrum-Bratsen concurred with Council Member Varlack stating that there is a scatter of rocks on Meridiana Parkway exit turning left onto 288. He asked if the pipeline of CR 57 West secured a deposit for the road for the new pipeline, they are putting in across and under 288. He drove through Sterling Lakes and the fire hydrant painting looks great. He thanked the Mayor for the Pride Proclamation.
- Councilmember Hargroder expressed her appreciation for the staff. Fourth of July was above and beyond. She thanked Jeremy and Parks and Recreation for the wonderful event.
- Mayor Kennedy stated he is honored and humbled to have such an outstanding council to work with. He thanked the three members of council who attended the Planning and Zoning Commission meeting. He stated that the Iowa Colony Pioneers will be kicking off their fall season soon. Go Iowa Colony Pioneers! Stay Hydrated. 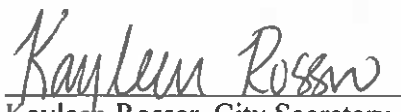

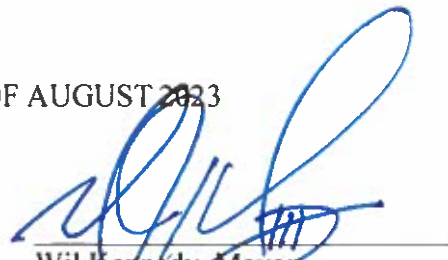
ADJOURNMENT
