CALL TO ORDER

Mayor Kennedy called the meeting to order at 7:02 P.M.

INVOCATION

Councilmember Varlack prayed aloud.

PLEDGE OF ALLEGIANCE

The Pledge of Allegiance and Texas Pledge were recited.

CITIZEN COMMENTS

Dr. John Okewunmi thanked Fire Marshal Cantu for visiting his home to review the Ellwood development. He discussed the proposed annexation of 20 feet from the centerline of County Road 758. He referenced a planning meeting held on May 5, 2026, and a City Council meeting held on May 16, 2026. Dr. Okewunmi expressed concerns regarding inconsistencies in the documentation provided to Brazoria County.

Councilmember Boyce recognized the Teen Advisory Committee for hosting its first 3-on-3 basketball tournament. He noted that attendance was low during the first year, as it was a new event. The tournament was held again this year, with trophies and medals presented to the winners. Councilmember Boyce stated that this year's tournament included a new scholarship component, providing a \$2,000 scholarship to an Iowa Colony High School senior. He acknowledged and thanked the event sponsors, including Breaktime, Adico, Alterra at Sierra Vista, Sterling Lakes, McDonald's, and Center Court Pizza. Members of the Teen Advisory Committee came to the front of the room, and Councilmember Boyce presented the Teen Advisory Scholarship Award to recipient Reagan Thomas.
