CALL TO ORDER

Mayor Kennedy called the meeting to order at 7:00 P.M.

Approximately 1.956 acres of land, being the south ½ of the southeast ¼ of section 53, H.T. & B.R.R. Co. Survey, Abstract 287, Brazoria County Texas as recorded in Volume 358, Page 495 Deed Records, Brazoria County Texas.

Mayor Kennedy opened the public hearing at 7:34 P.M. There were no comments from the public. Mayor Kennedy closed the public hearing 8:10 P.M.

2. Hold a public hearing to consider annexing the following property:

A 5.00-acre tract of land known as the West ½ of Lot 469 of a subdivision of Sections 50, 51, and 56 in the H.T. & B.R.R Company Survey, Abstract 449 and 2, 3, & 4 of L & N, Brazoria County, Texas recorded in the County Clerk's File No. 2008-002572 of the Official Records of Brazoria County, Texas.

Mayor Kennedy opened the public hearing at 7:35 P.M. There were no comments from the public. Mayor Kennedy closed the public hearing at 8:10 P.M.

3. Hold a public hearing pursuant to the Comprehensive Zoning Ordinance, as amended, to consider a proposed amendment to the Rally 288 West Planned Unit Development (PUD) to include an additional 5.00-acre tract and designate the tract for single-family residential use within the PUD.

Mayor Kennedy opened the public hearing at 7:35 P.M. Dr. John Okewuni owns the property. He asked about the flood control plan, pool dust from all the work, speed on the road, and the wood fence. Mayor Kennedy closed the public hearing at 8:10 P.M.

COUNCIL COMMENTS

Mayor Pro Tem Greene-Scott welcomed everyone and thanked those in attendance. She acknowledged the Veterans Day event and recognized Councilmember Varlack for his service as a veteran. She also expressed excitement about a swim school opening in Iowa Colony.

Councilmember Murray recognized Ms. Dye's son and mentioned the upcoming MLK Day parade and related events.

Councilmember Brooks stated she was pleased to see the strong support for Mrs. Dye and acknowledged Mr. Daggett for bringing his class to the meeting. She noted that this was a valuable opportunity to observe local government in action and emphasized the importance of staying engaged, as local government impacts daily life.

Councilmember Hargroder thanked those in attendance and commented on the strong sense of community support shown for the swim school.

Councilmember Boyce expressed appreciation for the community's support of Coach Dye and the swim school. He also highlighted upcoming city events, including the Festival of Lights and the MLK Day parade.

Councilmember Varlack thanked everyone for attending and referenced upcoming events such as the Festival of Lights and the MLK Day parade. He noted that he was unable to attend the Veterans Day event due to prior speaking commitments at another Veterans Day observance. He wished a happy 250th birthday to any Marines in attendance and reminded the public that November is Suicide Prevention Month. He encouraged anyone experiencing a personal crisis or harmful thoughts to call 988.

Mayor Wil Kennedy reminded everyone about the MLK Day parade scheduled for Saturday, January 17. He thanked the councilmembers who were able to attend the Veterans Day event, offered encouragement and well wishes to the Iowa Colony Pioneers, and expressed appreciation to the community members and Mr. Daggett's class for attending the meeting.
