### CALL TO ORDER

Mayor Kennedy called the meeting to order at 7:00 P.M.

### INVOCATION

Councilmember Murray prayed aloud.

### PLEDGE OF ALLEGIANCE

The Pledge of Allegiance and Texas Pledge were recited.

### SPECIAL PRESENTATIONS & ANNOUNCEMENTS

*Reserved for formal presentations and proclamations.*

1. Proclamation - Iowa Colony High School Track Team State Championship.

Mayor Kennedy presented the proclamation to the Iowa Colony High School Track team.

### CITIZEN COMMENTS

Terry Hayes spoke about the importance of citizenship, defining it as being an active, constructive, and respectful member of the community. He expressed concern over recent behavior that he believes does not reflect these values, including what he described as false accusations made against Council and committee members. He stated that these accusations appear to stem from personal dislikes, grudges, or vendettas and characterized such actions as sabotage rather than constructive citizenship. He noted that this behavior undermines not only individuals, but also the trust and progress within Iowa Colony. Mr. Hayes emphasized that while City leadership continues to act in good faith, there are individuals who attempt to undermine partnerships for personal gain. He requested that the City review the community

code of conduct and stated that such negative behavior should not be tolerated, reaffirming a shared goal of strengthening the community together.

Cameron Rollwitz referenced Senate Bill 1494, which allows municipalities to move their elections to November. He asked City Council to consider this option, stating that holding elections in November could improve representation, as some residents may be unaware that City elections currently occur in May.

Charles Koeh addressed an ordinance requiring buildings to be set back 25 feet from the fence line, stating that the ordinance is unclear and that he has not been provided a justification for the requirement. He noted that approximately 13 buildings have previously been permitted with setbacks of only five feet from the fence line. Mr. Koeh stated that despite hiring a contractor, his project has been delayed and remains unresolved. He indicated that he is prepared to have his property re-surveyed to move the process forward.

Terry Hayes stated that Iowa Colony is experiencing rapid growth but currently does not have a bank or credit union within the City, requiring residents to travel to neighboring communities for these services. He noted that bringing a Navy Federal Credit Union branch to Iowa Colony would benefit both the City and its residents. Mr. Hayes provided a proposal to City Council for review.

## **PUBLIC HEARINGS**

2. Hold a public hearing pursuant to the Comprehensive Zoning Ordinance, as amended, to consider a proposed amendment to the Rally 288 West Planned Unit Development (PUD) to add "Substation" as a conditional use within the commercial land use category in the PUD.

Mayor Kennedy opened the public hearing at 7:16 p.m. Michael Turzillo of EHRA Engineering presented information regarding the pursuit of the southern commercial tract. The Planning and Zoning Commission recommended approval of the proposed amendment, provided that CenterPoint installs appropriate screening. Mayor Kennedy closed the public hearing at 7:17 p.m.

3. Hold a public hearing to consider annexing the following property:

A 5.00-acre tract of land known as the West ½ of Lot 469 of a subdivision of Sections 50, 51, and 56 in the H.T.& B.R.R Company Survey, Abstract 449 and 2, 3, & 4 of L & N, Brazoria County, Texas recorded in the County Clerk's File No. 2008-002572 of the Official Records of Brazoria County, Texas.

Mayor Kennedy opened the public hearing at 7:17 p.m. Brad Sweitzer of EHRA Engineering stated that this represents the most compatible use of the property and supports moving it to the PUD. Mayor Kennedy closed the public hearing at 7:19 p.m.

## **COUNCIL COMMENTS**

Mayor Pro Tem Greene-Scott apologized for her tardiness, stating she was in Fort Bend County for a ballot draw as she is running for Congress. She noted that the Festival of Lights was a great success and expressed regret for missing the track team proclamation. She shared her excitement about the new City Manager beginning January 5th and stated that the hard work put into the City by staff and Council is coming to fruition.

Councilmember Murray thanked everyone for their attendance. She announced that the MLK Parade will be held on January 17, 2026, at 10:00 a.m., with the program to follow at Freedom Field. She encouraged anyone interested in participating to contact her.

Councilmember Brooks thanked those in attendance and shared that she is working with several groups interested in participating in the MLK Day parade and program. She expressed anticipation for the new City Manager, noting his prior experience with the City of DeSoto. She stated that she has been recording meetings and is seeking support for her goal of streaming City Council meetings.

Councilmember Hargroder thanked everyone in attendance and noted the many seasonal festivities taking place. She announced that on Saturday, December 20th, from 6:00 p.m. to 8:00 p.m., the Fire Department will host photos with Santa. She thanked staff, volunteers, and committee members for their hard work on the Festival of Lights and reminded everyone to celebrate safely and not drink and drive.

Councilmember Boyce acknowledged his wife and mother-in-law in the gallery. He stated that the Festival of Lights was outstanding and reminded residents of the upcoming MLK Day parade and program. He reiterated the importance of safety during the holiday season.

Councilmember Varlack stated that the Festival of Lights was enjoyed by all, especially the children who enjoyed the snow. He shared that he visited the City of Katy to watch the Iowa Colony Pioneers and expressed pride in being part of the City. He noted that the Iowa Colony Police Association is still accepting donations for toys and food and reminded everyone to not drink and drive.

Mayor Kennedy acknowledged those in the gallery. He congratulated the Iowa Colony Pioneers football team and thanked staff and Council for their collaboration in making the Festival of Lights a success. He stated that the City is organizing a meet-and-greet with the new City Manager and invited everyone to attend the State of the City, hosted by the Northern Brazoria County Chamber of Commerce, on January 20th at Freedom Field. He also encouraged participation in the upcoming MLK Day celebration.
