3. Emergency Allocations

A. Board of Regents – University of Iowa is requesting a supplemental emergency allocation in the amount of \$11,000.00. This brings the total allocation to \$490,716.49. On March 12, 2020, a chilled water line leak caused water damage at the Chemistry Building. Request is to cover repair costs.

The State Auditor’s Office has reviewed this request and recommends allocation and payment. This represents full and final payment and this allocation will be closed.

B. Iowa Communications Network is requesting a supplemental emergency allocation in the amount of \$2,582.44. This brings the total allocation to \$35,947.38. On November 19, 2020, ICN sustained cable damage due to rodent chew along Highway 3 in Fayette County. Request is to cover repair costs.

The State Auditor’s Office has reviewed this request and recommends allocation and payment. This represents full and final payment and this allocation will be closed.

- B. Fremont County made their first Contingency Loan payment of \$6,562.50. This loan was approved for \$131,250.00 on October 19, 2020 and is prorated not to exceed twenty years. Total repayment to date: \$6,562.50.
- C. On November 2, 2020, the Executive Council approved an emergency allocation in the amount of \$3,835.60. On August 10, 2020, State Patrol Vehicle #821 was damaged by a derecho. The final invoices and supporting documentation fell below the \$2,000.00 minimum threshold for 29C.20 claims and the allocation should be reverted to the State Treasury and this allocation will be closed.
