

The Jackson Parish Police Jury met in regular session on Tuesday, April 15, 2025, at 5:30 PM in the Nathaniel Zeno, Jr. meeting room, 160 Industrial Drive, Jonesboro, Louisiana. Members Present: Mr. Todd Culpepper, Mrs. Sheketia Combs, Mrs. Tarneshala Cowans, Mrs. Amy Magee, and Mr. Lewis Chatham. Absent: Ms. Regina Rowe, Mr. Keith Burris. Also present: Mr. Brad Roller, Operations Manager, Mr. Robin Sessions, Solid Waste Superintendent, Mr. Wayne Anderson, Road Superintendent, and Mr. Paul Riley, Parish Engineer.

The President, Mr. Culpepper, called the meeting to order. Mrs. Magee gave the invocation and Mrs. Combs led the recitation of the Pledge of Allegiance.
