

The Jackson Parish Police Jury met in regular session on Monday, February 12, 2024 at 5:30 PM in the Dr. Charles H. Garrett Community Center, 182 Industrial Drive, Jonesboro, Louisiana. Members Present: Mr. Todd Culpepper, Mr. Lewis Chatham, Ms. Amy Magee, Ms. Sheketia Combs, Ms. Regina Rowe, and Mr. Keith Burris. Absent: Ms. Tarneshala Cowans. Also present: Mr. Brad Roller, Operations Manager; Mr. Wayne Anderson, Road Superintendent; and Mr. Robin Sessions, Solid Waste Superintendent.

The President, Mr. Culpepper, called the meeting to order. Ms. Rowe gave the invocation and Mr. Chatham led in the recitation of the Pledge of Allegiance.
