

The Jackson Parish Police Jury met in regular session on Tuesday, September 10, 2024, at 5:30 PM in the Nathaniel Zeno, Jr. meeting room, 160 Industrial Drive, Jonesboro, Louisiana. Members Present: Mr. Todd Culpepper, Mrs. Sheketia Combs, Ms. Regina Rowe, Mrs. Tarneshala Cowans. Also present: Ms. Nia Evans, Secretary-Treasurer, Mr. Brad Roller, Operations Manager; Mr. Wayne Anderson, Road Superintendent; and Mr. Robin Sessions, Solid Waste Superintendent. Mrs. Amy Magee and Mr. Lewis Chatham were absent.

The President, Mr. Culpepper, called the meeting to order. Ms. Rowe gave the invocation and Mrs. Cowans led the recitation of the Pledge of Allegiance.
