The Jackson Parish Police Jury met on Tuesday, January 19, 2021 at 5:30 PM in the Nathaniel Zeno Jr. Meeting Room, Jackson Parish Administrative Building, 160 Industrial Drive, Jonesboro, Louisiana to conduct a public hearing to receive comments on changes to the Parish Road System. Members Present: Mr. Todd Culpepper, Mr. Lewis Chatham, Ms. Amy Magee, Mr. John McCarty, Ms. Regina Rowe, and Mr. Lynn Treadway. Absent: Ms. Tarneshala Cowans. Also present, Mr. Darrell Avery, Assistant D.A.

The President, Ms. Amy Magee, called the hearing to order. Mr. McCarty gave the invocation and Mr. Culpepper led in the recitation of the Pledge of Allegiance.

The President opened the meeting discussing the ongoing audit finding for the Police Jury spending public funds on roads in the Parish Road System that do not benefit the public. She stated that continued findings for this issue would result in the parish losing their Parish Transportation Funding from the state and that all roads must benefit the public in order to remain in the system.

The President called for public comments on the road changes and read aloud the details as follows:

William Shows Road: to adjust the parish maintenance to end at the Westbrook property line, removing the portion of the road with the same landowner on all three sides of the road.

No comment was made.

Choctaw Road: to adjust the parish maintenance to end at the Robert Moore property line. Public comment was given by Mr. Robert Moore stating that he did not oppose the change but that the sign needed to be replaced.

McKeever Road: to remove the road from the Parish Road System based on their being only one property owner on both sides and the end of the road.

Public comment was given by the property owner stating that there were multiple mailboxes on the road and that more than one family lives there.

Springfield Road: to adjust the parish maintenance to end at the Winter's property line. No comment was made.

St. Clair Road: to remove the road from the Parish Road System based on their being a gate placed across the road.

No comment was made.

With no other comments or questions, the President called for a closing of the public hearing.

Motion Mr. Culpepper, seconded Mr. Chatham to close the public hearing and adjourn. Motion carried.

The President, Ms. Amy Magee, called the meeting to order.

The President opened the floor for public comments. There were no public comments.

Motion Mr. Culpepper, seconded Ms. Rowe to amend the agenda to include consideration and action for a resolution of support of the Jackson Parish Hospital incurring certain debts under the PPP Second Draw Program. Motion carried unanimously and the item was added to the beginning of the agenda.

Motion Mr. Culpepper, seconded Mr. McCarty to amend the agenda to include consideration and authorization for the Secretary-Treasurer and President to sign the 2021 Audit Letter of Engagement. Motion carried unanimously and the item was added to the agenda as number 19.

Motion Ms. Rowe, seconded Mr. Treadway to adopt a resolution of support of the Jackson Parish Hospital incurring certain debts under the PPP Second Draw Program.

The following Resolution was offered by Ms. Rowe and seconded by Mr. Treadway:

RESOLUTION # _01-01912020_

A resolution of the Jackson Parish Police Jury, approving the request of the Jackson Parish Hospital Service District No. 1 for authorization to: issue not exceeding \$1,913,770.82 of Revenue Notes, in one or more series; to make application to the State Bond Commission for approval of and providing for the sale and certain terms of said Revenue Notes; and providing for other matters in connection therewith.

WHEREAS, the Jackson Parish Police Jury must approve and authorize the Jackson Parish Hospital Service District No. 1's incurrence of certain debts, including the debt at issue in this Resolution;

WHEREAS, Section 1060 of Title 46 of the Louisiana Revised Statutes of 1950, as amended, and other constitutional and statutory authority authorizes a hospital service district to incur debts and contract obligations for the carrying out of the objects and purposes for which the hospital service district was created;

WHEREAS, as a result of the COVID-19 pandemic and concurrent economic downturn, the Jackson Parish Hospital Service District No. 1 (hereinafter sometimes referred to as the "Issuer") may need to identify financing for operations and expenses in the current and upcoming fiscal years to ensure the continuity of essential government functions;

WHEREAS, the Issuer wishes to incur debt and issue not exceeding \$1,913,770.82 of its Revenue Notes, or any other such designation as may be required by the Small Business Administration ("SBA") under the "Paycheck Protection Program Second Draw Loan" Program (the "PPP Second Draw Program") should the borrowing take place pursuant to the PPP Second Draw Program, in one or more series (the "Notes"), for the purpose of funding operations and expenses in the current fiscal year, to mature no later than five (5) years from the date thereof, and to bear interest at a rate or rates not to exceed one per centum (1%) per annum; and

WHEREAS, the Issuer desires to make formal application to the State Bond Commission for approval of the Notes;

NOW, THEREFORE, BE IT RESOLVED by the **Jackson Parish Police Jury**, acting as the governing authority of the Issuer, that:

SECTION 1. Approval is hereby given to the incurrence of debt and issuance of not exceeding \$1,913,770.82 of Revenue Notes of the Issuer (the "Notes") in one or more series, each of which may be taxable or tax-exempt, for the purpose of funding salaries, wages, and other operating expenses (in accordance with SBA guidelines) in the current fiscal year is hereby authorized.

The Notes shall mature no later than five (5) years from the date thereof and bear interest at a rate or rates not to exceed one per centum (1%) per annum. The Notes shall be secured by and payable from all revenues to be received by the Issuer while the Notes are outstanding to the extent such revenues are available for the payment of debt service on the Notes. The Notes shall be issued in fully registered form and shall have such additional terms and provisions as may be determined appropriate by John Morgan, Chief Executive Officer of Jackson Parish Hospital Service District No. 1. "Notes" include any indebtedness obtained by the Issuer through a bank under the PPP Second Draw Program. If Notes are issued pursuant to the PPP Second Draw Program, the Issuer shall pay said administrative, closing, or other fees as required by the PPP Second Draw Program.

SECTION 2. In accordance with the PPP Second Draw Program and the PPP application process authorized by the State Bond Commission, application is hereby made to the State Bond Commission, Baton Rouge, Louisiana, for consent and approval to issue, sell, and deliver the Notes.

By virtue of applicant/issuer's application for, acceptance and utilization of the benefits of the Louisiana State Bond Commission's approval(s) resolved and set forth herein, it resolves that it understands and agrees that such approval(s) are expressly conditioned upon, and it further resolves that it understands, agrees and binds itself, its successors and assigns to, full and continuing compliance with the "State Bond Commission Policy on Approval of Proposed Use of Swaps, or other forms of Derivative Products Hedges, Etc.", adopted by the Commission on July 20, 2006, as to the borrowing(s) and other matter(s) subject to the approval(s), including subsequent application and approval under said Policy of the implementation or use of any swap(s) or other product(s) or enhancement(s) covered thereby.

SECTION 3. The Notes are hereby authorized to be sold to a purchaser, and John Morgan is hereby authorized to negotiate, enter into, sign, execute and deliver any and all contracts, agreements, and other documents associated with the sale of the Notes, provided the sale of the Notes is at a price not less than the principal amount of the Notes so sold and is within the parameters set forth herein. The authority granted in this Section shall be complete authority for the sale of the Notes by the Issuer.

Motion Mr. Treadway, seconded Mr. Chatham to adopt a resolution to authorize the Secretary-Treasurer to sign documents and pay bills on behalf of the Jackson Parish Police Jury for 2021. Motion carried.

Ms. Rowe requested that the Secretary-Treasurer send out weekly updates informing the Jury of their items.

The President moved to the approval of minutes.

Motion Mr. Treadway, seconded Mr. Chatham to adopt the minutes of the December 14th Jury Meeting, monthly purchase orders, and the payment of all bills. Motion carried.

The President moved to Committee Reports.

Motion Mr. Chatham, seconded Mr. Treadway to adopt the following minutes from the December 22nd Operations Committee meeting. Motion carried.

Operations Committee December 22, 2020

The Operations Committee met Tuesday, December 22, 2020 at 12:00 PM in the Police Jury Meeting Room of the Jackson Parish Courthouse, 500 E. Court Street, Room 301, Jonesboro, Louisiana. Members present: Mr. Lewis Chatham, Ms. Amy Magee, and Mr. Lynn Treadway. Absent: none. Also in attendance: Mr. Jody Stuckey, Road Superintendent and Mr. Paul Riley, Parish Engineer.

The meeting was called to order by the Chair, Ms. Amy Magee. Mr. Treadway gave the invocation and Mr. Chatham let in the recitation of the Pledge of Allegiance.

There were no public comments.

The Committee reviewed the amended invoice from McDonald Community Water System for the work performed on the water line issue on Poland Loop. Ms. Magee stated that the water system moved the water line from their portion of the road at their expense, but that the Jury should reimburse them for the expense to move the water lines that do not belong to their system. It was discussed that this saved the Police Jury money by not requiring another crew to come out and perform the work. Motion Mr. Chatham, seconded Mr. Treadway to recommend the Jury pay the requested \$450.00 charge to McDonald Community Water System. Motion carried.

Motion Mr. Treadway, seconded Mr. Chatham to recommend the Jury support the 2020-21 CWEF requests for Wesley Chapel Water System and McDonald Community Water System. Motion carried.

The Committee reviewed the first-pass reports of the following road studies. The following recommendations were made:

- Motion Mr. Treadway, seconded Mr. Chatham to recommend the Jury take no action on Lynn Dewitt Road as they confirmed that the maintenance ends at the gate. Motion carried.
- Motion Mr. Treadway, seconded Mr. Chatham to recommend the Jury take no action on Flowers Road as they confirmed that there are multiple structures and people living on the road. Motion carried.
- Motion Mr. Chatham, seconded Mr. Treadway to recommend the Jury adjust the parish maintenance on Viola Road to end at the Leonard property line. Motion carried.
- Motion Mr. Treadway, seconded Mr. Chatham to table recommendations on Bolds Road until Mr. John reviews the area. Motion carried.
- Motion Mr. Treadway, seconded Mr. Chatham to recommend the Jury send Clifford Osborne Road to a public hearing to receive comments on how the road serves the public. Motion carried.
- Motion Mr. Treadway, seconded Mr. Chatham to recommend the Jury take no action on Tim Staples
 Loop as they confirmed that there are multiple property owners and removal would landlock the
 McGuire property. Motion carried.
- Motion Mr. Treadway, seconded Mr. Chatham to recommend the Jury send Henderson Road to a public hearing to receive comments on how the road serves the public. Motion carried.
- Motion Mr. Chatham, seconded Mr. Treadway to recommend the Jury take no action on Swiss Road as they confirmed that there are multiple property owners. Motion carried.
- Motion Mr. Chatham, seconded Mr. Treadway to recommend the Jury take no action on Tatum Road as they confirmed that there are multiple property owners. Motion carried.
- Motion Mr. Chatham, seconded Mr. Treadway to recommend the Jury take no action on Annie Tatum Road as they confirmed that there are multiple structures and people living on the road. They also

discussed a medical need for ambulance access. Ms. Magee stated that they may want to revisit this road in the future. Motion carried.

Motion Mr. Chatham, seconded Mr. Treadway to adjourn. Motion carried.

Mr. Culpepper left the meeting.

Motion Ms. Rowe, seconded Mr. Treadway to reimburse McDonald Community Water System for work on water lines. Motion carried.

With the conclusion of Committee Reports, the President called for monthly management reports.

Mr. Jody Stuckey, Road Department Superintendent, gave the December 2020 Road report noting that \$3,648.19 had been spent on emergency call-outs/off-schedule work. He stated the 2021 Road Program was completed and updated the status of special projects.

Motion Mr. McCarty, seconded Ms. Rowe to accept the December 2020 emergency/off-schedule reports. Motion carried.

Mr. Robin Sessions, Solid Waste Superintendent, gave the December 2020 Solid Waste report noting the tonnages collected in the parish and municipalities and discussed the increase in tonnage over the last several years.

The President updated the Jury on the activities of the OEP Department.

Ms. Gina Thomas, Secretary-Treasurer, presented the December 2020 Financial Report highlighting the actual vs. budget comparisons for all funds and discussed the accrual process. She announced the 2020 audit fieldwork would take place the week of April $12^{th} - 16^{th}$.

The President moved on to Other Business.

Mr. Paul Riley, Parish Engineer with the Riley Co. gave the December 2020 Engineering report and stated that he would present the preliminary 2021 Road Program and 3-year plan in January.

Motion Mr. McCarty, seconded Mr. Treadway to adopt the following resolution in support of the FY 2020-2021 Community Water Enrichment Fund (CWEF) grant application for the Wesley Chapel Water System.

RESOLUTION

WHEREAS, the Jackson Parish Police Jury has been afforded the opportunity to participate in the FY 2020-2021 Community Water Enrichment Fund (CWEF) Program administered by the State of Louisiana, Division of Administration, Office of Community Development; and

WHEREAS, the Jackson Parish Police Jury desires to submit an application for funding to the CWEF Program, and

WHEREAS the Mt. Calm Water System is proposing to merge and consolidate with the Wesley Chapel Water System once sufficient improvements including an interconnection of the two water systems is made, and

WHEREAS, merging and consolidating the Mt. Calm Water System with the Wesley Chapel Water System will provide a more sustainable water system for customers of both water systems.

Finance Committee January 21, 2021

The Finance Committee met Thursday, January 21, 2021 at 12:00 PM in the Nathaniel Zeno Jr. Meeting Room of the Jackson Parish Police Jury Administrative Building, 160 Industrial Drive, Jonesboro, Louisiana. Members present: Ms. Amy Magee and Mr. John McCarty. Absent: Ms. Tarneshala Cowans.

With the Chairman not present, the meeting was called to order by Ms. Magee. Mr. McCarty gave the invocation and Ms. Magee led in the recitation of the Pledge of Allegiance.

There were no public comments.

Ms. Magee noted that Ms. Cowans and the Secretary-Treasurer were both listening via teleconference due to mandated COVID-19 quarantines.

The Committee discussed the deadline for the 2020-21 LGAP application. Ms. Magee stated that only the Village of North Hodge had requested a letter of support from the Police Jury and that the maximum for municipalities was \$25,000, leaving \$33,800 available. They discussed options for what the Police Jury could apply for and other grant opportunities available. Ms. Magee stated that if more municipalities applied, the Jury would not want to compete against them, but that the Police Jury should have an application prepared if no one else requested anything. Ms. Magee stated that a vehicle to be used by Administration, Maintenance, OEP, Administrative Clerks, and travel would benefit multiple departments. Ms. Cowans agreed.

Motion Mr. McCarty, seconded Ms. Magee to recommend the Jury use the 2020-21 LGAP application to apply for the purchase of an SUV. Motion carried.

Ms. Magee stated that the 2020 Finance Committee had requested the President to talk to the Sheriff's Office about the cost of prisoner housing. She stated that the Secretary-Treasurer had also been contacted by the correctional center asking if the Police Jury is supposed to receive the invoices for the towns. Ms. Magee stated that in her research she found that the Police Jury has been paying for all of the municipal prisoners, even though it is not mandated. The Committee discussed the cost per day for different types of prisoners and the tickets and sentences imposed by the towns.

Motion Mr. McCarty, seconded Ms. Magee to recommend the Jury notify the Sheriff's Office that the Police Jury will only pay for their mandated prisoners. Motion carried.

Motion Mr. McCarty, seconded Ms. Magee to set the next Finance Committee Meeting for Tuesday, February 16th at 12:00 PM at the Administrative Building. Motion carried.

Motion Ms. Magee, seconded Mr. McCarty to adjourn. Motion carried.

Finance Committee Recommendation January 21, 2021

Motion Mr. McCarty, seconded Ms. Magee to recommend the Jury notify the Sheriff's Office that the Police Jury will only pay for their mandated prisoners. Motion carried.

Operations Committee January 29, 2021

The Operations Committee met Friday, January 28, 2021 at 11:00 AM in the Nathaniel Zeno Jr. Meeting Room, Jackson Parish Administrative Building, 160 Industrial Drive, Jonesboro, Louisiana. Members Present: Mr. Lewis Chatham, Ms. Amy Magee, and Mr. John McCarty. Absent: none. Also in attendance: Mr. Jody Stuckey, Road Superintendent and Mr. Paul Riley, Parish Engineer.

The meeting was called to order by the Chair, Ms. Amy Magee. Mr. McCarty gave the invocation and Mr. Chatham let in the recitation of the Pledge of Allegiance.

There were no public comments.

Mr. Riley presented the preliminary 2021 Road Program, 3-Year Road Program, and 2-year Maintenance Program. The Committee discussed the planned work and that the 3-year program is subject to change year-over-year. Mr. Riley explained the skipped roads from the Maintenance Program due to the required repairs being too extensive for the Road Crew and stated these roads would stay in their priority ranking and go to the annual road program.

The Secretary-Treasurer announced that the Solid Waste Administrative Clerk would be moving into the Administrative Building on February 4th.

Ms. Magee announced that the Secretary-Treasurer would send the Jurors the Committee Assignment worksheet on the 15th and 30th of each month.

The Committee scheduled the next Operations Committee meeting for Thursday, February 11th at 3:00 PM at the Administrative Building.

Motion Mr. McCarty, seconded Mr. Chatham to adjourn. Motion carried.

RE: Assurances Uniform Relocation Assistance & Real Property Acquisition Act

Dear Ms. Milstead:

The Jackson Parish Police Jury assures that it will comply with the Uniform Relocation Assistance and Real Property Acquisition Policies Act, as amended (Uniform Relocation Act), 42 U.S.C. 4601-4655, and with implementing Federal regulations in 49 C.F.R. Part 24.

Specifically, the Jackson Parish Police Jury assures that:

- 1. Whenever federal financial assistance is used to pay for any part of the cost of a program or project which will result in the displacement of any person:
 - Fair and reasonable relocation payments and assistance shall be provided to or for displaced persons in accordance with the Uniform Relocation Act.
 - b. Relocation assistance programs offering the services described in the Uniform Relocation Act shall be provided to displaced persons.
 - c. Within a reasonable period of time prior to displacement, comparable replacement dwellings will be available to displaced persons in accordance with the Uniform Relocation Act.
- 2. Whenever Federal financial assistance is used to pay for any part of the cost of a program or project which will result in the acquisition of real property.
 - a. In acquiring real property, the parish will be guided by the land acquisition provision of the Uniform Relocation Act.
