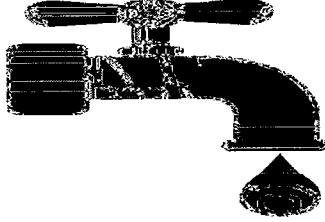

CWEF Funding Request


Dear Mrs. Thomas:

The Wesley Chapel Water System currently serves customers in Lincoln and Jackson Parishes. Wesley Chapel has been approached by the Mt. Calm Water System regarding the possibility of merging with Wesley Chapel. We feel this merger will provide a more sustainable water system to all customers of both Wesley Chapel and Mt. Calm. As part of this merger, needed improvements are proposed to the Mt. Calm system and a water line interconnection is proposed between both systems.

We are requesting support from the Jackson Parish Police Jury of a CWEF grant application to partially fund some of the required improvements.
