<u>Justin Cameron - Seeking Special Exception for Gravel Lot for a Shed Sales Location - Located off</u> <u>Highway 11-E</u>


After a brief discussion on the entrance design for both entrances, and the depth of solid surface before the gravel lot would begin, Mr. Cameron stated it would be asphalt or concrete. Mr. Cain asked if TDOT has specific standards and Mr. Houston stated he believed it to be 30 feet minimum. Mr. Cameron agreed to meet TDOT requirements. Considering that the use will have no permanent structures and not affect neighboring properties in a negative way the special exception was granted unanimously, on a motion by Mr. Chitwood, and a second by Mr. Bunch.




