



**MINUTES
CITY COUNCIL REGULAR MEETING
COUNCIL CHAMBERS
JUNE 18, 2026
6:30 PM**

The Joshua City Council will hold a Work Session at 6:30 pm. A Regular Meeting will be held immediately following the Work Session in the Council Chambers at Joshua City Hall, located at 101 S. Main St., Joshua, Texas. This meeting is subject to the open meeting laws of the State of Texas.

A. CALL TO ORDER AND ANNOUNCE A QUORUM PRESENT

Mayor Kimble announced a quorum and called the meeting to order at 6:30 pm.

C. INVOCATION

D. WORK SESSION

1. Review and discuss questions related to the financial report for May 2026. (Staff Resource: M. Peacock)

City Manager Peacock presented the Financial Report for May 2026. He reported that the City was at 67 percent of the annual budget and had collected approximately 90 percent of projected revenues to date. He also noted that municipal court fee collections were below average.

2. Discussion on an Ordinance amending article 3.06, "Signs" of Chapter 3, "Building Regulations", of the Code of Ordinances, by replacing said article with a new article 3.06, "Signs", extending the City's sign ordinance and regulations to the City's extraterritorial jurisdiction. (Resource: A. Maldonado and T. Welch)

City Attorney Terry Welch reported that there were no significant changes to the ordinance since its previous review. He noted that the only requested revision was to classify a mural as a wall sign.

Assistant City Manager Aaron Maldonado stated that, at the Council's previous direction, staff had researched whether there were any code enforcement violations occurring within the City's extraterritorial jurisdiction (ETJ). City Attorney Welch explained that counties have limited enforcement authority, whereas municipalities are authorized to adopt and enforce additional regulations within their ETJ as permitted by law. He further stated that including ETJ-related provisions in the ordinance would help prevent potential issues in the future.

City Manager Peacock added that the City is not currently experiencing any issues within the ETJ; however, adopting the provisions now would allow the City to address potential concerns should they arise in the future.

3. Discussion and update regarding the July 3 Joshua America's 250th Celebration. (Staff Resource: A. Holloway)

City Secretary Holloway provided an update on the upcoming July 3 Joshua America's 250th Celebration. She reported that approximately 150 vendors and food trucks were expected to participate in the event. She also highlighted that a large Kids Zone would be available free of charge for families.

Mrs. Holloway stated that, in addition to a DJ, the event would feature live entertainment by Memphis Soul Band. She noted that while the band's style of music is different from what is typically featured at local events, it was intentionally selected to provide a unique experience in celebration of America's 250th anniversary.

Mrs. Holloway also recognized the efforts of the event planning team, stating that from the first planning meeting the focus had been on working together as one team, supporting one another, and collaborating to make the celebration a success. She thanked the team members for their dedication and teamwork in planning the event.

E. UPDATES FROM MAYOR AND COUNCIL MEMBERS, UPDATES FROM CITY STAFF MEMBERS:

Pursuant to Texas Government Code Section 551.0415, the Mayor and Members of the City Council may report on the following items of community interest, including (1) expressions of thanks, congratulations, or condolences; (2) information about holiday schedules, (3) recognition of individuals; (4) reminders about upcoming City Council events; (5) information about community events; and (6) announcements involving any imminent threat to public health and safety. Staff Updates will address operational issues in various City departments. No deliberation is authorized under the Texas Open Meetings Act.

Mayor Kimble reported that he attended the North Central Texas Council of Governments (NCTCOG) meeting the previous week. He commented that the meeting involved significant political discussion and commended Victoria Johnson for doing an excellent job maintaining order and facilitating the meeting.

Mayor Kimble also noted that he attended the grand opening of State Representative Helen Kerwin's district office. Councilmember Grall commented that Representative Kerwin is becoming an active part of the Joshua community.

Councilmember Grall remarked that the Police Department continues to demonstrate that it is a very busy department through its ongoing activities and service to the community.

City Secretary Holloway informed the Council that she is in discussions with State Representative Helen Kerwin regarding the possibility of proposing legislation that would require counties to enter into annual contracts with cities for election services.

F. PUBLIC FORUM, PRESENTATION, AND RECOGNITION:

The City Council invites citizens to speak on any topic. However, unless the item is specifically noted on this agenda, the City Council is required under the Texas Open Meetings Act to limit its response to responding with a statement of specific factual information, reciting the City's existing policy, or directing the person making the inquiry to visit with City Staff about the issue. Therefore, no Council deliberation is permitted. Each person will have 3 minutes to speak.

Police Chief Fullagar introduced the City's newest police officer, Miranda Billbrey, and welcomed her to the Joshua Police Department.
