#### **Description of the Project or Asset**

Construction of 16 outdoor kennels and an enrichment area. Pour concrete and install 16 dog kennels with drains tied to the sanitary sewer under the existing cover to the north and east of the shelter. Improve watershed of storm water from the building.

# Justification of the Project or Asset Including Impact if Delayed

Current configuration: (9) kennels with gravel and dirt base does not allow for adequate number of dogs (16) nor does it allow for cleaning or disinfecting of these areas. The dogs cannot be let off lead for exercise and socialization. This project would decrease the possibilty of disease and increase the adoptability of our canine population through better normal and improved social behavior. Delay would perpetuate the possible spread of dsease in our dogs, the almost impossible task of cleaning these areas, and the euthanasia of dogs that may just need better social skills. Continued risk of slip and falls during rainy times.

### **Impact on Operating Budget and Explanation of Such Impacts**

This will allow for better cleaning and disinfecting both inside and outside. This will improve health and adoptability of our dogs. Impacting our budget by reducing cost of euthanasia and treatment of sick dogs. Possibly increasing revenue in adoption fees by improving the overall adoptbility of our dogs through improved health and social behavior.

# **Vaccination Recommendations for Shelter Dogs**

Vaccine	Adult Dogs (>20 weeks old)	Puppies (4-20 weeks old)	Where to Administer	Notes
Modified-live or recombinant Canine Distemper Virus, Adenovirus-2, Parvovirus, and Parainfluenza (DA2PP)	Administer one dose at or prior to intake. Administer a second dose 2 weeks later.*	Administer one dose at or prior to intake. Administer additional doses every 2 weeks until the puppy is 20 weeks old.*	Subcutaneous, right forelimb	Repeat in one year and every 3 years thereafter
Intranasal Bordetella bronchiseptica + Canine Parainfluenza Virus	Administer one dose at or prior to intake.	Administer one dose at or prior to intake. (May be administered as early as 3 weeks of age.)	Intranasal	Repeat intranasal vaccination every year.  Some intranasal products may also contain canine adenovirus-2. # **JUSTIFICATION**

Industry standards dictate vaccination of shelter animals upon intake and again every 2 weeks while in the shelter. The average length of stay for an animal at JAS is 28.8 days this would require 3 sets of vaccinations. 23-24 intake of 561 animal equals 1683 sets of vaccines. We curently budget for 1 set per animal.

# **BENEFIT/COST SAVINGS**

Vaccinating shelter animals boost their imunity and keeps them healthier during their stay. Having healthier animals promotes more adoptions, reduces vet care expenses, and reduces euthanasia.

# **JUSTIFICATION**

PetPoint Enterprise: Enhanced Support Package with realtime chat and over the phone and emergency support 24/7, Shcheduled Reports email lists and reminders for care and case follow ups, Advanced Security features. Allowing for better time management in the shelter, less missed medical care, beter case management in the field, easier follow up on cases and citations.

# **BENEFIT/COST SAVINGS**

Better time management allows for more one on one service in the field and at the shelter. Better reports allow for more time to be spent working to get pets out of the shelter and into homes. More pets in homes equals fewer euthanised at the shelter. Better case reports results in better enforcement and follow up.

# **JUSTIFICATION**

More stable footware that provides punture protection when out in the field. Waterproof footwear keeping the shelter attendants feet dry.

# BENEFIT/COST SAVINGS

Saves accident related cost by possibly preventing injury from puntures, slips, or pinch to foot ankle or toes. One trip to urgent care costs between \$100 and \$200 for standard visit with added services depending on severity between \$50-\$250.
