 - 2. <u>USE2025 0005</u> A Conditional Use Permit to modify an existing case to reduce the number of Planning Commission mandated parking by one (1). The Planning Commission set a minimum of 49 parking spaces for this 23 dwelling unit condo in a Light Commercial zoning district. The current parking plan shows 59 parking spaces which are offset from the units which occasionally blocks owner access. Reducing the number of parking spaces to 48 and aligning them with the garages of each unit will allow unit owners to control access to the garage entrances. The minimum parking requirement for this development according to the CBJ Land Use Code is 31 spaces.
 - 3. <u>USE2025 0008</u> A Conditional Use Permit for use of four classrooms to provide childcare for up to 45 students in the Floyd Dryden building.
