JCOA Annual Report

The 2024 Juneau Commission on Aging Annual Report and Brochure are included in your packet for review.

JCOA Appointments

Per <u>Resolution 2944</u>; the JCOA shall consist of nine voting members appointed from the general public. Members shall be appointed to staggered two-year terms. The assembly shall appoint members from a diverse population of people with knowledge of issues relating to aging or with expertise on health, housing, transportation, finances, insurance, and other areas of concern for seniors in Juneau. At least five public members shall be 65 years of age or older. Four public members shall serve without restriction as to age.

There are currently three (3) 65+ seats and three (3) general public seats with various terms up for action. JCOA seats are 2-year terms.

Juneau Commission on Aging - Current Roster

<u>Suggested Motion</u>: to forward to the full Assembly for approval, the reappointment of **Deborah Craig**, and **Carol Ende** to terms running January 1, 2025 through December 31, 2026 and the appointment of **Diane Kyser OR Barbara Murray** to a term beginning immediately and ending December 31, 2025 to the Juneau Commission on Aging Public/65+ Seats; and the reappointment **Jennifer Garrison** and the appointment of **Diane Kyser OR Barbara Murray** to terms running January 1, 2025 through December 31, 2026 and the appointment of **Diane Kyser OR Barbara Murray** to terms running January 1, 2025 through December 31, 2026 and the appointment of **Chris Schapp** to a term beginning immediately and ending December 31, 2025 all to the Juneau Commission on Aging General Public Seats, and ask for unanimous consent.

4. Resolution 3085 A Resolution to Dissolve the Sister Cities Committee and Repealing Resolutions No. 1986, 2420(c), and 2508.

This resolution was drafted at the request of the HRC.

5. Resolution 3086 A Resolution to Dissolve the Americans with Disabilities Act Committee and Repealing Resolutions No. 1585, 1769, 1928, 2204, 2359, and 2429.

The ADA Committee last met in September 2019 and has not been able to meet since then due to lack of quorum and lack of applicants. Staff recommends the adoption of this resolution dissolving the ADA Committee.

2. Local Emergency Planning Committee (LEPC) Appointment

Per <u>Resolution 2974</u>, the LEPC serves as a community coalition advising staff on emergency management issues, reviews the emergency response plan for CBJ and functions, when necessary, as the Local Emergency Planning Committee under SARA Title III. The Assembly nominates applicants and final appointments are done by the State Emergency Response Commission.

There is one seat up for action on this HRC agenda, the Primary Member Media Seat 6 and one applicant to fill that seat.

Local Emergency Planning Committee - Current Roster

MOTION: by Mr. Steininger that the Assembly Human Resources Committee forward to the full Assembly for approval, the recommendation to forward to the State of Alaska Emergency Response Commission the appointment of Justin Shoman, Media Seat 6, for a term beginning January 1, 2025 and ending December 31, 2027 and asked for unanimous consent. *Hearing no objection, motion passed.*

3. Board of Equalization (BOE) Annual Report & Appointments

BOE Annual Report

The Board of Equalization held its annual training on April 25th and held five hearing dates between May 23rd and July 25th to review 2024 property appeals filed with the Assessor's Office. Included in the HRC packet is the BOE's annual report which includes a breakdown of the 2024 assessement year including number of petitions files, number of appeals and late-files heard, cases remanded back for further

review, number of cases that received an altered property assessement and the net change to taxable property from baord action. The Board of Equalization will reconviene in April 2025 for the 2025 Assessment year.

The Assembly Human Resources Committee had no questions related to the Board of Equalization Annual Report.

BOE Appointments

Per Ordinance 2022-21(b) The Board of Equalization shall comprise a pool of no fewer than five, and up to nine, members, appointed by the Assembly. The board shall hear appeals in panels consisting of three members and shall be appointed on the basis of their general business expertise and knowledge or experience with quasi-judicial proceedings. General business expertise may include, but is not limited to, real and personal property appraisal, the real estate market, the personal property market, and other similar fields. Terms of office shall be for three years and shall be staggered so that approximately one-third of the terms shall expire each year. Compensation for members shall be \$100.00 per meeting. Board members may decline compensation by providing written notice to the municipal clerk.

Both incumbents have applied for reappointment, the Clerk's Office has received no other applications.

Board of Equalizaton - Current Roster

MOTION: by Ms. Hall to forward to the full Assembly for approval, the reappointments of Emily Haynes and Wayne Coogan to the Board of Equalization both for terms beginning January 1, 2025 and ending December 31, 2027 and asked for unanimous consent. *Hearing no objection, motion passed.*

4. Systemic Racism Review Committee (SRRC) Appointment

Per <u>Ordinance 2023-20b</u>, the Systemic Racism Review Committee is a seven-member committee appointed by the Assembly. Members shall be selected to provide the most balanced representation possible. Members shall have experience identifying unlawful discrimination—including based on race, color, or national origin—experience identifying social justice inequity, or intimate knowledge of local cultures and practices, including tribal culture and practices.

Systemic Racism Review Committee - Current Roster

MOTION: by Mr. Steininger to forward to the full Assembly for approval, the appointment of Lindsey Wold to the Systemic Racism Reivew Committe for a term beginning immediately and ending June 30, 2027 and asked for unanimous consent. *Hearing no objection, motion passed.*

5. CBJ Boards Discussion & Review

Review of Sister Cities Committee & ADA Committee

Chair Adkison brought forward the request that one of the topics for the HRC this coming year would be review of all boards and committees governing legislation and whether there are boards or committees that have met their charge and could be dissolved, sunset or otherwise adjusted with membership or duties. She reported to the HRC that she met with Clerk staff, Manager's Office staff and Law regarding the Sister Cities Committee and ADA Committee as the first committees for review. Neither committee has met since Covid and do not have enough membership to make quorum. The recommendation would be to dissolve the Sister Cities Committee and move those duties to the Manager's Office; Manager Koester was agreeable to this move. For the ADA Committee it was recommended the committee be dissolved and, in its place, include language in the proposed resolution to include the creation of an ADA Task Force if the need arises due to federal legislation changes or directions to local governments from the Department of Justice.

Chair Adkison asked Mr. Steininger and Ms. Hall if they were ok reviewing all other boards and committee resolutions or ordinances as a whole and move those forward as one package to the Committee of the Whole for review; Mr. Steininger and Ms. Hall agreed to that approach.

MOTION: by Ms. Hall to direct staff to draft a resolution to sunset the ADA Committee and include language in the draft resolution creating an ADA Task Force if federal legislation changes create a need for one and asked for unanimous consent. *Hearing no objection, motion passed*.

Six BRH Board applicants were considered. During the interviews it was discovered that one of the applicants has a partner that is employed by BRH which makes that applicant ineligible to hold a seat on the board. After interviewing the BRH Board applicants and the Planning Commission applicants, the HRC recessed into executive session per a motion by Mayor Weldon at 7:41 p.m. and reconvened into open meeting session at 8:26 p.m.

The HRC chose to fill the unexpired BRH seat with a term ending December 31, 2026 as a one-year term and will treat that seat again as a one-year term next year.




The Juneau Commission on Aging (JCOA) is charged with advising the Assembly on matters related to our aging population. Seniors over 55 now comprise **30% of Juneau's population**. Juneau's elders buy goods and services, volunteer extensively, and provide support to family members in our community. Many are retired with benefits and a desire to remain in our community while contributing to its wellbeing. The 2020 Juneau Senior Survey clearly indicated that Juneau seniors are healthier and



better off than in previous survey years. To that end and in recognition that *we are all aging*, JCOA adopted the byline "Aging! So cool, everyone is doing it!" We began to focus on aging as a natural process that effects everyone and thus is a community wide concern. The JCOA developed a brochure (attached), signage, robust presentations and a website https://juneau.org/clerk/boards-committees/jcoa, to bring attention to JCOA's efforts to elicit community support. In an effort to focus our efforts effectively, JCOA identified our top three priorities in 2024 and will continue to work toward these goals in 2025.

Priority One: Sustainable and Age-Friendly Community Planning

"Master planning is a valid and necessary first step to creating a <u>unified vision</u> that is then represented in the CBJ's budget. Our city's amenities continue to be grossly undervalued in economic terms, as well as having impact on the city's population, school enrollment, demographics, socioeconomic status,



employment, business-friendliness, etc. Juneau has a ton to offer and with investments in recreation and community amenities, could attract the households, workers, and tax base we need". John S. Juneau Age 35

The CBJ Assembly joined the *Age-Friendly Network* in 2023 and the next step is to engage in the planning process. Age-Friendly Community Planning was developed by the World Health Organization and used throughout the world to define observable, measurable factors that allow comparability with other communities and identify areas of improvement. This planning tool looks at eight (8) domains of "livability" that make a community viable for *all ages*, as well as for those aging in place.

2025: The JCOA recommends that the CBJ Assembly join the JCOA and AARP Community Action Team Juneau in implementing AARP Age-Friendly Community planning process that is a) driven by data b) in alignment with community values, and c) helps Juneau be more "livable" for people of all ages.

Priority Two: Promoting Community Wellness, Safety and healthy aging *for all ages* by supporting a CBJ Community Center.

"I am 73 years old and I've lived in Juneau since 1978. I started playing pickle ball about five years ago. It's the first time in my life I've played a sport and it really helps my physical and my mental coordination. Roughly half of the people I play with are seniors but at least half are middle age people and high school students. It's a great venue for intergenerational activity. I think significantly more people would play if there were more playing times available regularly". Mary Alice M, Juneau Age 73



This year, JCOA actively promoted the concept of a CBJ Community Center using the Marie Drake Complex to provide recreational opportunities, wellness classes, informational courses and other resources to ensure seniors living in Juneau are able to continue to contribute to the community. While the entire Marie Drake Complex remains in question, the concept of a multi-generational CBJ Community Center (gym) remains a viable mechanism to support healthy maturing for people of all ages, while targeting our elders. People of all ages are enabled to continue to contribute by striving to be as healthy as possible.

2025: JCOA recommends that the CBJ Assembly promote physical, emotional and mental health activities that help all community members attain and maintain good health by dedicating use of the Marie Drake Gym and adjoining classroom space via the Department of Parks and Recreation for the uses outlined above.

Priority Three: Housing: Include *Universal Design* as a preferred priority for building age friendly, affordable housing for people of all ages.

"I am retired, healthy and want to stay in Juneau but the maintenance of my home and yard will inevitably become daunting. I'm not interested in institutional living yet but would move to an accessible, affordable, age friendly dwelling that would allow me to age in place". Lynn C. Juneau Age 72

Elements of Universal Design

- No Step Entry Flush Thresholds
- One Story Living & Ample Space
- Wide doorways and halls
- Non slip surfaces
- Good lighting/rocker light switches
- Lever door handles

"I am an almost 52-year-old professional with a decent salary - you would think that I could afford to buy a house here. My 25-year-old son works at the mine and has good income but is contemplating moving to Anchorage because he can't find housing here. I love Juneau, my family is here and I plan to stay here when I retire, but I'm afraid buying a house here is not in the cards with today's prices". Jennifer G. Juneau Age 51

84% of Seniors own their own homes in Juneau. Many would downsize if more age friendly housing were available potentially opening up more

housing units for working age families. The JCOA continues to promote the concept of Universal Design that meets the needs of community members of all ages and abilities, while allowing aging at home and in community with minimal assistance.

2025: JCOA recommends that the CBJ prioritize elements of Universal Design within the CBJ planning process to encourage building affordable age friendly housing that would attract and retain seniors, while also providing housing options to help attract and retain working age community members.



Age Friendly Planning for Healthy Communities



CREATE AGE FRIENDLY COMMUNITY: In 2023, the CBJ Juneau Assembly joined the AARP Age-Friendly States and Communities Network. Age friendly communities serve everyone ensuring age friendly housing, and age friendly recreational and social spaces for Juneau's healthy and active population, as well as those with supportive needs.

Universal Age Friendly Housing

30% of Juneau's population is over 55 and that cohort is growing. Retirees want to retire in the community we've grown to love. JCOA promotes universal design elements that result in accessible housing for all who may need it and making aging in place possible with minimal assistance.

At the same time, we promote new ideas such as Tiny Houses, Accessory Dwelling Units, Mother-In-Law apartments, congregate communities and are open to new ideas that offer more housing opportunities.
