Mr. Barr read the ordinances into the record and gave a brief summary on each item.

Ms. Patterson noted for the record that if Ordinance 2022-49 was pulled for further discussion she would need to recuse herself as she has a personal relationship with the applicant. Chair Lee asked committee members if they wished to pull that ordinance, or any others, from the consent agenda for further discussion. Mr. Froehlich stated that Ordinance 2022-49 did bring up questions for him not specific to this ordinance but the nature of it. Conveying CBJ property to individuals at fair market value and feel there is a process that can be examined about historically disenfranchised groups particularly those who are our first peoples of the area (Auk Kwan). He brought forth the question of how these types of actions can continue a legacy of systemic racism in our community. If it is conveyances of land to individual parties could CBJ look at creating policy that would allow the various tribal communities in Juneau "right of first refusal" or purchasing that property at fair market value. Chair Lee asked Mr. Barr if he had additional information on the process of land sales and transfers that happen between CBJ and individuals or organizations. Mr. Barr stated it would be good for our Lands Manager to come before the committee and give the committee a briefing on that topic. Mr. Barr gave an overview of how disposal follows the policies outlined in the Land Management Plan and recommended the committee read through the plan and noted the final decision lies with the Assembly.

Chair Lee asked when would be a good time to speak to the topic brought forward by Mr. Froehlich, perhaps during a future SRRC meeting which the Lands Manager could come and give a presentation.

Mr. Nance appreciated Mr. Froehlich's comments and wondered if, as a committee, they were reactive or proactive and that Mr. Froehlich's comments were proactive. Do we look through all the CBJ codes for issues and be proactive or wait until it comes before us and be reactive; most of what the committee has done so far has been reactive.

Mr. Barr shared his screen to show where Gastineau Lodge Apartments would go per Mr. Froehlich's question of where the apartments would be located.

<u>MOTION</u>: by Mr. Froehlich to approve the consent agenda as presented and ask for unanimous consent. *Hearing no objection, motion passed.*

Assemblymember Woll appreciated hearing the discussion today regarding land disposal. This is a timely discussion as the Assembly just heard at last night's meeting the potential for two large land negotiations on Pedersen Hill, one with Tlingit & Haida Regional Housing Authority and the other with a private developer. Ms. Woll reported that she had updated the Assembly on the larger discussion that is beginning in the SRRC with review of its charge and looking at the bigger picture of systemic racism, where it begins and how to address that vs. only reviewing legislation. The Assembly would appreciate hearing back on what the SRRC recommends and perhaps hold a joint meeting between the Assembly and the SRRC for possible charge changes.
