Meeting Called to Order at 5:04 PM by Chair Waldo.

Chair Waldo asked Nate Rumsey, the new EPW Deputy Director, to introduce himself. Chair Waldo then gave a quick summary of JCOS' duties and activities.

Agenda Items:

1. Marine Passenger Fee Discussion

Chair Waldo gave an overview of last year's priorities and projects. A discussion ensued about the Circular Study and the results. Dianna gave a recap of that project and the success of last year's requests. Dock Electrification was identified as a priority for the group.

Chair Waldo asked for help drafting the memo. Duff made a motion to give Nick, Brennen, and Griffin the authority to draft a memo to the Assembly based on the previously submitted Marine Passenger Fee priorities. Griffin seconded the motion; motion passed.

2. 2024 Recap:

Solid Waste Subcommittee Recap – Nick

- Worked to support the Zero Waste Campus, compost facility, and waste characterization study
- Supported the solid waste disposal options study

Outreach Subcommittee Recap – Marian

- Sustainability Sessions
 - Varying level of attendance attendance seemed based on relative level of controversy.
 - However, the less well attended sessions also brought value through conversation.
 - o The sessions take a lot of member and staff time
 - The subcommittee should decide on a full year's worth of events early in the year in order to advertise the events well ahead of time

Transportation - Duff

- No formal subcommittee work, but Duff has been monitoring CBJ activities related to transportation, including:
 - Dock electrification
 - Electric buses
 - Support for grants like US DOT's NOFO grants

Old priority table

- Nick did not update the previous year's priority table due to time constraints, but would like to discuss a reformat
 - JCOS tried a task-based approach last year, which worked well for the Outreach and Solid Waste Subcommittee
 - There's an advantage to the individual project-based approach, but Duff raised the issue of lost institutional knowledge when members leave the committee
 - Discussion ensued around the idea of convening more subcommittee meetings to pass on that knowledge
 - Should there be a required number of meetings for each subcommittee?
 - Dedicated members that go to public meetings should report out to the group
 - Standardized reporting for subcommittees?
 - Standard committee written report
 - Reduce time spent covering subcommittee verbally in regular meetings
 - Due one week before the scheduled meeting
 - Nick: Should the group return to project-related work?
 - Project based work ended up falling under subcommittees should the group stick with that?
 - Discussion around returning to a worksession format, and not have separate subcommittee meetings
 - Is the group able to utilize the break-out room feature on Zoom? Dianna will speak with the Clerk's office, but suspects there will be issues with OMA
